9 AS INTRODUCED

10 An Act relating to the Oklahoma Tourism and
11 Recreation Department; requiring matching funds to be
12 used for certain purpose; and directing amount of
13 funds to be made available.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. From the funds appropriated to the Oklahoma Tourism
16 and Recreation Department in Enrolled House Bill No. 1004 of the 1st
17 Extraordinary Session of the 59th Oklahoma Legislature, the
18 Department shall make available matching funds to multicounty
19 organizations pursuant to Section 2234 of Title 74 of the Oklahoma
20 Statutes. The matching funds made available shall be equal in
21 amount to the funds made available in the fiscal year ending June
22 30, 2023.
