PROPOSAL: New Law

HB 3959 proposes to enact a new rebate program called the *Oklahoma Five Major Sports Leagues Rebate Program Act* for qualifying establishments. The Committee Substitute amended the Engrossed version by:

- 1. Providing a name for the rebate program;
- 2. Outlining the various sports league that may be eligible for the incentive; and
- 3. Providing a definition of sports-league jobs.1

EFFECTIVE DATE: November 1, 2024

REVENUE IMPACT: No changes in revenue are anticipated due to the revenue neutral features of both the *Oklahoma Quality Jobs Program Act* and this proposal.

ATTACHMENT TO REVENUE IMPACT - HB 3959 [CS for ENGR] Prepared: 4/9/24

PROPOSED NEW LAW:

HB 3959 proposes to enact a new rebate program called the *Oklahoma Five Major Sports Leagues Rebate Program Act* for qualifying establishments. This measure creates a rebate similar to the incentive payments under the *Oklahoma Quality Jobs Program Act*.² The amount of the quarterly rebate payment is equal to the net benefit rate³ determined by Oklahoma Department of Commerce (Commerce) multiplied by the actual gross payroll of sports-league jobs as verified by the Oklahoma Employment Security Commission. The maximum annual rebate may not exceed \$10 million in a year. Unlike the incentive payments under the current *Oklahoma Quality Jobs Program Act*⁴ there is no end date for this rebate.

To qualify for the rebate:

- ➤ The establishment must be classified in the NAICS Manual under U.S. Industry No. 711211 and a professional sports team from one of the five major sports leagues (NFL, NBA, NHL, MLB, MLS).
- > If the establishment previously qualified for Oklahoma's Quality Jobs Program, its contract must have expired or been terminated.
- ➤ The establishment must have an annual gross payroll for sports-league jobs projected by Commerce of at least \$10 million within 1 year of the first complete calendar quarter following the start date.
- At least 80% of the sports-league jobs created must be full-time-equivalent positions working an average of 30+ hours per week.
- > The establishment must apply to and be approved by Commerce.
- > The establishment must continue business operations in Oklahoma for at least 3 years after the initial rebate claim.

The Oklahoma Tax Commission has the following key roles and duties related to this rebate program:

- Verify payroll and job creation data submitted by establishments on their quarterly rebate claims.
- > Issue rebate payments to qualified establishments by multiplying the net benefit rate and verified gross payroll.
- Enforce requirements related to establishments retaining eligibility for payments based on meeting job creation and payroll thresholds.
- Withhold portions of revenue from state taxes paid by businesses to fund the Oklahoma Five Major Sports Leagues Rebate Payment Fund used to pay the rebates.
- > Coordinate with Commerce, which calculates cost-benefit analyses and provides the net benefit rate used in determining rebate payment amounts.

² Like the *Oklahoma Quality Jobs Program Act* (68 O.S. § 3604(L)) 5% of the quarterly incentive payment amount under this proposal are transferred by the OTC to the Oklahoma Quick Action Closing Fund.

³Based on conversations with Commerce, the net benefit rate calculation should result in revenue neutrality for the rebate payments.

⁴ Under the *Oklahoma Quality Jobs Program Act* (68 O.S. § 3601) et seq., incentive payments are limited to 10 years per contract.
