ATTACHMENT TO REVENUE IMPACT - SB 608 [Engrossed] Prepared 2/27/23

Engrossed SB 608 proposes to amend 68 O.S. § 212. Under current law, before any license or permit may be canceled, or the issuance, reinstatement, or extension refused, the Oklahoma Tax Commission (OTC) shall give the permit holder an opportunity to appear at a hearing and show cause why such action should not be taken.

Under the proposal, a show cause hearing is held only for cancellation of a permit or license. If the OTC refuses to issue a permit, reinstate a permit or extend a permit, the permit holder can file a written protest within 60 days of the date on the notice. If a hearing is requested, the applicant must be given at least 10 days' notice of the hearing.

In addition, the proposal amends 68 O.S. § 1364 to require an applicant to request a hearing to show cause why a permit should be renewed within 20 days of the date of the written notification of the notice of refusal. The proposal further provides that the OTC may revoke or suspend a permit after giving 20 days' notice in writing of the time and place of hearing to show why the permit should not be revoked. Currently, the OTC may revoke or suspend a permit after giving 10 days' notice of hearing to show cause.

The proposal is not expected to impact revenue.
