16	SECTION 1. AMENDATORY 12 O.S. 2021, Section 1148.15, is
17	amended to read as follows:
18	Section 1148.15 The actions for unlawful entry and detainer <u>,</u>
19	commonly known as an eviction, standing alone or when joined with a
20	claim for collection of rent or damages to the premises, or both,
21	shall be commenced by filing an affidavit in substantially the
22	following form with the clerk of the court: with the clerk of the
23	court. This affidavit is to be developed by the Administrative
24	Office of the Courts using plain and understandable language.

14	Section 1148.16 The summons to be issued in an action for
15	forcible entry and detainer, commonly known as an eviction, shall be
16	in the following <u>a</u> form: <u>developed in plain and understandable</u>
17	language by the Administrative Office of the Courts. The summons
18	shall be delivered no less than three (3) days before the scheduled
19	time and date of the court hearing. This scheduled date and time
20	shall not be less than five (5) days from the date the summons is
21	<u>issued.</u>
22	SUMMONS
23	The State of Oklahoma to the within-named defendant:

1	You are hereby directed to relinquish immediately to the
2	plaintiff herein total possession of the real property described as
3	
4	or to appear and show cause why you should be permitted to retain
5	control and possession thereof.
6	This matter shall be heard at (name or
7	address of building), in, County of,
8	State of Oklahoma, at the hour of o'clock of day of
9	month, 19, or at the same time and place three (3) days
10	after service hereof, whichever is the latter. (This date shall be
11	not less than five (5) days from the date summons is issued). You
12	are further notified that if you do not appear on the date shown,
13	judgment will be given against you as follows:
14	For the amount of the claim for deficient rent and/or damages to
15	the premises, as it is stated in the affidavit of the plaintiff and
16	for possession of the real property described in said affidavit,
17	whereupon a writ of assistance shall issue directing the sheriff to
18	remove you from said premises and take possession thereof.
19	In addition, a judgment for costs of the action, including
20	attorney's fees and other costs, may also be given.
