7	An Act relating to revenue and taxation; amending 68 O.S. 2021, Sections 2355, as last amended by Section

10	rates of individual income tax; modifying provisions related to standard deduction amounts; amending 68

12	income tax rate for certain natural persons; and providing an effective date.

15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. AMENDATORY 68 O.S. 2021, Section 2355, as
17	last amended by Section 1, Chapter 27, 1st Extraordinary Session,
18	O.S.L. 2023 (68 O.S. Supp. 2023, Section 2355), is amended to read
19	as follows:
20	Section 2355. A. Individuals. For all taxable years beginning
21	after December 31, 1998, and before January 1, 2006, a tax is hereby
22	imposed upon the Oklahoma taxable income of every resident or
23	nonresident individual, which tax shall be computed at the option of
24	the taxpayer under one of the two following methods:

1 1. METHOD 1.

23	B. Individuals. For all taxable years beginning on or after

24 January 1, 2008, and ending any tax year which begins after December

1 31, 2015, for which the determination required pursuant to Sections
2 4 <u>2355.1F</u> and 5 <u>2355.1G</u> of this act <u>title</u> is made by the State Board
3 of Equalization, a tax is hereby imposed upon the Oklahoma taxable
4 income of every resident or nonresident individual, which tax shall
5 be computed as follows:

6 1. Single individuals and married individuals filing7 separately:

8	(a)	1/2% tax on first \$1,000.00 or part thereof,
9	(b)	1% tax on next \$1,500.00 or part thereof,
10	(C)	2% tax on next \$1,250.00 or part thereof,
11	(d)	3% tax on next \$1,150.00 or part thereof,
12	(e)	4% tax on next \$2,300.00 or part thereof,
13	(f)	5% tax on next \$1,500.00 or part thereof,
14	(g)	5.50% tax on the remainder for the 2008 tax year and
15		any subsequent tax year unless the rate prescribed by
16		subparagraph (h) of this paragraph is in effect, and
17	(h)	5.25% tax on the remainder for the 2009 and subsequent
18		tax years. The decrease in the top marginal
19		individual income tax rate otherwise authorized by
20		this subparagraph shall be contingent upon the
21		determination required to be made by the State Board
22		of Equalization pursuant to Section 2355.1A of this
23		title.

C. Individuals. For all taxable years beginning on or after
January 1, 2024, a tax is hereby imposed upon the Oklahoma taxable

income of every resident or nonresident individual, which tax shall 1 2 be computed as follows: 1. Single individuals and married individuals filing 3 4 separately: (a) 0.25% tax on first \$1,000.00 or part thereof, 5 (b) 0.75% tax on next \$1,500.00 or part thereof, 6 7 (c) 1.75% tax on next \$1,250.00 or part thereof, 2.75% tax on next \$1,150.00 or part thereof, 8 (d) 9 (e) 3.75% tax on next \$2,300.00 or part thereof, (f) 4.75% tax on the remainder. 10 11 2. Married individuals filing jointly and surviving spouse to 12 the extent and in the manner that a surviving spouse is permitted to 13 file a joint return under the provisions of the Internal Revenue 14 Code and heads of households as defined in the Internal Revenue 15 Code: 16 (a) 0.25% tax on first \$2,000.00 or part thereof, 17 0.75% tax on next \$3,000.00 or part thereof, (b) 18 1.75% tax on next \$2,500.00 or part thereof, $\left(c \right)$ 19 (d) 2.75% tax on next \$2,300.00 or part thereof, 20 (e) 3.75% tax on next \$4,600.00 or part thereof, 21 (f) 4.75% tax on the remainder levied at the rate of four 22 and twenty-five hundredths percent (4.25%). 23 No deduction for federal income taxes paid shall be allowed to 24 any taxpayer to arrive at taxable income. The tax levied pursuant

1 to this subsection shall be levied only upon the amounts of Oklahoma
2 taxable income in excess of:

<u>1. Nine Thousand Seven Hundred Fifty Dollars (\$9,750.00) for</u>
 <u>taxpayers having a single or married filing separate status; or</u>
 <u>2. Sixteen Thousand Two Hundred Fifty Dollars (\$16,250.00) for</u>
 head of household filing status; or

7 <u>3. Nineteen Thousand Four Hundred Fifty Dollars (\$19,450.00)</u>
8 for taxpayers having a joint return filing status.

D. Nonresident aliens. In lieu of the rates set forth in
subsection A above this section, there shall be imposed on
nonresident aliens, as defined in the Internal Revenue Code, a tax
of eight percent (8%) instead of thirty percent (30%) as used in the
Internal Revenue Code, with respect to the Oklahoma taxable income
of such nonresident aliens as determined under the provision of the
Oklahoma Income Tax Act.

16 Every payer of amounts covered by this subsection shall deduct 17 and withhold from such amounts paid each payee an amount equal to 18 eight percent (8%) thereof. Every payer required to deduct and 19 withhold taxes under this subsection shall for each quarterly period 20 on or before the last day of the month following the close of each 21 such quarterly period, pay over the amount so withheld as taxes to 22 the Tax Commission, and shall file a return with each such payment. 23 Such return shall be in such form as the Tax Commission shall 24 prescribe. Every payer required under this subsection to deduct and

1 withhold a tax from a payee shall, as to the total amounts paid to each payee during the calendar year, furnish to such payee, on or 2 before January 31, of the succeeding year, a written statement 3 4 showing the name of the payer, the name of the payee and the payee's 5 Social Security account number, if any, the total amount paid subject to taxation, and the total amount deducted and withheld as 6 7 tax and such other information as the Tax Commission may require. Any payer who fails to withhold or pay to the Tax Commission any 8 9 sums herein required to be withheld or paid shall be personally and 10 individually liable therefor to the State of Oklahoma.

E. Corporations. For all taxable years beginning after December 31, 2021, a tax is hereby imposed upon the Oklahoma taxable income of every corporation doing business within this state or deriving income from sources within this state in an amount equal to four percent (4%) thereof.

There shall be no additional Oklahoma income tax imposed on accumulated taxable income or on undistributed personal holding company income as those terms are defined in the Internal Revenue Code.

F. Certain foreign corporations. In lieu of the tax imposed in the first paragraph of subsection $\frac{1}{2}$ of this section, for all taxable years beginning after December 31, 2021, there shall be imposed on foreign corporations, as defined in the Internal Revenue Code, a tax of four percent (4%) instead of thirty percent (30%) as

used in the Internal Revenue Code, where such income is received
 from sources within Oklahoma, in accordance with the provisions of
 the Internal Revenue Code and the Oklahoma Income Tax Act.

4 Every payer of amounts covered by this subsection shall deduct 5 and withhold from such amounts paid each payee an amount equal to four percent (4%) thereof. Every payer required to deduct and 6 7 withhold taxes under this subsection shall for each quarterly period on or before the last day of the month following the close of each 8 9 such quarterly period, pay over the amount so withheld as taxes to 10 the Tax Commission, and shall file a return with each such payment. 11 Such return shall be in such form as the Tax Commission shall 12 prescribe. Every payer required under this subsection to deduct and 13 withhold a tax from a payee shall, as to the total amounts paid to 14 each payee during the calendar year, furnish to such payee, on or 15 before January 31, of the succeeding year, a written statement 16 showing the name of the payer, the name of the payee and the payee's 17 Social Security account number, if any, the total amounts paid 18 subject to taxation, the total amount deducted and withheld as tax 19 and such other information as the Tax Commission may require. Any 20 payer who fails to withhold or pay to the Tax Commission any sums 21 herein required to be withheld or paid shall be personally and 22 individually liable therefor to the State of Oklahoma.

G. Fiduciaries. A tax is hereby imposed upon the Oklahoma
taxable income of every trust and estate at the same rates as are

provided in subsection B or C of this section for single
 individuals. Fiduciaries are not allowed a deduction for any
 federal income tax paid.

4 н. Tax rate tables. For all taxable years beginning after 5 December 31, 1991, in lieu of the tax imposed by subsection A, B, or C of this section, as applicable there is hereby imposed for each 6 7 taxable year on the taxable income of every individual, whose taxable income for such taxable year does not exceed the ceiling 8 9 amount, a tax determined under tables, applicable to such taxable year which shall be prescribed by the Tax Commission and which shall 10 11 be in such form as it determines appropriate. In the table so 12 prescribed, the amounts of the tax shall be computed on the basis of 13 the rates prescribed by subsection A, B or C of this section. For 14 purposes of this subsection, the term "ceiling amount" means, with 15 respect to any taxpayer, the amount determined by the Tax Commission 16 for the tax rate category in which such taxpayer falls.

SECTION 2. AMENDATORY 68 O.S. 2021, Section 2358, as amended by Section 2, Chapter 341, O.S.L. 2022 (68 O.S. Supp. 2023, Section 2358), is amended to read as follows:

20 Section 2358. For all tax years beginning after December 31, 21 1981, taxable income and adjusted gross income shall be adjusted to 22 arrive at Oklahoma taxable income and Oklahoma adjusted gross income 23 as required by this section.

24

A. The taxable income of any taxpayer shall be adjusted to arrive at Oklahoma taxable income for corporations and Oklahoma adjusted gross income for individuals, as follows:

There shall be added interest income on obligations of any
 state or political subdivision thereto which is not otherwise
 exempted pursuant to other laws of this state, to the extent that
 such interest is not included in taxable income and adjusted gross
 income.

9 2. There shall be deducted amounts included in such income that 10 the state is prohibited from taxing because of the provisions of the 11 Federal Constitution, the State Constitution, federal laws or laws 12 of Oklahoma.

13 3. The amount of any federal net operating loss deduction shall14 be adjusted as follows:

15 For carryovers and carrybacks to taxable years a. 16 beginning before January 1, 1981, the amount of any 17 net operating loss deduction allowed to a taxpayer for 18 federal income tax purposes shall be reduced to an 19 amount which is the same portion thereof as the loss 20 from sources within this state, as determined pursuant 21 to this section and Section 2362 of this title, for 22 the taxable year in which such loss is sustained is of 23 the total loss for such year;

24

1 b. For carryovers and carrybacks to taxable years 2 beginning after December 31, 1980, the amount of any net operating loss deduction allowed for the taxable 3 4 year shall be an amount equal to the aggregate of the 5 Oklahoma net operating loss carryovers and carrybacks to such year. Oklahoma net operating losses shall be 6 7 separately determined by reference to Section 172 of the Internal Revenue Code, 26 U.S.C., Section 172, as 8 9 modified by the Oklahoma Income Tax Act, Section 2351 10 et seq. of this title, and shall be allowed without 11 regard to the existence of a federal net operating 12 loss. For tax years beginning after December 31, 13 2000, and ending before January 1, 2008, the years to 14 which such losses may be carried shall be determined 15 solely by reference to Section 172 of the Internal 16 Revenue Code, 26 U.S.C., Section 172, with the 17 exception that the terms "net operating loss" and 18 "taxable income" shall be replaced with "Oklahoma net 19 operating loss" and "Oklahoma taxable income". For 20 tax years beginning after December 31, 2007, and 21 ending before January 1, 2009, years to which such 22 losses may be carried back shall be limited to two (2) 23 years. For tax years beginning after December 31, 24 2008, the years to which such losses may be carried

back shall be determined solely by reference to Section 172 of the Internal Revenue Code, 26 U.S.C., Section 172, with the exception that the terms "net operating loss" and "taxable income" shall be replaced with "Oklahoma net operating loss" and "Oklahoma taxable income".

7 4. Items of the following nature shall be allocated as
8 indicated. Allowable deductions attributable to items separately
9 allocable in subparagraphs a, b and c of this paragraph, whether or
10 not such items of income were actually received, shall be allocated
11 on the same basis as those items:

- a. Income from real and tangible personal property, such
 as rents, oil and mining production or royalties, and
 gains or losses from sales of such property, shall be
 allocated in accordance with the situs of such
 property;
- b. Income from intangible personal property, such as
 interest, dividends, patent or copyright royalties,
 and gains or losses from sales of such property, shall
 be allocated in accordance with the domiciliary situs
 of the taxpayer, except that:
- (1) where such property has acquired a nonunitary
 business or commercial situs apart from the
 domicile of the taxpayer such income shall be

allocated in accordance with such business or commercial situs; interest income from investments held to generate working capital for a unitary business enterprise shall be included in apportionable income; a resident trust or resident estate shall be treated as having a separate commercial or business situs insofar as undistributed income is concerned, but shall not be treated as having a separate commercial or business situs insofar as distributed income is concerned,

(2) for taxable years beginning after December 31, 2003, capital or ordinary gains or losses from the sale of an ownership interest in a publicly traded partnership, as defined by Section 7704(b) of the Internal Revenue Code, shall be allocated to this state in the ratio of the original cost of such partnership's tangible property in this state to the original cost of such partnership's tangible property everywhere, as determined at the time of the sale; if more than fifty percent (50%) of the value of the partnership's assets consists of intangible assets, capital or ordinary gains or losses from the sale of an

1 ownership interest in the partnership shall be 2 allocated to this state in accordance with the sales factor of the partnership for its first 3 4 full tax period immediately preceding its tax 5 period during which the ownership interest in the 6 partnership was sold; the provisions of this 7 division shall only apply if the capital or ordinary gains or losses from the sale of an 8 9 ownership interest in a partnership do not 10 constitute qualifying gain receiving capital 11 treatment as defined in subparagraph a of paragraph 2 of subsection F of this section, 12 13 (3) income from such property which is required to be 14 allocated pursuant to the provisions of paragraph 15 5 of this subsection shall be allocated as herein 16 provided; 17 с. Net income or loss from a business activity which is 18 not a part of business carried on within or without 19 the state of a unitary character shall be separately 20 allocated to the state in which such activity is 21 conducted; 22 d. In the case of a manufacturing or processing

enterprise the business of which in Oklahoma consistssolely of marketing its products by:

- 1 (1) sales having a situs without this state, shipped 2 directly to a point from without the state to a 3 purchaser within the state, commonly known as 4 interstate sales,
 - (2) sales of the product stored in public warehouses within the state pursuant to "in transit" tariffs, as prescribed and allowed by the Interstate Commerce Commission, to a purchaser within the state,
- 10 (3) sales of the product stored in public warehouses
 11 within the state where the shipment to such
 12 warehouses is not covered by "in transit"
 13 tariffs, as prescribed and allowed by the
 14 Interstate Commerce Commission, to a purchaser
 15 within or without the state,

16 the Oklahoma net income shall, at the option of the 17 taxpayer, be that portion of the total net income of 18 the taxpayer for federal income tax purposes derived 19 from the manufacture and/or processing and sales 20 everywhere as determined by the ratio of the sales 21 defined in this section made to the purchaser within 22 the state to the total sales everywhere. The term 23 "public warehouse" as used in this subparagraph means

1 a licensed public warehouse, the principal business of 2 which is warehousing merchandise for the public; In the case of insurance companies, Oklahoma taxable 3 e. 4 income shall be taxable income of the taxpayer for 5 federal tax purposes, as adjusted for the adjustments provided pursuant to the provisions of paragraphs 1 6 7 and 2 of this subsection, apportioned as follows: except as otherwise provided by division (2) of 8 (1)9 this subparagraph, taxable income of an insurance 10 company for a taxable year shall be apportioned 11 to this state by multiplying such income by a fraction, the numerator of which is the direct 12 13 premiums written for insurance on property or 14 risks in this state, and the denominator of which 15 is the direct premiums written for insurance on 16 property or risks everywhere. For purposes of 17 this subsection, the term "direct premiums 18 written" means the total amount of direct 19 premiums written, assessments and annuity 20 considerations as reported for the taxable year 21 on the annual statement filed by the company with 22 the Insurance Commissioner in the form approved 23 by the National Association of Insurance

Commissioners, or such other form as may be prescribed in lieu thereof,

if the principal source of premiums written by an (2) insurance company consists of premiums for reinsurance accepted by it, the taxable income of such company shall be apportioned to this state by multiplying such income by a fraction, the numerator of which is the sum of (a) direct premiums written for insurance on property or risks in this state, plus (b) premiums written for reinsurance accepted in respect of property or risks in this state, and the denominator of which is the sum of (c) direct premiums written for insurance on property or risks everywhere, plus (d) premiums written for reinsurance accepted in respect of property or risks everywhere. For purposes of this paragraph, premiums written for reinsurance accepted in respect of property or risks in this state, whether or not otherwise determinable, may at the election of the company be determined on the basis of the proportion which premiums written for insurance accepted from companies commercially domiciled in Oklahoma bears to

premiums written for reinsurance accepted from all sources, or alternatively in the proportion which the sum of the direct premiums written for insurance on property or risks in this state by each ceding company from which reinsurance is accepted bears to the sum of the total direct premiums written by each such ceding company for the taxable year.

9 5. The net income or loss remaining after the separate allocation in paragraph 4 of this subsection, being that which is 10 11 derived from a unitary business enterprise, shall be apportioned to 12 this state on the basis of the arithmetical average of three factors 13 consisting of property, payroll and sales or gross revenue 14 enumerated as subparagraphs a, b and c of this paragraph. Net 15 income or loss as used in this paragraph includes that derived from 16 patent or copyright royalties, purchase discounts, and interest on 17 accounts receivable relating to or arising from a business activity, 18 the income from which is apportioned pursuant to this subsection, 19 including the sale or other disposition of such property and any 20 other property used in the unitary enterprise. Deductions used in 21 computing such net income or loss shall not include taxes based on 22 or measured by income. Provided, for corporations whose property 23 for purposes of the tax imposed by Section 2355 of this title has an 24 initial investment cost equaling or exceeding Two Hundred Million

Dollars (\$200,000,000.00) and such investment is made on or after 1 2 July 1, 1997, or for corporations which expand their property or facilities in this state and such expansion has an investment cost 3 equaling or exceeding Two Hundred Million Dollars (\$200,000,000.00) 4 5 over a period not to exceed three (3) years, and such expansion is 6 commenced on or after January 1, 2000, the three factors shall be 7 apportioned with property and payroll, each comprising twenty-five percent (25%) of the apportionment factor and sales comprising fifty 8 9 percent (50%) of the apportionment factor. The apportionment 10 factors shall be computed as follows:

11a.The property factor is a fraction, the numerator of12which is the average value of the taxpayer's real and13tangible personal property owned or rented and used in14this state during the tax period and the denominator15of which is the average value of all the taxpayer's16real and tangible personal property everywhere owned17or rented and used during the tax period.

18 (1) Property, the income from which is separately
19 allocated in paragraph 4 of this subsection,
20 shall not be included in determining this
21 fraction. The numerator of the fraction shall
22 include a portion of the investment in
23 transportation and other equipment having no
24 fixed situs, such as rolling stock, buses, trucks

1 and trailers, including machinery and equipment 2 carried thereon, airplanes, salespersons' 3 automobiles and other similar equipment, in the 4 proportion that miles traveled in Oklahoma by 5 such equipment bears to total miles traveled, 6 Property owned by the taxpayer is valued at its (2) 7 original cost. 14 With respect to sales of stock or ownership (2)15 interest in or sales of all or substantially all 16 of the assets of an Oklahoma company, limited 17 liability company, partnership or Oklahoma 18 proprietorship business enterprise, the deduction 19 described in this subsection shall not apply 20 unless the pass-through entity that makes the 21 sale has held the stock or ownership interest for 22 not less than two (2) uninterrupted years prior 23 to the date of the transaction that created the 24 capital gain, and each pass-through entity

1 included in the chain of ownership has been a 2 member, partner or shareholder of the passthrough entity in the tier immediately below it 3 for an uninterrupted period of not less than two 4 5 (2) years. For purposes of this division, uninterrupted ownership prior to July 1, 2007, 6 7 shall be included in the determination of the required holding period prescribed by this 8 9 division, and 10 f. "Oklahoma proprietorship business enterprise" means a 11 business enterprise whose income and expenses have 12 been reported on Schedule C or F of an individual 13 taxpayer's federal income tax return, or any similar 14 successor schedule published by the Internal Revenue 15 Service and whose primary headquarters have been 16 located in Oklahoma for at least three (3) 17 uninterrupted years prior to the date of the 18 transaction from which the net capital gains arise. 19 For purposes of computing its Oklahoma taxable income G. 1. 20 under this section, the dividends-paid deduction otherwise allowed 21 by federal law in computing net income of a real estate investment 22 trust that is subject to federal income tax shall be added back in 23 computing the tax imposed by this state under this title if the real 24 estate investment trust is a captive real estate investment trust.

2. For purposes of computing its Oklahoma taxable income under this section, a taxpayer shall add back otherwise deductible rents and interest expenses paid to a captive real estate investment trust that is not subject to the provisions of paragraph 1 of this subsection. As used in this subsection:

- a. the term "real estate investment trust" or "REIT"
 means the meaning ascribed to such term in Section 856
 of the Internal Revenue Code,
- 9 b. the term "captive real estate investment trust" means a real estate investment trust, the shares or 10 11 beneficial interests of which are not regularly traded 12 on an established securities market and more than 13 fifty percent (50%) of the voting power or value of 14 the beneficial interests or shares of which are owned 15 or controlled, directly or indirectly, or 16 constructively, by a single entity that is:
- 17 (1) treated as an association taxable as a
 18 corporation under the Internal Revenue Code, and
 - (2) not exempt from federal income tax pursuant to the provisions of Section 501(a) of the Internal Revenue Code.

The term shall not include a real estate investment trust that is intended to be regularly traded on an established securities market, and that satisfies the

3. For purposes of this subsection, the constructive ownership rules of Section 318(a) of the Internal Revenue Code, as modified by Section 856(d)(5) of the Internal Revenue Code, shall apply in determining the ownership of stock, assets, or net profits of any person.

17 4. A real estate investment trust that does not become 18 regularly traded on an established securities market within one (1) 19 year of the date on which it first becomes a real estate investment 20 trust shall be deemed not to have been regularly traded on an 21 established securities market, retroactive to the date it first 22 became a real estate investment trust, and shall file an amended 23 return reflecting such retroactive designation for any tax year or 24 part year occurring during its initial year of status as a real

estate investment trust. For purposes of this subsection, a real estate investment trust becomes a real estate investment trust on the first day it has both met the requirements of Section 856 of the Internal Revenue Code and has elected to be treated as a real estate investment trust pursuant to Section 856(c)(1) of the Internal Revenue Code.

7 SECTION 3. AMENDATORY 68 O.S. 2021, Section 2355.1P-4, 8 is amended to read as follows:

9 Section 2355.1P-4 A. For tax years beginning on or after 10 January 1, 2022, there is hereby levied on each electing pass-11 through entity the pass-through entity tax which shall be calculated 12 as follows:

With regard to each member of an electing pass-through
 entity, the electing pass-through entity shall multiply such
 member's Oklahoma distributive share of the electing pass-through
 entity's Oklahoma net entity income for the tax year by:

a. the highest Oklahoma marginal income tax rate levied
on the taxable income of natural persons pursuant to
Section 2355 of this title if the member is an
individual, trust, or estate,

b. four percent (4%) if the member is classified as a
corporation pursuant to the Internal Revenue Code, and
is not classified as an S corporation,

1 с. four percent (4%) if the member is a pass-through 2 entity, d. four percent (4%) if the member is a financial 3 institution subject to tax imposed pursuant to the 4 5 provisions of Section 2370 of this title, and the highest Oklahoma marginal income tax rate that 6 e. 7 would be applicable to any item of the electing passthrough entity's income or gain without the election 8 made pursuant to subsection F of this section, if the 9 10 member is an organization described in Section 2359 of 11 this title; and

12 2. The electing pass-through entity shall aggregate the amounts 13 determined with respect to all members pursuant to paragraph 1 of 14 this subsection and the pass-through entity tax for the applicable 15 tax year shall be equal to such aggregated tax amount for the tax 16 year with respect to which the election has been made.

B. Sections 2385.29, 2385.30 and 2385.31 of this title shall
not be applicable to an electing pass-through entity.

C. The pass-through entity tax shall be due and payable on the same date as provided for the filing of the electing pass-through entity's Oklahoma income tax return, and for tax years beginning on or after January 1, 2020, estimated tax payments shall be required as provided in Section 2385.9 of this title.

D. If the pass-through entity election results in a net entity loss for Oklahoma income tax purposes in any tax year, the net entity loss may be carried back and carried forward by the electing pass-through entity for Oklahoma income tax purposes as set forth in subparagraph b of paragraph 3 of subsection A of Section 2358 of this title.

7 Notwithstanding paragraph 2 of subsection C of Section 2368 Ε. of this title, a nonresident individual who is a member of an 8 9 electing pass-through entity is not required to file an Oklahoma 10 income tax return, if, for the taxable year, the only source of 11 income allocable or apportionable to this state for the member, or, 12 if a joint income tax return is filed, the member and his or her 13 spouse, is from one or more electing pass-through entities, and each 14 electing pass-through entity files and pays the taxes due under this 15 section.

16 F. Any entity required to file an Oklahoma partnership income 17 tax return or an Oklahoma S corporation income tax return may elect 18 to become an electing pass-through entity. The election shall be 19 made on such form and in such manner as the Oklahoma Tax Commission 20 may prescribe, and any election under this subsection shall have 21 priority over and revoke any election to file a composite Oklahoma 22 partnership return or requirement of a Subchapter S corporation to 23 report and pay tax on behalf of a nonresident shareholder for the 24 same tax year.

G. Pursuant to procedures prescribed by the Tax Commission, if the amount of tax required to be paid by a pass-through entity pursuant to the provisions of this section is not paid when due, the Oklahoma Tax Commission may revoke the pass-through entity's election under subsection F of this section effective for the first year for which the tax is not paid.

7 The election authorized by the provisions of this section н. shall be made pursuant to procedures prescribed by the Tax 8 9 Commission and shall be filed (i) within sixty (60) days of 10 enactment and pursuant to procedures prescribed by the Oklahoma Tax 11 Commission for any income tax year beginning on or after January 1, 12 2019, and prior to January 1, 2020, or (ii) for any income tax year 13 beginning on or after January 1, 2020, at any time during the 14 preceding tax year or two (2) months and fifteen (15) days after the 15 beginning of the tax year. Any such election shall be binding until 16 revoked pursuant to procedures prescribed by the Tax Commission. 17 The effective date of a revocation (i) made within two (2) months 18 and fifteen (15) days of the electing pass-through entity's taxable 19 year shall be the first day of such taxable year and (ii) made 20 during the electing pass-through entity's taxable year but after 21 such fifteenth day shall be effective on the first day of the 22 following taxable year. No election made by a pass-through entity 23 with respect to income tax to be paid by such entity using the 24 calculations prescribed by this section shall be binding on any
