AMENDATORY 47 O.S. 2021, Section 1104.18, is 17 amended to read as follows: 18 Section 1104.18. A. Twenty Dollars (\$20.00) of the fee 19 authorized by Section 1135.5 of this title for the Oklahoma State 20 Capitol Restoration License Plate shall be deposited in the Oklahoma 21 Friends of the Capitol License Plate Revolving Fund created in 22 subsection B of this section. 23 There is hereby created in the State Treasury a revolving Β. 24 fund for the Office of Management and Enterprise Services to be \_ \_

1 designated the "Oklahoma Friends of the Capitol License Plate 2 Revolving Fund". The fund shall be a continuing fund, not subject 3 to fiscal year limitations, and shall consist of all monies received 4 by the Office of Management and Enterprise Services pursuant to the 5 provisions of subsection A of this section. All monies accruing to 6 the credit of the fund are hereby appropriated and shall be budgeted 7 and expended by the Office of Management and Enterprise Services for 8 restoration and modification of the Oklahoma State Capitol. Before 9 the Office makes any expenditure from the fund, the expenditure 10 shall be approved by the State Capitol Preservation Commission 11 created pursuant to Section 4102 of Title 74 of the Oklahoma 12 Statutes. Expenditures from the fund shall be made upon warrants 13 issued by the State Treasurer against claims filed as prescribed by 14 law with the Director of the Office of Management and Enterprise 15 Services for approval and payment.

SECTION 2. AMENDATORY 73 O.S. 2021, Section 15.4, is amended to read as follows:

Section 15.4. A. There is hereby authorized the creation of a not-for-profit corporation to be known as "Friends of the Capitol" to raise funds and to assist in the preservation and enhancement of the Oklahoma <u>State</u> Capitol and surrounding <del>areas</del> grounds as defined in Section <del>1 of this title</del> <u>7 of this act</u>.

B. The board of directors of the corporation authorized in subsection A of this section shall choose its own chairperson.

C. After proper incorporation, the not-for-profit corporation is authorized and directed to apply for tax-exempt status under Section 501(c)(3) of the Internal Revenue Code (26 U.S.C., Section 501(c)(3)).

D. In addition to funds received from the general public or
other public and private sources, the not-for-profit corporation may
receive funds from state agencies at such times and in such amounts
as may be appropriated by the Legislature for the Oklahoma <u>State</u>
Capitol or made available to the corporation from state agencies
from their sources of revenue.

E. Costs to underwrite activities related to the preservation and enhancement of the Oklahoma <u>State</u> Capitol may be borne from revenues of the not-for-profit corporation.

F. Upon the incorporation, the not-for-profit corporation shall be authorized to hire staff and name advisory groups or steering committees as necessary to assist in the preservation and enhancement of the Oklahoma State Capitol.

G. The corporation shall coordinate preservation and,
 restoration, enhancement, maintenance, and modification projects in
 conjunction with and the consent approval of the State Capitol
 Preservation Commission and the Office of Management and Enterprise
 Services.

1 SECTION 3. AMENDATORY 73 O.S. 2021, Section 83.1, as 2 amended by Section 1, Chapter 91, O.S.L. 2022 (73 O.S. Supp. 2022, 3 Section 83.1), is amended to read as follows: 4 Section 83.1. A. There is hereby re-created to continue until 5 July 1, 2025 2026, in accordance with the Oklahoma Sunset Law, a 6 Capitol-Medical Center Improvement and Zoning Commission to exercise 7 the functions and perform the duties hereinafter prescribed. 8 Β. The Commission shall be composed of eleven (11) members as 9 follows: 10 1. The Director of the Office of Management and Enterprise 11 Services or his or her designee, who shall be ex officio chair of 12 the Capitol-Medical Center Improvement and Zoning Commission; 13 The Director of the Transportation Commission or his or her 2. 14 designee; 15 3. The President of the University of Oklahoma or his or her 16 designee; 17 4. Two members appointed by the President Pro Tempore of the 18 Senate; 19 5. Two members appointed by the Speaker of the House of 20 Representatives; 21 The Chair of the Planning Commission of Oklahoma City or his 6. 22 or her designee; 23 7. 8. Two members of the Commission appointed by the Governor,
 with the advice and consent of the State Senate, for four-year
 staggered terms with one term expiring on January 31 of each even numbered year.

5 C. The Commission is authorized to appoint and hire a Director, 6 who shall serve as the chief administrative officer of the 7 Commission, and other necessary personnel. The Attorney General of 8 the State of Oklahoma this state shall be the legal advisor to the 9 Commission in the same capacity as he or she is to other boards and 10 commissions.

D. At least one of the members <u>One member</u> appointed by the President Pro Tempore of the Senate and <u>one member appointed by</u> the Speaker of the House of Representatives shall be a resident within the boundaries of the Capitol-Medical Center Improvement and Zoning District as set forth in Section 83 of this title.

SECTION 4. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 93 of Title 73, unless there is created a duplication in numbering, reads as follows:

The Department of Public Safety shall create a security plan for the Oklahoma State Capitol and Oklahoma State Capitol grounds and the Governor's Mansion. The plan shall be submitted to the State Capitol Preservation Commission for review and approval. A new plan shall be submitted every three (3) years.

The department shall coordinate with the Office of Management and Enterprise Services to implement and staff the approved security plan.

<sup>4</sup> SECTION 5. AMENDATORY 73 O.S. 2021, Section 176, is <sup>5</sup> amended to read as follows:

6 Section 176. A. There shall be established created within the 7 Legislative Service Bureau the position of a permanent legislative 8 liaison Capitol Liaison committee, composed of three (3) members 9 from each house, appointed by the President Pro Tempore and Speaker, 10 respectively to the State Capitol Preservation Commission. The 11 legislative liaison Capitol Liaison committee will shall keep the 12 Legislature properly advised as to the activities of the Oklahoma 13 Capitol Improvement Authority and the Office of Management and 14 Enterprise Services by making such reports as they deem the Capitol 15 Liaison deems necessary to the appropriate committees and leadership 16 of both houses. B. The Oklahoma Capitol Improvement Authority and the Office of
Management and Enterprise Services shall provide such information,
records, testimony, or recommendations as the <u>committee</u> <u>Capitol</u>
Liaison may require.

8 <u>C. The Capitol Liaison responsibilities shall include serving</u>
 9 <u>as the primary contact for Americans with Disabilities Act (ADA)</u>
 10 compliance for the Oklahoma State Capitol.

D. All proposals for enhancement, modification, preservation, or restoration of the Oklahoma State Capitol and Oklahoma State Capitol grounds, and the Governor's Mansion and grounds, shall be submitted to the Liaison. The Liaison shall submit all proposals to the State Capitol Preservation Commission for approval.

E. All proposals for space allocation in the Oklahoma State
 Capitol and parking allocation shall be submitted to the Liaison.
 The Liaison shall submit all proposals to the State Capitol

F. All proposals for security modifications and enhancements by agencies, the Senate, or the House of Representatives shall be submitted to the Liaison. The Liaison shall submit all proposals to the State Capitol Preservation Commission for approval.

1 G. The Capitol Liaison shall be the primary liaison for all 2 tenants that occupy space in the Oklahoma State Capitol. 3 SECTION 6. AMENDATORY 73 O.S. 2021, Section 345, is 4 amended to read as follows: 5 Section 345. A. In addition to any other authorization 6 provided by law, the Oklahoma Capitol Improvement Authority is 7 authorized to issue obligations to acquire real property, together 8 with improvements located thereon, and personal property to 9 construct improvements to real property and to provide funding for 10 repairs, refurbishments and improvements to real and personal 11 property of the Oklahoma State Capitol Building in a total amount 12 not to exceed One Hundred Twenty Million Dollars (\$120,000,000.00). 13 The funds shall be used for the renovation, repair and remodeling of 14 the Oklahoma State Capitol Building.

15 The Authority may hold title to the property and Β. 16 improvements until such time as any obligations issued for this 17 purpose are retired or defeased and may lease the property and 18 improvements to the Office of Management and Enterprise Services. 19 Upon final redemption or defeasance of the obligations created 20 pursuant to this section, title to the property and improvements 21 shall be transferred from the Oklahoma Capitol Improvement Authority 22 to the Office of Management and Enterprise Services.

C. For the purposes of paying the costs for construction of the real property and improvements, and providing funding for the

1 project authorized in subsection A of this section, and for the 2 purpose authorized in subsection D of this section, the Authority is 3 hereby authorized to borrow monies on the credit of the income and 4 revenues to be derived from the leasing of such property and 5 improvements and, in anticipation of the collection of such income 6 and revenues, to issue negotiable obligations in a total amount not 7 to exceed One Hundred Twenty Million Dollars (\$120,000,000.00) 8 whether issued in one or more series. The Authority is authorized 9 to capitalize interest on the obligations issued pursuant to this 10 section for a period of not to exceed one (1) year from the date of 11 issuance. For subsequent fiscal years, it is the intent of the 12 Legislature to appropriate to the Office of Management and 13 Enterprise Services sufficient monies to make rental payments for 14 the purpose of retiring the obligations created pursuant to this 15 To the extent funds are available from the proceeds of the section. 16 borrowing authorized by this subsection, the Oklahoma Capitol 17 Improvement Authority shall provide for the payment of professional 18 fees and associated costs related to the project authorized in 19 subsection A of this section.

D. The Authority may issue obligations in one or more series and in conjunction with other issues of the Authority. The Authority is authorized to hire bond counsel, financial consultants, and such other professionals as it may deem necessary to provide for the efficient sale of the obligations and may utilize a portion of

<sup>1</sup> the proceeds of any borrowing to create such reserves as may be <sup>2</sup> deemed necessary and to pay costs associated with the issuance and <sup>3</sup> administration of such obligations.

4 The obligations authorized under this section may be sold at Е. 5 either competitive or negotiated sale, as determined by the 6 Authority, and in such form and at such prices as may be authorized 7 by the Authority. The Authority may enter into agreements with such 8 credit enhancers and liquidity providers as may be determined 9 necessary to efficiently market the obligations. The obligations 10 may mature and have such provisions for redemption as shall be 11 determined by the Authority, but in no event shall the final 12 maturity of such obligations occur later than ten (10) years from 13 the first principal maturity date.

F. Any interest earnings on funds or accounts created for the purposes of this section may be utilized as partial payment of the annual debt service or for the purposes directed by the Authority.

G. The obligations issued under this section, the transfer thereof and the interest earned on such obligations, including any profit derived from the sale thereof, shall not be subject to taxation of any kind by the State of Oklahoma this state, or by any county, municipality or political subdivision therein.

H. The Authority may direct the investment of all monies in any
 funds or accounts created in connection with the offering of the
 obligations authorized under this section. Such investments shall

<sup>1</sup> be made in a manner consistent with the investment guidelines of the <sup>2</sup> State Treasurer. The Authority may place additional restrictions on <sup>3</sup> the investment of such monies if necessary to enhance the <sup>4</sup> marketability of the obligations.

5 I. There is hereby created a State Capitol Repair Expenditure 6 Oversight Committee. The proceeds from the sale of obligations 7 issued pursuant to the provisions of this section and Section 1 of 8 Enrolled House Bill No. 3168 of the 2nd Session of the 55th Oklahoma 9 Legislature that are needed for repairs to the interior and exterior 10 of the State Capitol shall be subject to the approval of the State 11 Capitol Repair Expenditure Oversight Committee; provided, however, 12 the expenditure of those proceeds shall be subject to a request for 13 proposal process.

<sup>14</sup> The Committee shall be composed of nine (9) members as follows: <sup>15</sup> 1. Three persons to be appointed by the Governor, one of whom <sup>16</sup> shall serve as chair of the Committee;

17 2. Three legislators to be appointed by the Speaker of the 18 House of Representatives, two of whom shall be members of the 19 majority political party and one of whom shall be a member of the 20 minority political party; and

3. Three legislators to be appointed by the President Pro Tempore of the Senate, two of whom shall be members of the majority political party and one of whom shall be a member of the minority political party. Five members of the Committee shall constitute a

2	action taken by the Committee. The Committee shall be staffed by
3	employees of the Office of Management and Enterprise Services. The
4	Committee shall be subject to the Oklahoma Open Meeting Act.
5	J. The Committee shall deliver a preliminary plan for the
6	renovation, repair and remodeling of the State Capitol to the
7	Director of the Office of Management and Enterprise Services no
8	later than December 31, 2014. The preliminary plan shall include
9	the following components:
10	1. Establishment of the Office of Management and Enterprise
11	Services' goal and criteria for use by the vendor; and
12	2. Selection criteria for the design-build team vendor to be
13	selected through a Request For Proposal process.
14	K. Following receipt of the preliminary plan as approved by the
15	Committee, the Office of Management and Enterprise Services shall
16	solicit Requests For Proposals to select the vendor for the project.
17	L. The Committee shall deliver a final plan to the Director of
18	the Office of Management and Enterprise Services no later than June
19	30, 2015. The final plan shall include the following components:
20	1. Approval of the final scope of work developed by the vendor;

22	2. Approval of the project phasing developed by the vendor.
23	M. Following delivery of the final plan, the Committee shall
24	continue to oversee the expenditure of proceeds from the sale of

<sup>8</sup> aligned with recognized values, created by the conscious use of
<sup>9</sup> skill and creative imagination-<u>;</u>

10 <u>3. "Design standards" means a document that is produced for the</u> 11 purpose of guiding review of proposed alterations to the Oklahoma 12 <u>State Capitol, Governor's Mansion, and respective grounds.</u>

Design standards set the acceptable level of finishes for the historic fabric, features, and materials in use in the Oklahoma State Capitol.

18 <u>4. "Enhancement" means an increase or improvement upon the</u> 19 <u>quality, value, or extent of the original design intent of the</u> 20 <u>Oklahoma State Capitol, Governor's Mansion, or the respective</u> 21 grounds;

22 <u>5. "Grounds" means all land surrounding the Oklahoma State</u>
23 <u>Capitol and bordered by Lincoln Boulevard, and the land contained</u>
24 <u>within the fence line surrounding the Governor's Mansion;</u>

1	6. "Maintenance" means keeping spaces, structures, and
2	infrastructure in proper operating condition in a routine,
3	scheduled, or anticipated fashion to prevent failure or degradation;
4	7. "Modification" means any change to an existing physical
5	attribute of the Oklahoma State Capitol, Governor's Mansion, or the
6	respective grounds;
7	8. "Preservation" means the act or process of applying measures
8	necessary to sustain the existing form, integrity, and materials of
9	a historic property. Work including preliminary measures to protect
10	and stabilize the property, generally focusing upon the ongoing
11	maintenance and repair of historic materials and features, rather
12	than extensive replacement and new construction; and
13	9. "Restoration" means the act or process of accurately
14	depicting the form, features, and character of the Oklahoma State
15	Capitol as the building appeared in 1917, and dome in 2002, by means
16	of the removal of features from later periods in its history and
17	reconstruction of missing features from the restoration period.
18	SECTION 8. AMENDATORY 74 O.S. 2021, Section 4102, is
19	amended to read as follows:
20	Section 4102. There is hereby re-created, to continue until
21	July 1, 2024 July 1, 2028, in accordance with the provisions of the
22	Oklahoma Sunset Law, the State Capitol Preservation Commission which
23	shall be responsible for planning and supervising the preservation

22	5. One member of the Senate appointed by the President Pro

5	8. One former member of the House of Representatives appointed

2	Pro Tempore of the Senate, and the Speaker of the House of

4	3. One of the members appointed by the Governor, the President

6	Representatives shall serve a five-year term.
7	The term of office for each successor shall be for five (5)
8	years. Any member of the Legislature who is appointed to the
9	Commission shall serve only as long as the member is a member of the
10	respective house from which the member was appointed. All appointed
11	voting and ex officio non-voting members of the State Capitol
12	Preservation Commission shall serve at the pleasure of their
13	appointing authority.
14	C. The Commission shall elect a chair and a vice-chair from its
15	membership to serve for a period of two (2) years. The first chair
16	of the Commission shall be the Governor, or designee, who shall
17	serve a term of two (2) years. Thereafter, the chair of the
18	Commission shall rotate between the President Pro Tempore of the
19	Senate, or designee, the Speaker of the House of Representatives, or
20	designee, and the Governor, or designee, for two-year increments in
21	perpetuity. Members of the Commission shall not be compensated
22

D. The Office of Management and Enterprise Services shall make
the necessary arrangements for support services for the State
Capitol Preservation Commission. The State Capitol Preservation
Commission shall meet at least once per quarter and at the call of
the chair as needed. A quorum of the voting members shall be
present for any action taken. A quorum is the majority of the
appointed voting members. The Commission shall be subject to the
Oklahoma Open Meeting Act.
E. The Commission functions performed by the Governor,
President Pro Tempore of the Senate, Speaker of the House of
Representatives, Secretary of State, and appointed senators and
representatives are additional functions of their other public
offices and duties.
SECTION 10. AMENDATORY 74 O.S. 2021, Section 4104, is
amended to read as follows:
Section 4104. A. The State Capitol Preservation Commission
shall provide oversight to the Capitol Liaison and the Office of
Management and Enterprise Services on duties for management and
maintenance of the Oklahoma State Capitol and shall:
1. Research, plan, and have control of modifications and decor
of the interior and exterior of the Capitol and the Governor's
Mansion Approve the maintenance, restoration, preservation,

19	Long-Range Capital Planning Commission As of the effective date of
20	this act, the State Capitol Preservation Commission shall assume
21	oversight responsibility of the Capitol Restoration Project from the
22	State Capitol Repair Expenditure Oversight Committee created in
23	Section 345 of Title 73 of the Oklahoma Statutes.

5. Make recommendations to the State Capitol Preservation Commission for preservation zones and design standards.

The Director of the Office of Management and Enterprise Services may contract for the services of a Capitol Architect and Curator or employ such an individual on either a full- or part-time basis. Compensation for the position will be in accord with similar professional positions in state government.

8 SECTION 12. NEW LAW A new section of law to be codified 9 in the Oklahoma Statutes as Section 4105.1 of Title 74, unless there 10 is created a duplication in numbering, reads as follows:

11 The Office of Management and Enterprise Services (OMES) Α. 12 shall be the custodian of the Oklahoma State Capitol, Governor's 13 Mansion, and the respective grounds. To aid in these duties, the 14 State Capitol Preservation Office is established under the State 15 Capitol Preservation Commission. All administration and budgetary 16 decisions for the State Capitol Preservation Office shall be made by 17 the Office of Management and Enterprise Services with authorization 18 by the State Capitol Preservation Commission.

7. OMES shall be responsible for operation or coordinating operation of the visitor center, visitor relations activities, and tours in the Oklahoma State Capitol;

8. OMES shall be responsible for operation of all dining and vending services in the Oklahoma State Capitol and shall approve food trucks and other mobile food preparation vehicles on the grounds;

9. OMES shall be responsible for taking and approving
reservations in all meeting rooms and areas of the Oklahoma State
Capitol and grounds not allocated to the Legislature by Section 15.1
of Title 73 of the Oklahoma Statutes;

9 10. OMES shall be responsible for approving all events and 10 gatherings in the Oklahoma State Capitol and on the respective 11 grounds except for space designated in Section 15.1 of Title 73 of 12 the Oklahoma Statutes;

13 11. OMES shall coordinate with the Oklahoma Arts Council for 14 curation of and care for all exhibits, art, monuments, and memorials 15 in public areas at the Oklahoma State Capitol, Governor's Mansion, 16 and the respective grounds;

17 12. OMES shall coordinate with the Department of Public Safety 18 to ensure the safety of all visitors, employees, and elected 19 officials who are in the Oklahoma State Capitol, Governor's Mansion, 20 or on the respective grounds. In cooperation with the Department of 21 Public Safety, a security plan shall be submitted to the State 22 Capitol Preservation Commission every three (3) years; 23

10 C. The Office of Management and Enterprise Services shall 11 employ all staff and consultants necessary to perform the duties of 12 the Office including, but not limited to, a licensed architect. 13 SECTION 13. AMENDATORY 74 O.S. 2021, Section 4108, is 14 amended to read as follows:

Section 4108. The provisions of Sections 4101 through 4107
4110.1 of this title shall apply to all modifications in the
structure or decor of the <u>Oklahoma State</u> Capitol and the, Governor's
Mansion, and the respective grounds except for those immediate
emergency repairs needed to prevent loss or damage to property or to
protect the <u>health and safety of the</u> public during use of the
building <u>and any art displayed on the grounds</u>.

SECTION 14. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 4108.1 of Title 74, unless there is created a duplication in numbering, reads as follows:

1 The Oklahoma Arts Council shall be given the responsibility to 2 acquire, maintain, preserve, or restore any state-owned art that is 3 in storage or on display in the Oklahoma State Capitol, Governor's 4 Mansion, and the respective grounds. The council is authorized to 5 hold exhibitions and commissions to display art to the general 6 public. The Oklahoma Arts Council may request direct appropriations 7 or submit requests to the Office of Management and Enterprise 8 Services.

9 SECTION 15. AMENDATORY 74 O.S. 2021, Section 4109, is 10 amended to read as follows:

11 Section 4109. By the order of the Director of the Office of 12 Management and Enterprise Services, restoration and preservation 13 Maintenance, restoration, preservation, enhancement, and 14 modification projects of the Oklahoma State Capitol Building or of 15 the, Governor's Mansion, and the respective grounds may be exempted 16 from the provisions of the Public Competitive Bidding Act of 1974, 17 Section 101 et seq. of Title 61 of the Oklahoma Statutes. For 18 exempted Oklahoma State Capitol Building or Governor's Mansion 19 construction projects, the Office of Management and Enterprise 20 Services shall select among contractors qualified by past experience 21 to conduct historical preservation projects.

SECTION 16. REPEALER 74 O.S. 2021, Sections 4106 and 4107, are hereby repealed.
