9 An Act relating to health insurance; amending 36 O.S.
10 2021, Section 6903.1, which relates to exemption of
11 certain domestic health maintenance organizations
12 from certain provisions of the Health Maintenance
13 Organizations Act; updating exemptions; and providing
14 an effective date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 36 O.S. 2021, Section 6903.1, is
17 amended to read as follows:

18 Section 6903.1. Notwithstanding any other provision of this
19 title:

20 1. Domestic health maintenance organizations that contract with
21 the Oklahoma Health Care Authority to provide basic health services
22 to Medicaid recipients ~~and that do not provide basic health care~~
23 ~~services to any other group of persons shall be~~ are only subject to
24 the benefit coverage criteria and regulations of the Medicaid

1 program and are exempt from the following provisions of Sections
2 6911, 6914, 6915 and 6932 of this title:

3 a. Sections 6058, 6058A, 6059, 6060, 6060.1, 6060.2, 6060.3,
4 6060.3a, 6060.4, 6060.4a, 6060.4b, 6060.5, 6060.5a, 6060.6, 6060.7,
5 6060.8, 6060.8a, 6060.8b, 6060.9, 6060.9a, 6060.9b, 6060.9c, and
6 6060.9d of this title,

7 b. Section 6911 of this title, and

8 c. Section 6915 of this title;

9 2. The exemptions listed therein, will apply only to the
10 services provided to Medicaid recipients pursuant to Section 4002.2
11 of Title 56 of the Oklahoma Statutes.

12 SECTION 2. This act shall become effective November 1, 2025.
