17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:												
18	SECTION 1. NEW LAW A new section of law to be codified												
19	in the Oklahoma Statutes as Section 240.1 of Title 44 , unless there												
20	is created a duplication in numbering, reads as follows:												
21	As used in this act:												
22	1. "Clearinghouse" means the Military Aviation and Installation												
23	Assurance Siting Clearinghouse established by the United States												
24	Secretary of Defense under 10 U.S.C., Section 183(a);												

1 2. "Commencement of construction" means beginning excavation of 2 wind turbine foundations or other actions relating to the actual erection and installation of commercial wind energy equipment. 3 Commencement of construction does not include activities related to: 4 5 a. the erection of meteorological towers, environmental assessments, 6 b. 7 с. surveys, d. preliminary engineering, or 8 9 e. assessments of the development of the wind resources 10 on a given parcel of property; 11 3. "Department" means the Oklahoma Military Department; 12 "Determination of no hazard" means the formal response 4. 13 issued by the FAA upon completion of an aeronautical study regarding 14 a facility structure's impact to air navigation affirming that: 15 the facility structure does not exceed obstruction a. 16 standards, and 17 b. modifications to the facility structure are not 18 required; "FAA" means the United States Federal Aviation 19 5. 20 Administration; 21 6. "Facility structure" means a wind turbine or other structure 22 located on a wind energy facility, the construction or modification 23 of which would require the completion of Form 7460-1; 7. "Form 7460-1" means: 24

- a. FAA Form 7460-1 Notice of Proposed Construction or
 Alteration, which the FAA uses to conduct aeronautical
 studies to promote air safety and the efficient use of
 navigable airspace, as required under 14 C.F.R., Part
 77, or
- b. a form designated by the FAA to conduct aeronautical
 studies to promote air safety and the efficient use of
 navigable airspace;

9 8. "Mission compatibility certification letter" means the 10 formal response the Clearinghouse issues through the Clearinghouse's 11 review of proposed projects and facility structures through the 12 Clearinghouse's evaluation process;

9. "Owner" means a person having a majority equity interest ina commercial wind energy facility;

15 10. "Wind energy facility" means an electrical generation 16 consisting of one or more wind turbines under common ownership or 17 operating control. Wind energy facility includes the infrastructure 18 necessary to support the generation of electricity by one or more 19 wind turbines, including:

- 20 a. substations,
- 21 b. meteorological data towers,
- c. aboveground and underground electrical transmission
 lines,
- d. transformers,

- e. control systems, and

f. other structures used to support the operation of the facility with the primary purpose of supplying electricity to an off-site customer; and

5 11. "Wind turbine" means a wind energy conversion system that 6 converts wind energy into electricity through the use of a wind 7 turbine generator. Wind turbine includes the turbine, blade, tower, 8 base, and pad transformer.

9 SECTION 2. NEW LAW A new section of law to be codified 10 in the Oklahoma Statutes as Section 240.2 of Title 44, unless there 11 is created a duplication in numbering, reads as follows:

A. Construction or modification of a facility structure may not encroach upon or otherwise have an adverse impact on the mission, training, or operations of any military installation or branch of the military as determined by the Clearinghouse and the FAA.

B. An adverse impact to a military installation or branch of the military as described in subsection A of this section includes an adverse impact to:

19 1. A military training route;

20 2. A drop zone;

21 3. An approach to a runway;

22 4. A test or training range;

23 5. A military installation or facility;

6. United States Department of Defense special use air space;
 and

3 7. United States Department of Defense spectral requirements.
4 C. A facility structure may not be constructed or expanded
5 unless:

1. There is an active determination of no hazard; or
2. Any adverse impacts to the United States Department of
Defense, determined in accordance with 32 C.F.R., Section 211.6, or
the National Defense Authorization Act have been resolved as
evidenced by documentation from the Clearinghouse for the facility
structure and the Department.

D. For purposes of paragraph 2 of subsection C of this section, a mission compatibility certification letter may serve as evidence that the wind energy facility has resolved adverse impacts with the United States Department of Defense or successor agency.

E. Before expanding or constructing a facility structure, and within thirty (30) days of submitting an application to the FAA, an owner shall file a copy of the FAA application with the Department.

F. Within fifteen (15) days of receiving a copy of the FAA application to construct a wind energy site, the Oklahoma Military Department will provide a copy of the application to the affected military entities.

G. The Department may serve in a coordination role with the owner and the affected military entity.

1 H. Within thirty (30) days of receiving final notification from 2 the FAA or a Notice of Presumed Risk from the Department of Defense, the owner shall provide the Department a copy of the documentation. 3 The Department may make rules in accordance with the 4 I. Oklahoma Administrative Procedures Act to administer this section. 5 6 The documentation an owner submits in accordance with J. 7 subsections E and H of this section: 1. Shall only be used and disclosed by the Department in 8 9 accordance with this section; 2. Is confidential, not public, and not open to public 10 inspection; and 11 12 Is not subject to the Oklahoma Open Records Act. 3. 13 Κ. If an owner fails to submit the documentation described in 14 subsections E and H of this section for an individual facility 15 structure: 16 1. The Department may charge the owner an administrative 17 penalty not to exceed One Thousand Five Hundred Dollars (\$1,500.00) 18 per day, per violation; and 19 2. A stakeholder, including the Department, may bring an action 20 in court to: 21 enjoin any action on a facility structure in violation a. 22 of this section, and 23 enforce the requirements of this section. b. 24
