17	SECTION 1. AMENDATORY Section 1, Chapter 425, O.S.L.									
18	2024 (74 O.S. Supp. 2024, Section 2294.1), is amended to read as

20	Section 2294.1. There is hereby created in the State Treasury a									
21	revolving fund for the Oklahoma Historical Society, to be designated									
22	the "Oklahoma Museum of Popular Culture Supplemental Revolving									
23	Fund". The fund shall be a continuing fund, not subject to fiscal									
24	year limitations, and shall consist of all monies received by the
