| 14 | BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: |
| 15 | SECTION 1. NEW LAW A new section of law to be codified |
| 16 | in the Oklahoma Statutes as Section 5008.10 of Title 74, unless |
| 17 | there is created a duplication in numbering, reads as follows: |
| 18 | A. There is hereby created the Southeast Asia Trade Office. |
| 19 | B. The Office shall be an administrative component of the |
| 20 | Oklahoma Department of Commerce. |
| 21 | C. The Office shall: |
| 22 | 1. Facilitate economic relationships between Oklahoma-based |
| 23 | businesses and business entities with principal business activity |
| 2.4 | which is based or occurs in southeast Asia including but not |

1 limited to, Taiwan, Vietnam, Laos, Myanmar, Brunei, Cambodia,
2 Singapore, Thailand, and Malaysia;

- 2. Promote Oklahoma-based business and establish business-tobusiness trading activity within the southeast Asia region;
- 3. Provide information about business trading opportunities in southeast Asia to Oklahoma-based businesses;
- 4. Facilitate positive relationships between this state and its political subdivisions with the relevant governments in the southeast Asia trading region consistent with United States foreign policy and any applicable trade or travel restrictions;
- 5. Coordinate the activities of the Oklahoma Department of Commerce with respect to business outreach in southeast Asia;
- 6. Coordinate, organize, support, and fund travel from Oklahoma to southeast Asia and return as part of an ongoing mission to establish and maintain relationships between Oklahoma and countries in the region with the objective of creating trade opportunities for Oklahoma-based business enterprises;
- 7. Manage actions taking place at the federal level whose primary objective promotes business-to-business transactions between entities in southeast Asia and the United States with emphasis on promoting Oklahoma-based business activity;
- 8. Conduct training programs for Oklahoma-based business owners to inform them of potential trading opportunities with entities in southeast Asia;

9. Produce promotional and educational materials for distribution by business organizations, trade associations, or similar entities consistent with the mission of the Office; and

- 10. Take such other actions or develop such programs consistent with the mission of developing business-to-business opportunities between entities in southeast Asia and Oklahoma-based business enterprises.
- D. The Southeast Asia Trade Office shall maintain a physical office in Taipei, Taiwan.
- E. 1. No later than January 1, 2031, the Oklahoma Department of Commerce shall conduct a cost/benefit analysis to determine the estimated net direct state benefits applicable for a five-year period beginning with the first complete calendar quarter.
- 2. If the Oklahoma Department of Commerce determines that the Office failed to meet the estimated net direct state benefit for operations, the Department shall cease operation of the Office. As used in this section, "estimated net direct state benefits" means the estimated direct state benefits less the estimated direct state costs.
- F. The Oklahoma Department of Commerce shall promulgate any rules necessary to implement the provisions of this section.
- 22 | SECTION 2. This act shall become effective July 1, 2025.
- 23 SECTION 3. It being immediately necessary for the preservation 24 of the public peace, health or safety, an emergency is hereby
