8	An Act relating to state property; permitting residents to forage for nuts and edible plants or						
9	fungi on state-owned or state-managed property; providing exceptions; limiting times for foraging

14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:						
15	SECTION 1. NEW LAW A new section of law to be codified						
16	in the Oklahoma Statutes as Section 335 of Title 61, unless there is						
17	created a duplication in numbering, reads as follows:						
18	A. Any person may forage for nuts and edible plants or fungi on						
19	state-owned or state-managed property for personal use and not for						
20	resale except when such nuts and other edible plants or fungi are:						
21	1. From crops certified by the Oklahoma Agricultural Experiment						
22	Station system or the Oklahoma Cooperative Extension Service of the						
23	Oklahoma State University Division of Agricultural Sciences and						
24							

Natural Resources, as provided in Section 8-33 of Title 2 of the
 Oklahoma Statutes;

3 2. Located on state-owned or University-owned test or research
4 farms;

5 3. On property otherwise restricted for access by state or6 federal law; or

7 4. From plants that are threatened or endangered.

B. 1. Any person foraging pursuant to this section on a state
or federal wildlife refuge or a Wildlife Management Area shall limit
his or her foraging to between the hours of 9:00 a.m. and 3:00 p.m.
during those months coinciding with hunting seasons when the gun is
a legal means of take.

13 2. Any person foraging pursuant to this section is encouraged 14 to wear an outer garment of hunter orange that is clearly visible 15 while in the field.

16 C. As used in this section:

17 1. "State-owned or state-managed property" means property owned
 18 or managed by an agency, municipality, or political subdivision of
 19 this state, unless otherwise stated in subsection A of this section;

20 2. "Edible plant or fungus" means a plant or fungus commonly 21 found in the wild, which is edible to humans in part or in its 22 entirety and may require cooking to make safe for consumption; and 3. "Nut" means a dry fruit that has a single seed, a hard 24 shell, and a protective husk.
