18	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:						
19	SECTION 1. Pursuant to Section 3 of Article V of the Oklahoma						
20	Constitution, there is hereby ordered the following legislative						
21	referendum which shall be filed with the Secretary of State and						
22	addressed to the Governor of the state, who shall submit the same to						
23	the people for their approval or rejection at the next General						
24	Election. Provided, however, that this measure shall not be

referred to a vote of the people if the provisions of Enrolled House
 Bill No. 1047 of the 1st Session of the 60th Oklahoma Legislature
 become enacted as law.

4 SECTION 2. AMENDATORY 3A O.S. 2021, Section 262, is 5 amended to read as follows:

6 Section 262. A. If at least four Indian tribes enter into the model tribal-state compact set forth in Section 281 of this title, 7 and such compacts are approved by the Secretary of the Interior and 8 9 notice of such approval is published in the Federal Register, the 10 Oklahoma Horse Racing Commission ("Commission") shall license 11 organization licensees which are licensed pursuant to Section 205.2 12 of this title to conduct authorized gaming as that term is defined 13 by this act pursuant to this act utilizing gaming machines or 14 devices authorized by this act subject to the limitations of 15 subsection C of this section. No fair association or organization 16 licensed pursuant to Section 208.2 of this title or a city, town or 17 municipality incorporated or otherwise, or an instrumentality 18 thereof, may conduct authorized gaming as that term is defined by 19 this act.

Notwithstanding the provisions of Sections 941 through 988 of
Title 21 of the Oklahoma Statutes, the conducting of and
participation in gaming in accordance with the provisions of this
act or the model compact set forth in Section 281 of this title is
lawful and shall not be subject to any criminal penalties. Provided

1 further, a licensed manufacturer or distributor licensed pursuant to 2 this act may manufacture, exhibit or store as a lawful activity any 3 machines or devices which are capable of being used to conduct the 4 following types of gaming:

5 1. Gaming authorized by the State-Tribal Gaming Act; or
6 2. Other gaming which may be lawfully conducted by an Indian
7 tribe in this state.

B. Except for Christmas Day, authorized gaming may only be 8 9 conducted by an organization licensee on days when the licensee is 10 either conducting live racing or is accepting wagers on simulcast 11 races at the licensee's racing facilities. Authorized gaming may 12 only be conducted by organization licensees at enclosure locations 13 where live racing is conducted. Under no circumstances shall 14 authorized gaming be conducted by an organization licensee at any 15 facility outside the organization licensee's racing enclosure. No 16 person who would not be eligible to be a patron of a pari-mutuel 17 system of wagering pursuant to the provisions of subsection B of 18 Section 208.4 of this title shall be admitted into any area of a 19 facility when authorized games are played nor be permitted to 20 operate, or obtain a prize from, or in connection with, the 21 operation of any authorized game, directly or indirectly.

C. In order to encourage the growth, sustenance and development of live horse racing in this state and of the state's agriculture and horse industries, the Commission is hereby authorized to issue

1 licenses to conduct authorized gaming to no more than three 2 organization licensees operating racetrack locations at which horse 3 race meetings with pari-mutuel wagering, as authorized by the 4 Commission pursuant to the provisions of this title, occurred in 5 calendar year 2001, as follows:

6 1. An organization licensee operating a racetrack location at 7 which an organization licensee is licensed to conduct a race meeting pursuant to the provisions of Section 205.2 of this title located in 8 9 a county with a population exceeding six hundred thousand (600,000) persons, according to the most recent Federal Decennial Census, 10 11 shall be licensed to operate not more than six hundred fifty (650) player terminals in any year. Beginning with the third year after 12 13 an organization licensee is licensed pursuant to this paragraph to 14 operate such player terminals, such licensee may be licensed to 15 operate an additional fifty (50) player terminals. Beginning with 16 the fifth year after an organization licensee is licensed pursuant 17 to this paragraph to operate such player terminals, such licensee 18 may be licensed to operate a further additional fifty (50) player 19 terminals; and

20 2. Two organization licensees operating racetrack locations at 21 which the organization licensees are licensed to conduct race 22 meetings pursuant to the provisions of Section 205.2 of this title 23 located in counties with populations not exceeding four hundred 24 thousand (400,000) persons, according to the most recent Federal

Decennial Census, may each be licensed to operate not more than two
 hundred fifty (250) player terminals in any year.

Subject to the limitations on the number of player terminals 3 permitted to each organization licensee, an organization licensee 4 5 may utilize electronic amusement games as defined in this act, electronic bonanza-style bingo games as defined in this act and 6 7 electronic instant bingo games as defined in this act, and any type of gaming machine or device that is specifically allowed by law and 8 9 that an Indian tribe in this state is authorized to utilize pursuant 10 to a compact entered into between the state and the tribe in 11 accordance with the provisions of the Indian Gaming Regulatory Act 12 and any other machine or device that an Indian tribe in this state 13 is lawfully permitted to operate pursuant to the Indian Gaming 14 Regulatory Act, referred to collectively as "authorized games". An 15 organization licensee's utilization of such machines or devices 16 shall be subject to the regulatory control and supervision of the 17 Commission; provided, the Commission shall have no role in oversight 18 and regulation of gaming conducted by a tribe subject to a compact. 19 The Commission shall promulgate rules to regulate the operation and 20 use of authorized gaming by organization licensees. In promulgating 21 such rules, the Commission shall consider the provisions of any 22 compact which authorizes electronic gaming which is specifically 23 authorized by law by an Indian tribe. For the purpose of paragraphs 24 1 and 2 of this subsection, the number of player terminals in an

1 authorized game that permits multiple players shall be determined by the maximum number of players that can participate in that game at 2 any given time; provided, however, that nothing in this act 3 4 prohibits the linking of player terminals for progressive jackpots, 5 so long as the limitations on the number of permitted player terminals at each organization licensee are not exceeded. Each 6 7 organization licensee shall keep a record of, and shall report at least quarterly to the Oklahoma Horse Racing Commission, the number 8 9 of games authorized by this section utilized in the organization 10 licensee's facility, by the name or type of each and its identifying number. 11

D. No zoning or other local ordinance may be adopted or amended by a political subdivision where an organization licensee conducts live horse racing with the intent to restrict or prohibit an organization licensee's right to conduct authorized gaming at such location.

E. For purposes of this act, "adjusted gross revenues" means the total receipts received by an organization licensee from the play of all authorized gaming minus all monetary payouts.

F. The Oklahoma Horse Racing Commission shall promulgate rules to regulate, implement and enforce the provisions of this act with regard to the conduct of authorized gaming by organization licensees; provided, regulation and oversight of games covered by a

compact and operated by an Indian tribe shall be conducted solely
 pursuant to the requirements of the compact.

G. If an organization licensee operates or attempts to operate 3 4 more player terminals which offer authorized games than it is 5 authorized to offer to the public by this act or the terms of its license, upon written notice from the Commission, such activity 6 7 shall cease forthwith. Such activity shall constitute a basis upon which the Commission may suspend or revoke the licensee's license. 8 9 The Commission shall promulgate any rules and regulations necessary 10 to enforce the provisions of this subsection.

11 This act is game-specific and shall not be construed to Η. 12 allow the operation of any other form of gaming unless specifically 13 allowed by this act. This act shall not permit the operation of 14 slot machines, house-banked card games, house-banked table games 15 involving dice or roulette wheels, or games where winners are 16 determined by wagering on the outcome of a sports contest; provided, 17 however, that wagering on the outcome of sports contests may be 18 conducted in accordance with Section 4 of this act.

19SECTION 3.AMENDATORY3A O.S. 2021, Section 280, is20amended to read as follows:

Section 280. The State of Oklahoma through the concurrence of the Governor after considering the executive prerogatives of that office and the power to negotiate the terms of a compact between the state and a tribe, and by means of the execution of the State-Tribal

1 Gaming Act, and with the concurrence of the State Legislature 2 through the enactment of the State-Tribal Gaming Act, hereby makes the following offer of a model tribal gaming compact Model Tribal 3 4 Gaming Compact regarding gaming to all federally recognized Indian 5 tribes as identified in the Federal Register within this state that own or are the beneficial owners of Indian lands as defined by the 6 7 Indian Gaming Regulatory Act, 25 U.S.C., Section 2703(4), and over 8 which the tribe has jurisdiction as recognized by the Secretary of 9 the Interior and is a part of the tribe's "Indian reservation" as 10 defined in 25 C.F.R., Part 151.2 or has been acquired pursuant to 25 11 C.F.R., Part 151, which, if accepted, shall constitute a gaming 12 compact between this state and the accepting tribe for purposes of 13 the Indian Gaming Regulatory Act. Acceptance of the offer contained 14 in this section shall be through the signature of the chief 15 executive officer of the tribal government whose authority to enter 16 into the compact Compact shall be set forth in an accompanying law 17 or ordinance or resolution by the governing body of the tribe, a 18 copy of which shall be provided by the tribe to the Governor. No 19 further action by the Governor or the state is required before the 20 compact Compact can take effect. A tribe accepting this Model 21 Tribal Gaming Compact is responsible for submitting a copy of the 22 Compact executed by the tribe to the Secretary of the Interior for 23 approval and publication in the Federal Register. The tribe shall 24 provide a copy of the executed Compact to the Governor. No tribe

1 shall be required to agree to terms different than the terms set 2 forth in the Model Tribal Gaming Compact, which is set forth in Section 281 of this title. As a precondition to execution of the 3 4 Model Tribal Gaming Compact by any tribe, the tribe must have paid 5 or entered into a written agreement for payment of any fines assessed prior to the effective date of the State-Tribal Gaming Act 6 7 by the federal government with respect to the tribe's gaming 8 activities pursuant to the Indian Gaming Regulatory Act.

9 Notwithstanding the provisions of Sections 941 through 988 of 10 Title 21 of the Oklahoma Statutes, the conducting of and the 11 participation in any game authorized by the model compact Model 12 Tribal Gaming Compact set forth in Section 281 of this title are 13 lawful when played pursuant to a compact which has become effective. 14 Prior to July 1, 2008, of all fees received by the state 1. 15 pursuant to subsection A of Part 11 of the Model Tribal Gaming 16 Compact set forth in Section 281 of this title:

17 a. twelve percent (12%) shall be deposited in the 18 Oklahoma Higher Learning Access Trust Fund, and 19 eighty-eight percent (88%) of such fees shall be b. 20 deposited in the Education Reform Revolving Fund. 21 2. On or after July 1, 2008, of all fees received by the state 22 pursuant to subsection A of Part 11 of the Model Tribal Gaming 23 Compact set forth in Section 281 of this title and Gaming Compact 24

Supplements offered pursuant to Section 2 280.1 of this title and
 Section 4 of this act:

- a. twelve percent (12%) shall be deposited in the General Revenue Fund, and
- 5

b. eighty-eight percent (88%) of such fees shall be deposited in the Education Reform Revolving Fund.

7 Provided, the first Twenty Thousand Eight Hundred Thirty-three Dollars and thirty-three cents (\$20,833.33) of all fees received 8 9 each month by the state pursuant to subsection A of Part 11 of the 10 Model Tribal Gaming Compact set forth in Section 281 of this title 11 and Gaming Compact Supplements offered pursuant to Section 2 280.1 of this title and Section 4 of this act shall be transferred to the 12 13 Department of Mental Health and Substance Abuse Services for the 14 treatment of compulsive gambling disorder and educational programs 15 related to such disorder.

16 SECTION 4. NEW LAW A new section of law to be codified 17 in the Oklahoma Statutes as Section 280.2 of Title 3A, unless there 18 is created a duplication in numbering, reads as follows:

A. Provided that federal laws permit and pursuant to the offer of the Model Tribal Gaming Compact made in Section 280 of Title 3A of the Oklahoma Statutes and the definition of "covered games" in the Model Tribal Gaming Compact codified in Section 281 of Title 3A of the Oklahoma Statutes, which said codified compact offer provides the state may approve additional forms of covered games under said

1 compact by amendment of the State-Tribal Gaming Act and a compacting 2 tribe may operate such additional forms of covered games by written supplement to an existing compact, the state hereby approves, 3 subject to this section, an additional game offering as follows: 4 5 "Sports betting" means any wagering on the outcome of sporting events or other events, other than horse or other animal races. 6 7 Should a tribe that has compacted with the state in в. accordance with Sections 280 and 281 of Title 3A of the Oklahoma 8 9 Statutes elect to accept this offer of an additional covered game 10 and, accordingly, to operate sports betting under the terms of its 11 existing gaming compact with the state, said tribe shall execute a 12 supplement to said compact, to provide as follows: 13 MODEL TRIBAL GAMING COMPACT SUPPLEMENT 14 Between the [Name of Tribe] 15 and the STATE OF OKLAHOMA 16 To be governed in accord with the [Name of Tribe]'s State-Tribal 17 Gaming Compact ("Compact"), approved by the United States Department 18 of the Interior on [Date], the [Name of Tribe] ("Tribe") accepts the 19 state's offer of additional covered game codified in Section 280.2 20 of Title 3A of the Oklahoma Statutes, which offer and this 21 acceptance are subject to the following terms: 22 Part 1. TITLE 23 24

This document shall be referred to as the "[Name of Tribe] and
 State of Oklahoma Gaming Compact Sports Betting Supplement ("Gaming
 Compact Supplement").

Part 2. TERMS

A. The Tribe hereby memorializes its election to accept the state's offer of an additional covered game, which offer is codified in Section 280.2 of Title 3A of the Oklahoma Statutes. The Tribe further certifies and agrees it shall not offer such additional covered game unless and until doing so would be legal under federal law.

11 The Tribe agrees, subject to the enforcement and exclusivity Β. 12 provisions of its Compact, to pay to the state a fee derived from 13 sports betting revenues calculated as set forth in this subsection. 14 Such fee shall be paid no later than the twentieth day of the month 15 for revenues received by the Tribe in the preceding month. The fee 16 shall be ten percent (10%) of monthly adjusted gross revenue from 17 sports betting.

Payments of such fees shall be made to the Treasurer of the State of Oklahoma. Nothing herein shall require the allocation of such fees to particular state purposes, including, but not limited to, the actual costs of performing the State's regulatory responsibilities hereunder. "Net win" shall mean all money wagered less prizes paid out and less applicable federal taxes. For all purposes, such payment shall be deemed an exclusivity and fee payment under

paragraph 2 of subsection A of Part 11 of the State-Tribal Gaming
 Compact between the electing Tribe and the State.

C. The Tribe's operation of sports betting pursuant to this
Gaming Compact Supplement shall, for all purposes, including
enforcement and exclusivity, be treated as subject to and lawfully
conducted under the terms and provisions of the Compact.

7 Part 3. AUTHORITY TO EXECUTE

This Gaming Compact Supplement, to the extent it conforms with 8 9 Section 280.2 of Title 3A of the Oklahoma Statutes, is deemed approved by the State of Oklahoma. No further action of the State 10 11 or any state official is necessary for this Gaming Compact 12 Supplement to take effect upon approval by the Secretary of the 13 United States Department of the Interior and publication in the 14 Federal Register. The undersigned tribal official(s) represents 15 that he or she is duly authorized and has the authority to execute 16 this Gaming Compact Supplement on behalf of the Tribe for whom he or 17 she is signing.

C. A tribe electing to accept this additional game offering is responsible for submitting a copy of the executed supplement to the 24 Secretary of the United States Department of the Interior for
 approval and publication in the Federal Register.

D. Upon approval of a supplement by the Secretary of the United
States Department of the Interior, said supplement shall be
construed as an acceptance of this offer and a supplement to the
Tribe's existing State-Tribal Gaming Compact with the State.
Thereafter, sports betting shall be deemed a covered game pursuant
to said Compact.

9 E. The Tribe is entitled to keep an amount equal to state 10 payments from the operation of sports betting. For all purposes, 11 such payment shall be deemed an exclusivity and fee payment under 12 paragraph 2 of subsection A of Part 11 of the State-Tribal Gaming 13 Compact between the electing Tribe and the State.

F. The offer contained in this section shall not be construed to permit the operation of any additional form of gaming by organization licensees or permit any additional electronic or machine gaming within Oklahoma.

18 G. Notwithstanding the provisions of Sections 941 through 988 19 of Title 21 of the Oklahoma Statutes, the conducting of and 20 participation in any game authorized pursuant to this section are 21 lawful when played pursuant to a compact supplement which has become 22 effective in accordance with this section.

1 SECTION 5. The Ballot Title for the proposed amendments as set 2 forth in SECTIONS 2 through 4 of this act shall be in the following form: 3 4 BALLOT TITLE Legislative Referendum No. 5 State Question No. THE GIST OF THE PROPOSITION IS AS FOLLOWS: 6 7 The measure authorizes the wagering on sports contests. The measure raises certain fee to be received by the state for the 8 9 treatment of compulsive gambling disorder to Twenty-five Thousand Dollars (\$25,000.00). The measure authorizes a tribe 10 11 that has compacted with the state to accept the offer of the 12 gaming compact supplement. The measure provides a form that the 13 supplement shall be submitted on to the United States Department 14 of the Interior. The measure directs that the tribe pay a fee 15 to the state from certain revenues. The fee will be ten percent 16 (10%) of monthly adjusted gross revenue from sports betting. 17 The measure allows the tribe to keep an amount equal to state 18 payments from the operation of sports betting. 19 SHALL THE PROPOSAL BE APPROVED? 20 FOR THE PROPOSAL - YES 21 AGAINST THE PROPOSAL - NO 22 SECTION 6. The Chief Clerk of the House of Representatives, 23 immediately after the passage of this act, shall prepare and file 24 one copy thereof, including the Ballot Title set forth in SECTION 5
