| 15 | BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: |
| 16 | SECTION 1. AMENDATORY 26 O.S. 2021, Section 14-105, as |
| 17 | amended by Section 1, Chapter 292, O.S.L. 2022 (26 O.S. Supp. 2024, |
| 18 | Section 14-105), is amended to read as follows: |
| 19 | Section 14-105. A. Any registered voter may apply for an |
| 20 | absentee ballot in person at the county election board, by United |
| 21 | States mail, by facsimile device as defined in Section 1862 of Title |
| 22 | 21 of the Oklahoma Statutes or by a means of electronic |
| 23 | communication designated by the Secretary of the State Election |
| 24 | Board. The Secretary of the State Election Board shall prescribe a |

form to be used for the application, although any application
 setting forth substantially the same facts shall be valid.

1. A registered voter applying for an absentee ballot by 3 Β. 4 means of electronic communication shall provide his or her name, 5 birth date, an identification number, and other information as may be prescribed by the Secretary of the State Election Board. 6 The name, birth date, and identification number provided on the 7 application must match the name, birth date, and identification 8 9 number in the voter registration record in order to apply for an 10 absentee ballot pursuant to this subsection.

11 2. If the voter does not recall which identification number he 12 or she included in the voter registration record, the voter may 13 provide multiple identification numbers, at least one of which must 14 match the identification number in the voter registration record if such record included an identification number. If the name, birth 15 16 date, or any identification number provided does not match the voter 17 registration record, the voter shall be informed of the failure to 18 match the voter registration record and shall be provided 19 information and instruction to contact the county election board.

3. If the voter registration record on file with the county election board does not contain a birth date or identification number, the voter shall not be eligible to apply for an absentee ballot by means of electronic communication but may apply for an absentee ballot pursuant to subsection C of this section.

4. Identifying information such as birth date and
 identification number shall not be modified online in an existing
 voter registration except as provided in Section 4-109.4 of this
 title.

5 5. No later than January 1, 2023, a registered voter applying 6 for an absentee ballot pursuant to this subsection who meets the 7 criteria provided in Section 7-115.1 of this title shall be required 8 to confirm his or her address prior to submitting an application for 9 absentee ballot by means of electronic communication.

10 6. <u>Registered voters applying for an absentee ballot by any</u> 11 <u>means must also provide a statement declaring why they are unable to</u> 12 <u>vote either early in-person absentee or on election day due to one</u>

13 of the following reasons:

- 14 <u>a.</u> absent from the jurisdiction,
- 15 <u>b.</u> <u>illness or disability</u>,
- 16 c. employment-related,
- 17 <u>d.</u> education-related,
- 18 <u>e.</u> military service,
- 19 <u>f.</u> religion,
- 20 g. serving as an election official,
- 21 h. seventy-five (75) years of age or older, or
- 22 <u>i.</u> serving on jury duty.
- 23 7. The Secretary of the State Election Board shall prescribe a
- 24 form to be used for the statement required by paragraph 6 of this

1 <u>subsection.</u> Failure to submit this statement will result in the 2 denial of the application.

C. 1. A registered voter applying for an absentee ballot in person, by United States mail, or by facsimile device shall provide his or her name, birth date, an identification number, and other information as may be prescribed by the Secretary of the State Election Board. The name, birth date, and identification number provided on the application must match the name, birth date, and identification number in the voter registration record.

2. If the voter does not recall which identification number he 10 or she included in the voter registration record, the voter may 11 12 provide multiple identification numbers, at least one of which must 13 match the identification number in the voter registration record if 14 such record included an identification number. If the voter 15 registration record does not contain a birth date or an 16 identification number, the absentee ballot application shall be 17 accepted without a match of a birth date or an identification 18 number.

D. For purposes of this section, "identification number" means
a number submitted on the registration application pursuant to
paragraph 3 of subsection A of Section 4-112 of this title.

22 SECTION 2. NEW LAW A new section of law to be codified 23 in the Oklahoma Statutes as Section 14-103.1 of Title 26, unless 24 there is created a duplication in numbering, reads as follows:
