10	POLICY COMMITTEE RECOMMENDATION
11	An Act relating to alien ownership of land; amending
12	60 O.S. 2021, Section 121, as last amended by Section 1, Chapter 373, O.S.L. 2024 (60 O.S. Supp. 2024,
13	Section 121), which relates to prohibition of alien ownership of land; defining terms; providing nations
14	that are considered a foreign government adversary; prohibiting certain ownership by certain parties; and
15	providing an effective date.

18	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
19	SECTION 1. AMENDATORY 60 O.S. 2021, Section 121, as last
20	amended by Section 1, Chapter 373, O.S.L. 2024 (60 O.S. Supp. 2024,
21	Section 121), is amended to read as follows:

5	title, but shall not include oil, gas, other minerals, or any

7	9. "Military installation" means a base, camp, post, station,
8	yard, or center that is under the jurisdiction of the Department of
9	Defense or its affiliates including the Oklahoma National Guard,
10	encompassing at least ten (10) contiguous acres; and
11	10. "Real property" means any land, buildings, fixtures, and
12	all other improvements to land.
13	B. No alien or any person who is not a citizen of the United
14	States or foreign government adversary shall acquire title to or own
15	land in this state either directly or indirectly through a business
16	entity, trust, or foreign government enterprise, except as
17	hereinafter provided, but they shall have and enjoy in this state
18	such rights as to personal property as are, or shall be, accorded a
19	citizen of the United States under the laws of the nation to which
20	such alien belongs, or by the treaties of such nation with the
21	United States, except as the same may be affected by the provisions
22	of Section 121 et seq. of this title or the Constitution of this
23	state. Provided, however, the requirements of this subsection shall
24	not apply to a business entity that is engaged in regulated

interstate commerce or has a national security agreement with the
 Committee on Foreign Investment in the United States (CFIUS) in
 accordance with federal law.

4 C. On or after November 1, 2023, any deed recorded with a 5 county clerk shall include as an exhibit to the deed an affidavit executed by the person, the person's attorney-in-fact, a court-6 7 appointed guardian or personal representative, an authorized officer of the entity, or trustee of the trust coming into title attesting 8 9 that the person, business entity, or trust is obtaining the land in 10 compliance with the requirements of this section and that no funding 11 source is being used in the sale or transfer in violation of this 12 section or any other state or federal law. A county clerk shall not 13 accept and record any deed without an affidavit as required by this 14 section which is duly notarized pursuant to Title 49 of the Oklahoma 15 Statutes. The requirements of this subsection shall not apply to a: 16 1. Deed which, without additional consideration, confirms,

17 corrects, modifies, or supplements a deed previously recorded;

Deed made by a grantor to cure a defect in title or
 effectuate a disclaimer of interest in real property;

3. Transfer-on-death deed made by a grantor designating a grantee beneficiary pursuant to the Nontestamentary Transfer of Property Act, Section 1251 et seq. of Title 58 of the Oklahoma Statutes;

4. State or federal court order in an action to quiet title or
 to cure a defect in title;

3 5. State or federal court order or decree in probate,4 partition, quiet title, and divorce actions;

5 6. Deed which secures a debt or other obligation, or which6 releases such property as security for a debt or other obligation;

7. Deed of dedication to the public; or

8 8. Deed in favor of the United States or any of its political
9 subdivisions, a state or any of its political subdivisions, or a
10 tribe.

11 The applicable exemption shall be shown on the face of the deed 12 prior to the recording of the deed and no affidavit shall be 13 required.

14 The Attorney General shall promulgate a separate affidavit D. 15 form for individuals and for business entities or trusts to comply 16 with the requirements of this section. The Attorney General may 17 establish additional exemptions which the Attorney General deems 18 necessary to substantially comply with the requirements of this 19 section. The county clerk may accept an affidavit in substantial 20 compliance with the affidavit form promulgated by the Attorney 21 General.

E. Notwithstanding any other law, no foreign principal shall acquire title to, or acquire a controlling interest in, any of the following:

1	1. Agricultural and forest property; or
2	2. Real property on or within two hundred (200) miles of any
3	military installation or critical infrastructure facility.
4	SECTION 2. This act shall become effective November 1, 2025.
