16	SECTION 1. AMENDATORY Section 1, Chapter 425, O.S.L.								
17	2024 (74 O.S. Supp. 2024, Section 2294.1), is amended to read as								
18	follows:								
19	Section 2294.1. There is hereby created in the State Treasury a								
20	revolving fund for the Oklahoma Historical Society, to be designated								
21	the "Oklahoma Museum of Popular Culture Supplemental Revolving								
22	Fund". The fund shall be a continuing fund, not subject to fiscal								
23	year limitations, and shall consist of all monies received by the								
24	Oklahoma Historical Society from appropriations of the Legislature

    credit of the fund are hereby appropriated and shall be budgeted and
    expended to provide funding for repairs, planning, staging,

    No expenditures shall be made from the fund until the State

    Treasurer determines that funds provided by local and county

    Expenditures from the fund shall be made upon warrants issued by the

    made by the State Treasurer pursuant to the provisions of this

    section authorizing expenditures from this fund, all unencumbered
