6 An Act relating to alcoholic beverages; amending 37A  
7 O.S. 2021, Section 2-121, as amended by Section 1,  
8 Chapter 81, O.S.L. 2022 (37A O.S. Supp. 2024, Section  
9 2-121), which relates to employee licenses; providing  
10 that holders of a license may serve certain beverages  
11 if they are eighteen years of age and older;  
12 providing restrictions; and providing an effective  
13 date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 37A O.S. 2021, Section 2-121, as  
16 amended by Section 1, Chapter 81, O.S.L. 2022 (37A O.S. Supp. 2024,  
17 Section 2-121), is amended to read as follows:

18 Section 2-121. A. An employee license shall authorize the  
19 holder thereof to work in a licensed package store, retail spirits,  
20 retail wine or retail beer establishment, brewpub, mixed beverage  
21 establishment, beer and wine establishment, bottle club, public  
22 event or any establishment where alcohol or alcoholic beverages are  
23 sold, mixed or served. Persons employed by a mixed beverage, on-  
24 premises beer and wine, retail wine, retail beer, public event or a  
bottle club licensee who do not participate in the service, mixing  
or sale of mixed beverages shall not be required to have an employee

1 license. Provided, however, that a manager employed by a mixed  
2 beverage licensee, public event licensee or a bottle club shall be  
3 required to have an employee license whether or not the manager  
4 participates in the service, mixing or sale of mixed beverages.  
5 Applicants for an employee license shall be at least eighteen (18)  
6 years of age, except for applicants employed by a grocery store or  
7 convenience store who shall be at least sixteen (16) years of age,  
8 and have a health card issued by the county in which they are  
9 employed, if the county issues such a card; ~~provided.~~ Provided, the  
10 provisions of this section shall not be construed to permit any  
11 person under twenty-one (21) years of age to be employed to sell  
12 spirits; however, individuals eighteen (18) years of age and older  
13 may open and serve beer and wine from their original containers or  
14 serve beer, wine, and spirits from a shaker tin that has been  
15 premade and mixed by an employee who is at least twenty-one (21)  
16 years of age. Employees of a special event, caterer, unless  
17 catering a mixed beverage-licensed premises, or airline/railroad  
18 beverage licensees shall not be required to obtain an employee  
19 license; further, employees of beer distributors and other licensees  
20 holding licenses issued by the ABLE Commission shall not be required  
21 to obtain an employee license if such employee only sells alcohol or  
22 alcoholic beverages to establishments holding licenses issued by the  
23 ABLE Commission and not to the public. Persons employed by a hotel  
24 licensee who participate in the stocking of hotel room mini-bars or

1 in the handling of alcoholic beverages to be placed in such devices  
2 shall be required to have an employee license. As a prerequisite to  
3 the issuance of an employee license, not later than fourteen (14)  
4 days after initial licensure, the first-time applicant shall be  
5 required to have successfully completed a training program conducted  
6 by the ABLE Commission, or by another entity approved by the ABLE  
7 Commission including an in-house training program conducted by the  
8 employer. Proof of training completion shall be made available for  
9 inspection by the ABLE Commission at the business location employing  
10 the licensee. The failure of an employee licensee to comply with  
11 this section may constitute a revocable offense.

12 B. In the event the ABLE Commission denies an application for  
13 an employee license, the Commission shall provide written notice to  
14 the applicant's employer, if any. The notice shall be given at the  
15 time notice is provided to the applicant.

16 SECTION 2. This act shall become effective November 1, 2025.
