6 An Act relating to education; amending 70 O.S. 2021,  
7 Section 6-127A, which relates to public school  
8 paraprofessionals; exempting certain  
9 paraprofessionals from certain educational  
10 requirements; exempting certain teachers from certain  
11 additional educational requirements; providing for  
12 codification; providing an effective date; and  
13 declaring an emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 70 O.S. 2021, Section 6-127A, is  
16 amended to read as follows:

17 Section 6-127A. A. The Oklahoma Legislature recognizes that  
18 public school paraprofessionals play an important role in educating  
19 school children and in assisting teachers. The Legislature further  
20 recognizes the increasing role of public school paraprofessionals in  
21 the school system in light of teacher shortages. To achieve the  
22 goal of excellence for all persons who have an impact on student  
23 learning, it is the intent of the Oklahoma Legislature that public  
24 school paraprofessionals be afforded career opportunities and  
economic incentives through a career development program.

1 B. The State Board of Education shall adopt a program for the  
2 career development of public school paraprofessionals. The purpose  
3 of the program is to provide to public school paraprofessionals a  
4 system of career development which is based upon education and  
5 training advancement to encourage excellence among public school  
6 paraprofessionals. Public school paraprofessionals who hold a  
7 bachelor's degree in education or education studies and who have not  
8 been out of the classroom for more than ten (10) years shall be  
9 deemed to have satisfied any rule that requires additional  
10 professional education coursework from an institution of higher  
11 education under the adopted program. Nothing in this section shall  
12 be construed to require public school paraprofessionals to  
13 participate in the career development program.

14 C. The board of education of a school district shall have  
15 authority to extend an existing contract with a public school  
16 paraprofessional that provides for the payment of compensation for  
17 paraprofessional services rendered for the same time period during  
18 which the paraprofessional is also assigned to the school district  
19 for practice teaching as a student teacher.

20 D. For the purposes of this section, a public school  
21 paraprofessional is an employee of a school district whose position  
22 is either instructional in nature, or who delivers other direct  
23 services to students and/or their parents. A public school  
24 paraprofessional serves in a position for which a teacher or another

1 professional has the ultimate responsibility for the design,  
2 implementation, and evaluation of the individual educational  
3 programs or related services and student performance.

4 SECTION 2. NEW LAW A new section of law to be codified  
5 in the Oklahoma Statutes as Section 6-213 of Title 70, unless there  
6 is created a duplication in numbering, reads as follows:

7 Teachers who hold a bachelor's degree in education or education  
8 studies shall be deemed to have satisfied any State Board of  
9 Education rule that requires teachers to complete additional  
10 professional education coursework from an institution of higher  
11 education as a condition to obtain, renew, or satisfy any other  
12 professional development requirement for an emergency certificate,  
13 alternate placement teaching certificate, or standard certificate if  
14 the teacher has not been out of the classroom for more than ten (10)  
15 years.

16 SECTION 3. This act shall become effective July 1, 2025.

17 SECTION 4. It being immediately necessary for the preservation  
18 of the public peace, health or safety, an emergency is hereby  
19 declared to exist, by reason whereof this act shall take effect and  
20 be in full force from and after its passage and approval.
