20	Section 547.1. A. Any Oklahoma sheriff, deputy sheriff, or a

22	with the National Sheriffs' Association annual conference within				
23	Oklahoma County during the month of June 2024, outside of his or her				
24	county of employment shall have the same powers and duties as though
