10 COMMITTEE SUBSTITUTE

11 An Act relating to sunset; amending 59 O.S. 2021,
12 Section 396, as amended by Section 1, Chapter 32,
13 O.S.L. 2023 (59 O.S. Supp. 2024, Section 396), which
14 relates to the Oklahoma Funeral Board; re-creating
15 the Board; and modifying the termination date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 59 O.S. 2021, Section 396, as
18 amended by Section 1, Chapter 32, O.S.L. 2023 (59 O.S. Supp. 2024,
19 Section 396), is amended to read as follows:

20 Section 396. There is hereby re-created, to continue until July
21 1, ~~2024~~ 2026, in accordance with the provisions of the Oklahoma
22 Sunset Law, the Oklahoma Funeral Board. Any reference in the
23 statutes to the Oklahoma State Board of Embalmers and Funeral
24 Directors shall be a reference to the Oklahoma Funeral Board. The

1 Board shall consist of seven (7) persons, who shall be appointed by
2 the Governor. The term of membership of each member of the Board
3 shall be five (5) years from the expiration of the term of the
4 member succeeded. Any member having served as a member of the Board
5 shall be eligible for reappointment. Provided that, a member of the
6 Board shall serve no more than two consecutive terms and any
7 unexpired term that a member is appointed to shall not apply to this
8 limit. The Governor shall appoint the necessary members to the
9 Board upon vacancies and immediately prior to the expiration of the
10 various terms. Upon request of the Governor, appointments of a
11 licensed embalmer and funeral director member of the Board shall be
12 made from a list of five qualified persons submitted by the Oklahoma
13 Funeral Directors Association. An appointment to fill a vacancy
14 shall be for the unexpired term. A member of the Board shall serve
15 until a successor is appointed and qualified. No person shall be a
16 member of the Board, unless, at the time of appointment, the person
17 is of good moral character and a resident of this state. Five of
18 the members shall have been actively engaged in the practice of
19 embalming and funeral directing in this state for not less than
20 seven (7) consecutive years immediately prior to the appointment of
21 the person, shall have an active license as provided by the Funeral
22 Services Licensing Act, shall keep the license effective, and remain
23 a resident of this state during the entire time the person serves on
24 the Board. Two of the members of the Board shall be chosen from the

1 general public, one of whom shall, if possible, be a person licensed
2 and actively engaged in the health care field, and shall not be
3 licensed funeral directors or embalmers or have any interest,
4 directly or indirectly, in any funeral establishment or any business
5 dealing in funeral services, supplies or equipment. These two
6 members shall be appointed to serve for five-year terms.
