

1 1. "Airbag" means an inflatable restraint device for vehicle
2 occupants that is part of a supplemental restraint system in a motor
3 vehicle;

4 2. "Counterfeit supplemental restraint system component" means
5 a replacement supplemental restraint system component that displays
6 a mark identical or substantially similar to the genuine mark of a
7 motor vehicle manufacturer or supplier of parts to a motor vehicle
8 manufacturer without authorization from that manufacturer or
9 supplier;

10 3. "Nonfunctional airbag" means a replacement airbag that:

- 11 a. was previously deployed or damaged,
- 12 b. has an electric fault that is detected by the motor
13 vehicles' diagnostic systems when the installation
14 procedure is completed and the motor vehicle is
15 returned to the customer who requested the work to be
16 performed or when ownership is intended to be
17 transferred,
- 18 c. includes a part or object, including a supplemental
19 restraint system component, installed in a motor
20 vehicle to mislead the owner or operator of the motor
21 vehicle into believing that a functional airbag has
22 been installed, or
- 23 d. is prohibited in accordance with 49 U.S.C. Section
24 301209(j) from being sold or leased;

1 4. "Supplemental restraint system" means a passive motor
2 vehicle occupant crash protection system designed for use in
3 conjunction with active restraint systems, including, but not
4 limited to, seat belt assemblies, as described in 49 CFR 571.208.

5 Such term shall include:

6 a. each airbag installed in accordance with the motor
7 vehicle manufacturer's design, and

8 b. all components required to ensure that an airbag
9 operates as designed by the manufacturer in the event
10 of a crash and in accordance with the federal motor
11 vehicle safety standards for the specific make, model
12 and year of the motor vehicle.

13 B. No person shall knowingly or intentionally manufacture,
14 import, distribute, sell, offer for sale, install, or reinstall a
15 device intended to replace a component of a supplemental restraint
16 system if the device is:

17 1. A counterfeit supplemental restraint system component;

18 2. A nonfunctional airbag; or

19 3. Any object in lieu of a supplemental restraint system
20 component if the object was not designed in accordance with federal
21 safety regulations for the make, model, and year of the motor
22 vehicle in which such device is or will be installed.

1 C. Any person violating any of the provisions of this section,
2 shall, upon conviction thereof, be punished as provided in Section
3 17-101 of Title 47 of the Oklahoma Statutes.

4 SECTION 2. This act shall become effective November 1, 2025.
