6	An Act relating to county election boards; amending 26 O.S. 2021, Section 2-117, which relates to
7	secretary's duties and assistant secretary; requiring certain notice from county election board to
8	Secretary of the State Election Board; providing for execution of duties under certain circumstances;
9	authorizing certain actions by assistant secretary under specified circumstances; and providing an
10	effective date.

13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. AMENDATORY 26 O.S. 2021, Section 2-117, is
15	amended to read as follows:
16	Section 2-117. A. The secretary of the county election board
17	shall be the administrative officer of the county election board and
18	shall have general supervisory authority over all precinct officials
19	and absentee voting board members within the county.
20	B. The secretary shall employ an assistant secretary and such
21	other employees as are necessary to perform the duties of the county
22	election board. In the event a vacancy exists in the office of the
23	secretary of the county election board, the Secretary of the State
24	Election Board shall have the authority to stand in the place of the

 necessary county election board personnel.

C. The secretary of the county election board shall be charged with the operational responsibilities of the board, including, but not limited to:

6 1. The supervision, defining job positions and
7 responsibilities, and discharge of the employees of the county
8 election board;

9 2. The preparation of the annual budget;

10 3. The preparation and filing of all reports; and

The implementation of policy, findings, and actions required
 by law or lawfully prescribed or determined by the county election
 board.

The minimum salary of the assistant secretary shall be equal D. 14 to ninety percent (90%) of the scheduled salary of the secretary in 15 the same county, but shall not exceed the salary of the highest 16 salaried first or chief deputy or assistant to any county officer, 17 excluding the under sheriff, in the same county. Provided, the 18 minimum salary may be prorated if a county election board office is 19 open to the public for fewer hours per day than the average of the 20 regular public office hours of other county offices. The salary 21 limitation contained in this section shall not operate to reduce the 22 salary of any person employed as an assistant secretary or chief 23 clerk on October 31, 2019. 24

E. Salaries of additional personnel, including personnel
 employed temporarily, shall not exceed the salary of the assistant
 secretary and shall be comparable to salaries paid for the same
 positions in other offices within the county.

5 F. The salaries of the assistant secretary and other personnel 6 shall be paid from county funds on a monthly basis. In the event 7 that the secretary, assistant secretary or any other essential 8 county election board employee must be away from work for a period 9 of time due to personal illness, family illness, or family 10 emergency, the county shall be required to fund compensation of 11 appropriate temporary personnel during the employee's absence.

12 <u>G. 1. The secretary of the county election board shall notify</u> 13 <u>the Secretary of the State Election Board of the person employed</u> 14 <u>pursuant to subsection B of this section as the assistant secretary</u> 15 <u>of the county election board. The assistant secretary shall be</u> 16 <u>subject to the direction of the secretary of the county election</u> 17 <u>board.</u>

2. The assistant secretary shall execute the duties of the
secretary during the absence of the secretary due to illness,
disqualification, recusal, or any other reason approved in writing
by the Secretary of the State Election Board.
3. In the event of a vacancy in the office of the secretary of
the county election board due to the death, removal, or resignation

24 of the secretary, the assistant secretary shall execute the duties

1	of the secretary until a successor is appointed as prescribed by
2	law.
3	4. In the event of an absence or vacancy described in this
4	subsection, the assistant secretary may stand in the place of the
5	secretary of the county election board as a voting member of the
6	county election board at public meetings of the board with the
7	written authority of the Secretary of the State Election Board.
8	SECTION 2. This act shall become effective November 1, 2025.
