16 Prevention Council; repealing 62 O.S. 2021, Section  
17 34.30, which relates to the Electronic and  
18 Information Technology Accessibility Advisory  
19 Council; repealing 70 O.S. 2021, Sections 1210.451,  
20 1210.452, and 1210.453, which relate to the Oklahoma  
21 School for the Visual and Performing Arts; repealing  
22 73 O.S. 2021, Section 176, which relates to the  
23 permanent legislative liaison committee; repealing 74  
24 O.S. 2021, Sections 291.10, 291.11, and 291.19, which  
relate to the Staff Review Committee of the Senate;  
repealing 74 O.S. 2021, Section 840-1.7, as amended  
by Section 5, Chapter 243, O.S.L. 2022 (74 O.S. Supp.  
2024, Section 840-1.7), which relates to the Oklahoma  
Merit Protection Commission; and providing an  
effective date.

21 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

22 SECTION 1. AMENDATORY 43A O.S. 2021, Section 12-105, is  
23 amended to read as follows:

1 Section 12-105. A. The Department of Mental Health and  
2 Substance Abuse Services shall act as the lead agency in  
3 implementing the provisions of the Suicide Prevention Act ~~in~~  
4 ~~cooperation with the Oklahoma Suicide Prevention Council.~~

5 B. The Department shall have primary responsibility for  
6 evaluating the effectiveness of efforts designed to reduce the  
7 number of attempted suicides and suicides, and shall electronically  
8 submit an evaluation report to the ~~Chair of the Oklahoma Suicide~~  
9 ~~Prevention Council,~~ the Speaker of the House of Representatives, the  
10 President Pro Tempore of the Senate, and the Governor no later than  
11 July 1 of each year.

12 SECTION 2. REPEALER 2 O.S. 2021, Sections 16-35, 16-36,  
13 16-37, and 16-38, are hereby repealed.

14 SECTION 3. REPEALER 43A O.S. 2021, Section 12-104, is  
15 hereby repealed.

16 SECTION 4. REPEALER 62 O.S. 2021, Section 34.30, is  
17 hereby repealed.

18 SECTION 5. REPEALER 70 O.S. 2021, Sections 1210.451,  
19 1210.452, and 1210.453, are hereby repealed.

20 SECTION 6. REPEALER 73 O.S. 2021, Section 176, is hereby  
21 repealed.

22 SECTION 7. REPEALER 74 O.S. 2021, Sections 291.10,  
23 291.11, and 291.19, are hereby repealed.

1 SECTION 8. REPEALER 74 O.S. 2021, Section 840-1.7, as  
2 amended by Section 5, Chapter 243, O.S.L. 2022 (74 O.S. Supp. 2024,  
3 Section 840-1.7), is hereby repealed.

4 SECTION 9. This act shall become effective November 1, 2025.
