12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 62 O.S. 2021, Section 35.3, is
14 amended to read as follows:

15 Section 35.3. As used in the Information Technology
16 Consolidation and Coordination Act:

17 1. "Appropriated state agency" means any state agency that
18 receives funding through the annual legislative appropriations
19 process;

20 2. "Information technology assets" means any equipment or
21 interconnected system or subsystem of equipment that is used in the
22 acquisition, storage, manipulation, management, movement, control,
23 display, switching, interchange, transmission, or reception of data
24 or information. The term shall include computers, ancillary

1 equipment, software, firmware and similar procedures, services,
2 including support services and consulting services, software
3 development, and related resources, and shall further include
4 telecommunications fiber networks used for conveying electronic
5 communication or information systems to multiple physical locations;

6 3. "Information technology position" means a classified or
7 unclassified position in the following functional areas:

- 8 a. applications programming,
- 9 b. EDP audit,
- 10 c. data examination,
- 11 d. computer applications,
- 12 e. computer data entry,
- 13 f. computer networking,
- 14 g. computer operations,
- 15 h. computer programming,
- 16 i. computer security,
- 17 j. computer software design,
- 18 k. web applications,
- 19 l. database analysis,
- 20 m. data management analysis,
- 21 n. database development,
- 22 o. database programming,
- 23 p. software design/development,
- 24 q. help desk,

- 1 r. imaging,
- 2 s. systems analysis,
- 3 t. systems application planning,
- 4 u. systems application,
- 5 v. systems administration,
- 6 w. systems coordination,
- 7 x. systems integration,
- 8 y. systems operation,
- 9 z. systems planning/development,
- 10 aa. systems programming,
- 11 bb. systems engineering,
- 12 cc. systems service specialist,
- 13 dd. systems support,
- 14 ee. network administration,
- 15 ff. network management,
- 16 gg. network technical,
- 17 hh. operating systems specialist,
- 18 ii. systems program manager,
- 19 jj. telecommunications, whether data or voice,
- 20 kk. software training, and
- 21 ll. technology development or support;

22 4. "Nonappropriated state agency" means any state agency that
23 does not receive funding through the annual legislative
24 appropriations process;

1 5. "Shared services" means those state agency functions which
2 are or could be provided through:

- 3 a. the services and systems specified in subsection A of
4 Section 35.6 of this title, and
5 b. the programs, services, software, or processes
6 specified in subsection B of Section 35.6 of this
7 title; and

8 6. "State agency" means any office, elected or appointed
9 officer, bureau, board, commission, counsel, unit, division, body,
10 authority, or institution of the executive branch of state
11 government excluding institutions within The Oklahoma State System
12 of Higher Education, the Oklahoma Municipal Power Authority, the
13 Oklahoma State Regents for Higher Education, the Oklahoma State
14 Bureau of Investigation, the District Attorneys Council, the Office
15 of the Attorney General, the Office of the State Auditor and
16 Inspector, and the telecommunications network known as OneNet.

17 SECTION 2. **It being immediately necessary for the preservation**
18 **of the public peace, health or safety, an emergency is hereby**
19 **declared to exist, by reason whereof this act shall take effect and**
20 **be in full force from and after its passage and approval.**
