5 An Act relating to special license plates; amending
6 47 O.S. 2021, Section 1135.5, as last amended by
7 Section 1, Chapter 88, O.S.L. 2024 (47 O.S. Supp.
8 2024, Section 1135.5), which relates to the issuance
9 of special license plates; updating statutory
10 language; modifying certain special license plate;
11 repealing 47 O.S. 2021, Section 1104.13, which
12 relates to the Oklahoma Zoological Society Revolving
13 Fund; and providing an effective date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 47 O.S. 2021, Section 1135.5, as
16 last amended by Section 1, Chapter 88, O.S.L. 2024 (47 O.S. Supp.
17 2024, Section 1135.5), is amended to read as follows:

18 Section 1135.5. A. Service Oklahoma is hereby authorized to
19 design and issue appropriate official special license plates to
20 persons wishing to demonstrate support and provide financial
21 assistance as provided by this section.

22 Special license plates shall not be transferred to any other
23 person but shall be removed from the vehicle upon transfer of
24 ownership and retained. The special license plate may then be used
on another vehicle but only after such other vehicle has been
registered for the current year with a licensed operator.

1 Special license plates shall be renewed each year by Service
2 Oklahoma or a licensed operator, unless authorized by Service
3 Oklahoma to be renewed for a period greater than one (1) year.
4 Service Oklahoma shall notify by mail all persons issued special
5 license plates. The notice shall contain all necessary information
6 and shall contain instructions for the renewal procedure upon
7 presentation to a licensed operator or Service Oklahoma. The
8 license plates shall be issued on a staggered system.

9 Service Oklahoma is hereby directed to develop and implement a
10 system whereby licensed operators are permitted to accept
11 applications for special license plates authorized under this
12 section. The licensed operator shall confirm the applicant's
13 eligibility, if applicable, collect and deposit any amount
14 specifically authorized by law, accept and process the necessary
15 information directly into such system and generate a receipt
16 accordingly. For performance of these duties, licensed operators
17 shall retain the fee provided in Section 1141.1 of this title for
18 registration of a motor vehicle through June 30, 2025. Through June
19 30, 2025, the licensed operator fees for acceptance of applications
20 and renewals shall be paid out of the Service Oklahoma Reimbursement
21 Fund. Beginning July 1, 2023, fees shall be retained by the
22 licensed operator pursuant to subsection E of Section 1141.1 of this
23 title.

1 If fewer than one hundred of any type of special license plates
2 authorized prior to January 1, 2004, are issued prior to January 1,
3 2006, Service Oklahoma shall discontinue issuance and renewal of
4 that type of special license plate. Any such authorized special
5 license plate registrant shall be allowed to display the license
6 plate upon the designated vehicle until the registration expiration
7 date. After such time the expired special license plate shall be
8 removed from the vehicle.

9 For special license plates authorized on or after July 1, 2004,
10 no special license plates shall be developed or issued by Service
11 Oklahoma until Service Oklahoma receives one hundred prepaid
12 applications therefor. The prepaid applications must be received by
13 Service Oklahoma within one hundred eighty (180) days of the
14 effective date of the authorization or the authority to issue shall
15 be null and void. In the event one hundred prepaid applications are
16 not received by Service Oklahoma within such prescribed time period
17 any payment so received shall be refunded accordingly.

18 B. The special license plates provided by this section are as
19 follows:

20 1. University or College Supporter License Plate - such plates
21 shall be designed and issued to any person wishing to demonstrate
22 support to any state-supported or private university or college. As
23 provided in this section, an amount of the fee collected shall be
24 apportioned as provided in Section 1104.1 of this title;

1 2. Environmental Awareness License Plate - such plates shall be
2 designed, subject to the criteria to be presented to Service
3 Oklahoma by the Department of Environmental Quality in consultation
4 with the Oklahoma Arts Council, and issued to any person wishing to
5 demonstrate support to implement the statewide general public
6 Environmental Education Program created pursuant to the provisions
7 of the Oklahoma Environmental Quality Code. Such plates shall be
8 designed and issued to any person in any combination of numbers and
9 letters from one to a maximum of seven, as for personalized license
10 plates. A dealer's license plate issued pursuant to Section 1116.1
11 or 1128 of this title may be designated an Environmental Awareness
12 License Plate upon payment of the fee imposed by this section and
13 any other registration fees required by the Oklahoma Vehicle License
14 and Registration Act. As provided in this section, an amount of the
15 fee collected shall be apportioned pursuant to Section 1104.2 of
16 this title;

17 3. Firefighter License Plate - such plates shall be designed
18 for any career or retired firefighter, volunteer or paid.
19 Firefighters may apply for firefighter plates for up to four
20 vehicles with a rated capacity of one (1) ton or less or for a
21 motorcycle upon proof of a fire department membership by either an
22 identification card or letter from the chief of the fire department.
23 Retirees who are eligible for such plates shall provide proof of
24 eligibility upon initial application, but shall not be required to

1 provide proof of eligibility annually. The surviving spouse of any
2 deceased firefighter, if the spouse has not since remarried, may
3 apply for a firefighter license plate for one vehicle with a rated
4 carrying capacity of one (1) ton or less or for a motorcycle upon
5 proof that the deceased firefighter was a member of a fire
6 department by either an identification card or letter from the chief
7 of the fire department. The license plate shall be designed in
8 consultation with the Oklahoma State Firefighters Association.

9 As provided in this section, an amount of the fee collected
10 shall be deposited to the Oklahoma State Firemen's Museum Building &
11 Memorial Fund for support of the Oklahoma State Firefighters Museum
12 and the Oklahoma Fallen and Living Firefighters Memorial;

13 4. Wildlife Conservation License Plate - such plates shall be
14 designed, subject to the criteria to be presented to Service
15 Oklahoma by the Department of Wildlife Conservation in consultation
16 with the Oklahoma Arts Council, and issued to any person wishing to
17 demonstrate support for wildlife conservation in this state through
18 the Wildlife Diversity Fund, provided for in Section 3-310 of Title
19 29 of the Oklahoma Statutes. Such plates may be designed and issued
20 to any person as for personalized license plates.

21 As provided in this section, an amount of the fee collected
22 shall be apportioned pursuant to subsection D of Section 3-310 of
23 Title 29 of the Oklahoma Statutes;

1 5. Child Abuse Prevention License Plate - such plates shall be
2 designed, subject to the criteria to be presented to Service
3 Oklahoma by the Office of Child Abuse Prevention in the State
4 Department of Health and the Child Abuse Prevention Action
5 Committee, and issued to any person wishing to demonstrate support
6 for the prevention of child abuse.

7 As provided in this section, an amount of the fee collected
8 shall be deposited in the Child Abuse Prevention Fund;

9 6. United States Olympic and Paralympic Committee Supporter
10 License Plate - such plates shall be designed and issued to any
11 person wishing to demonstrate support for the United States Olympic
12 and Paralympic Committee. The plates shall be issued to any person
13 in any combination of numbers and letters from one to a maximum of
14 seven, as for personalized license plates. The plate shall contain
15 the official United States Olympic and Paralympic Committee logo.
16 Service Oklahoma shall be authorized, if necessary, to enter into a
17 licensing agreement with the United States Olympic and Paralympic
18 Committee for any licensing fees which may be required in order to
19 use the United States Olympic and Paralympic Committee logo or
20 design. The licensing agreement shall provide for a payment of not
21 more than Twenty-five Dollars (\$25.00) for each license plate
22 issued;

23 7. Oklahoma History License Plate - such plates shall be
24 designed and issued to any person wishing to demonstrate interest in

1 Oklahoma history. As provided in this section, an amount of the fee
2 collected shall be deposited to the Oklahoma Historical Society
3 Revolving Fund to be used for educational purposes;

4 8. Historic Route 66 License Plate - such:

- 5 a. vehicle plates shall be designed to honor historic
6 Route 66, also known as the "Mother Road". As
7 provided in this section, an amount of the fee
8 collected for each vehicle license plate shall be
9 apportioned to the Oklahoma Historical Society
10 Revolving Fund to be distributed to the Oklahoma Route
11 66 Museum located in Clinton, Oklahoma, and
- 12 b. motorcycle plates shall be designed in consultation
13 with the Oklahoma Route 66 Association, Inc. Service
14 Oklahoma shall be authorized to enter into a licensing
15 agreement with the Oklahoma Route 66 Association,
16 Inc., for any licensing fees which may be required in
17 order to use the Oklahoma Route 66 Association, Inc.,
18 logo or design. The licensing agreement shall provide
19 for a payment to the Oklahoma Route 66 Association,
20 Inc., of not more than Twenty Dollars (\$20.00) for
21 each motorcycle license plate issued;

22 9. Heart of the Heartland License Plate - such plates shall be
23 designed and issued to any person wishing to honor the victims of
24 the terrorist bombing attack on the Alfred P. Murrah Federal

1 Building in downtown Oklahoma City on April 19, 1995. As provided
2 in this section, an amount of the fee collected shall be deposited
3 in the Heart of the Heartland Scholarship Fund, as established in
4 Section 2282 of Title 70 of the Oklahoma Statutes;

5 10. Emergency Medical Technician License Plate - such plates
6 shall be designed and issued to any person who is an emergency
7 medical technician. Such persons may apply for an emergency medical
8 technician license plate for each vehicle with a rated carrying
9 capacity of one (1) ton or less upon proof of an emergency medical
10 technician's license. The license plate shall be designed in
11 consultation with the Oklahoma Emergency Medical Technicians
12 Association. As provided in this section, an amount of the fee
13 collected shall be apportioned to the Emergency Medical Personnel
14 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63
15 of the Oklahoma Statutes;

16 11. Fight Breast Cancer License Plate - such plates shall be
17 designed to demonstrate support for the prevention and treatment of
18 breast cancer in this state;

19 12. Crime Victims Awareness License Plate - such plates shall
20 be designed and issued to any person wishing to demonstrate
21 awareness of and support for victims of crimes. The license plates
22 shall be designed in consultation with the Crime Victims
23 Compensation Program. As provided in this section, an amount of the
24 fee collected shall be apportioned to the Attorney General's

1 Revolving Fund for the Office of the Attorney General, which is
2 hereby directed to use such funds to contract with a statewide
3 nonprofit organization to provide services to crime victims;

4 13. Safe Kids Oklahoma License Plate - such plates shall be
5 designed and issued to any person wishing to demonstrate support and
6 awareness of the Safe Kids Oklahoma. The license plate shall be
7 designed in consultation with the Oklahoma Safe Kids Association.
8 As provided in this section, an amount of the fee collected shall be
9 deposited in the Children's Hospital - Oklahoma Safe Kids
10 Association Revolving Fund to be distributed to the Safe Kids
11 Oklahoma program;

12 14. Oklahoma Four-H Club License Plate - such plates shall be
13 designed, subject to criteria to be presented to Service Oklahoma by
14 the Four-H Foundation, and issued to any person wishing to
15 demonstrate support of the Oklahoma Four-H Club. Such plates may be
16 designed and issued to any person as for personalized license
17 plates. As provided in this section, an amount of the fee collected
18 shall be apportioned to the OSU Extension Service License Plate
19 Revolving Fund created in Section 1104.4 of this title;

20 15. Agricultural Awareness License Plate - such plates shall be
21 designed, subject to criteria to be presented to Service Oklahoma,
22 by the Oklahoma Department of Agriculture, Food, and Forestry in
23 consultation with the Oklahoma Arts Council, and issued to any
24 person wishing to demonstrate support of the Department's Ag in the

1 Classroom Education Program. As provided in this section, an amount
2 of the fee collected shall be apportioned as provided in Section
3 1104.3 of this title;

4 16. Oklahoma Statehood Centennial License Plate - such plates
5 shall be designed and issued to any person wishing to commemorate
6 the centennial of Oklahoma's admission to statehood in 1907. The
7 license plates shall be designed in consultation with the Oklahoma
8 Capitol Complex and Centennial Commemoration Commission. As
9 provided in this section, an amount of the fee collected shall be
10 deposited in the Oklahoma Department of Commerce Revolving Fund
11 created in Section 5012 of Title 74 of the Oklahoma Statutes;

12 17. Support Education License Plate - such plates shall be
13 designed, subject to criteria to be presented to Service Oklahoma by
14 the State Department of Education in consultation with the Oklahoma
15 Arts Council, and issued to any person wishing to demonstrate
16 support for education in this state. All licensed operators shall
17 display a sample of the Support Education License plate in the area
18 of the business accessed by the public. Twenty-three Dollars
19 (\$23.00) of the fee collected shall be apportioned as follows:

- 20 a. five percent (5%) shall be deposited to the Education
21 Reform Revolving Fund,
- 22 b. five percent (5%) shall be deposited to the Oklahoma
23 State Regents for Higher Education Revolving Fund,

24

1 c. five percent (5%) shall be deposited to the State
2 Career-Technology Fund, and

3 d. eighty-five percent (85%) shall be deposited to the
4 Retirement Benefit Fund as set forth in Section 17-108
5 of Title 70 of the Oklahoma Statutes.

6 However, when the Retirement Benefit Fund attains a seventy
7 percent (70%) funded ratio based on an annual actuarial valuation as
8 required by law, the amount of the fee shall be apportioned equally
9 pursuant to subparagraphs a, b and c of this paragraph;

10 18. Retired Oklahoma Highway Patrol Officers License Plate -
11 such plates shall be designed and issued to any retired officer of
12 the Oklahoma Highway Patrol. The license plate shall have the
13 legend "Oklahoma" and shall contain, in the center of the plate, the
14 Highway Patrol Officers patch using the same colors and pattern as
15 used in the patch. Centered on the bottom of the license plate
16 shall be the word "Retired". The letters "TRP" shall be used in
17 combination with three numbers on either side of the insignia or
18 emblem. The color of the letters and numbers shall be brown.
19 Retirees who are eligible for such plates shall provide proof of
20 eligibility upon initial application, but shall not be required to
21 provide proof of eligibility annually. The surviving spouse of any
22 deceased retired officer of the Oklahoma Highway Patrol, if the
23 spouse has not since remarried, or if remarried, the remarriage is
24 terminated by death, divorce, or annulment, may apply for a Retired

1 Oklahoma Highway Patrol Officers license plate. As provided in this
2 section, an amount of the fee collected shall be deposited into the
3 Oklahoma Law Enforcement Retirement Fund;

4 19. Boy Scouts of America Supporter License Plate - such plates
5 shall be designed and issued to any person wishing to demonstrate
6 support for the Boy Scouts of America. The plates shall be issued
7 to any person in any combination of numbers and letters from one to
8 a maximum of seven, as for personalized license plates. The plate
9 shall contain the official Boy Scouts of America logo. Service
10 Oklahoma shall be authorized, if necessary, to enter into a
11 licensing agreement with the Boy Scouts of America for any licensing
12 fees which may be required in order to use the Boy Scouts of America
13 logo or design. The licensing agreement shall provide for a payment
14 to the Boy Scouts of America of not more than Twenty Dollars
15 (\$20.00) for each license plate issued;

16 20. Urban Forestry and Beautification License Plate - such
17 plates shall be designed, subject to criteria to be presented to
18 Service Oklahoma, by the Oklahoma Department of Agriculture, Food,
19 and Forestry in consultation with nonprofit organizations in this
20 state that develop and operate programs to encourage urban forestry
21 and beautification, and issued to any person wishing to demonstrate
22 support of such programs. As provided in this section, an amount of
23 the fee collected shall be apportioned as provided in Section 1104.5
24 of this title;

1 21. Oklahoma State Parks Supporter License Plate - such plates
2 shall be designed, subject to criteria to be presented to ~~Serve~~
3 Service Oklahoma by the Oklahoma Tourism and Recreation Department,
4 and issued to any person wishing to demonstrate support for the
5 Oklahoma state parks system. Twenty-three Dollars (\$23.00) of the
6 fee collected shall be deposited in the Oklahoma Tourism and
7 Recreation Department Revolving Fund. Such money shall be
8 designated for and may only be expended for the support of Oklahoma
9 state parks;

10 22. Adoption Creates Families License Plate - such plates shall
11 be issued to any person wishing to demonstrate support of pregnant
12 women who are committed to placing their children for adoption and
13 wishing to provide assistance to guardians, adoptive parents and
14 other created families to assist in the adoption and placement of
15 children in permanent, safe homes. The license plates shall be
16 designed and final terminology delivered in consultation with the
17 Oklahoma Adoption Coalition and the Department of Human Services.
18 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited
19 in a revolving fund established in the State Treasury for and to be
20 used by the Department of Human Services for the implementation of
21 the Investing in Stronger Oklahoma Families Act specifically for
22 created families;

23 23. Choose Life License Plate - such plates shall be designed,
24 subject to criteria presented to Service Oklahoma, by Choose Life

1 America, Inc., and issued to any person who wishes to demonstrate
2 support of organizations that encourage adoption as a positive
3 choice for women with unplanned pregnancies. As provided in this
4 section, an amount of the fee collected shall be deposited in the
5 Choose Life Assistance Program Revolving Fund established in Section
6 1104.6 of this title;

7 24. Future Farmers of America License Plate - such plates shall
8 be designed and issued to persons wishing to demonstrate support for
9 the Oklahoma FFA Association (formerly known as Future Farmers of
10 America). The license plates shall be designed in consultation with
11 the Oklahoma FFA Association Board of Directors. As provided in
12 this section, an amount of the fee collected shall be apportioned as
13 provided in Section 1104.7 of this title;

14 25. Lions Club License Plate - such plates shall be designed
15 and issued to persons wishing to demonstrate support for the Lions
16 Clubs of Oklahoma. The plates shall be issued to any person in any
17 combination of numbers and letters from one to a maximum of seven,
18 as for personalized license plates. The license plates shall be
19 designed in consultation with the Oklahoma Lions Service Foundation
20 and shall contain the official logo of the International Association
21 of Lions Clubs. Service Oklahoma shall be authorized to enter into
22 a licensing agreement with the Oklahoma Lions Service Foundation.
23 The licensing agreement shall provide for a payment to the Oklahoma
24

1 Lions Service Foundation of not more than Ten Dollars (\$10.00) for
2 each license plate issued;

3 26. Color Oklahoma License Plate - such plates shall be
4 designed, subject to criteria to be presented to Service Oklahoma by
5 the Oklahoma Native Plant Society, and issued to any person wishing
6 to demonstrate support for preserving and planting wildflowers and
7 native plants in this state and to promote Oklahoma's wildflower
8 heritage through education. As provided in this section, an amount
9 of the fee collected shall be apportioned as provided in Section
10 1104.8 of this title;

11 27. Girl Scouts of the United States of America Supporter
12 License Plate - such plates shall be designed and issued to any
13 person wishing to demonstrate support for the Girl Scouts of the
14 United States of America. The plates shall be issued to any person
15 in any combination of numbers and letters from one to a maximum of
16 seven, as for personalized license plates. The plate shall contain
17 the official Girl Scouts of the United States of America logo.
18 Service Oklahoma shall be authorized, if necessary, to enter into a
19 licensing agreement with the Girl Scouts of the United States of
20 America for any licensing fees which may be required in order to use
21 the Girl Scouts of the United States of America logo or design. The
22 licensing agreement shall provide for a payment to the Magic Empire
23 Council of Girl Scouts, acting on behalf of all Oklahoma Girl Scout

24

1 councils, of not more than Twenty Dollars (\$20.00) for each license
2 plate issued;

3 28. Oklahoma City Memorial Marathon License Plate - such plates
4 shall be designed and issued to any person wishing to demonstrate
5 support for the Oklahoma City Memorial Marathon. The plate shall be
6 designed in consultation with the Oklahoma City Memorial Marathon.
7 Service Oklahoma shall be authorized to enter into a licensing
8 agreement with the Oklahoma City Memorial Marathon for any licensing
9 fees which may be required in order to use the Oklahoma City
10 Memorial Marathon logo or design. The licensing agreement shall
11 provide for a payment to the Oklahoma City Memorial Marathon of not
12 more than Twenty Dollars (\$20.00) for each license plate issued;

13 29. Oklahoma Scenic Rivers License Plate - such plates shall be
14 designed to demonstrate support for the Grand River Dam Authority.
15 The plates shall be designed in consultation with the Grand River
16 Dam Authority. Twenty-five Dollars (\$25.00) of the fee shall be
17 apportioned to the Grand River Dam Authority;

18 30. Fight Cancer License Plate - such plates shall be designed
19 to demonstrate support for the Oklahoma Central Cancer Registry.
20 The plate shall contain the American Cancer Society logo. The
21 American Cancer Society logo shall be used in accordance with the
22 American Cancer Society's branding guidelines and shall only be
23 utilized to support the Oklahoma Central Cancer Registry. Twenty
24

1 Dollars (\$20.00) of the fee shall be apportioned to the Oklahoma
2 Central Cancer Registry Revolving Fund;

3 31. Animal Friendly License Plate - such plates shall be
4 designed and issued to any person wishing to demonstrate support for
5 controlling the overpopulation of dogs and cats through educational
6 and sterilization efforts. The plates shall be designed in
7 consultation with the Veterinary Medical Association. Twenty
8 Dollars (\$20.00) of the fee collected shall be designated by the
9 purchaser of the plate to be deposited in the Oklahoma Pet
10 Overpopulation Fund created in Section 2368.13 of Title 68 of the
11 Oklahoma Statutes or the Animal Friendly Revolving Fund created in
12 Section 1104.10 of this title;

13 32. Patriot License Plate - such plates shall be designed in
14 consultation with the Military Department of the State of Oklahoma
15 and issued to any person wishing to demonstrate support for Oklahoma
16 residents who are members of the Oklahoma National Guard and
17 deployed on active duty. The plates shall be issued to any person
18 in any combination of numbers and letters from one to a maximum of
19 seven, as for personalized license plates. As provided in this
20 section, a portion of the fee collected shall be deposited in the
21 Patriot License Plate Revolving Fund created in Section 1104.11 of
22 this title;

23 33. Global War on Terrorism License Plate - such plate shall be
24 designed in consultation with the Military Department of the State

1 of Oklahoma and issued to any person wishing to demonstrate support
2 for Oklahoma residents who are members of the Armed Forces of the
3 United States or Oklahoma National Guard that have served in the
4 Global War on Terrorism. The plate shall be issued to any person in
5 any combination of numbers and letters from one to a maximum of six.
6 As provided in this section, a portion of the fee collected shall be
7 deposited in the Oklahoma National Guard Museum Fund created in
8 Section 235.1 of Title 44 of the Oklahoma Statutes;

9 34. Boys and Girls Clubs of America Supporter License Plate -
10 such plates shall be designed and issued to any person wishing to
11 demonstrate support for the Boys and Girls Clubs of America. The
12 plates shall be issued to any person in any combination of numbers
13 and letters from one to a maximum of seven, as for personalized
14 license plates. The plate shall contain the official Boys and Girls
15 Clubs of America logo. Service Oklahoma, if necessary, may enter
16 into a licensing agreement with the Boys and Girls Clubs of America
17 for any licensing fees which may be required in order to use the
18 Boys and Girls Clubs of America logo or design. The licensing
19 agreement shall provide for a payment to the Boys and Girls Clubs of
20 America of not more than Twenty Dollars (\$20.00) for each license
21 plate issued;

22 35. Oklahoma Quarter Horse License Plate - such plates shall be
23 designed and issued to any person wishing to demonstrate support for
24 the American Quarter Horse in this state. The plate shall be

1 designed in consultation with the Oklahoma Quarter Horse
2 Association. As provided in this section, a portion of the fee
3 collected shall be deposited in the Oklahoma Quarter Horse Revolving
4 Fund created in Section 1104.12 of this title;

5 36. Oklahoma Association for the Deaf License Plate - such
6 plates shall be designed in consultation with the Oklahoma
7 Association for the Deaf and issued to any person wishing to
8 demonstrate support for Oklahoma residents who are deaf. The plates
9 shall be issued to any person in any combination of numbers and
10 letters from one to a maximum of seven, as for personalized license
11 plates. As provided in this section, a portion of the fee collected
12 shall be deposited in the Oklahoma Association for the Deaf License
13 Plate Revolving Fund created in Section 1104.15 of this title;

14 37. Oklahoma City Zoo License Plate - such plates shall be
15 issued to any person wishing to demonstrate support for the Oklahoma
16 City Zoo. The license plates shall be designed in consultation with
17 the Oklahoma Zoological Society, Inc. ~~As provided in this section,~~
18 ~~an amount of the fee collected~~ Service Oklahoma shall be deposited

7 plates shall be designed in consultation with the Oklahoma Music
8 Hall of Fame Inc. and issued to any member of the organization
9 wishing to demonstrate support. Service Oklahoma shall be
10 authorized to enter into a licensing agreement with the Oklahoma
11 Music Hall of Fame Inc. for any licensing fees which may be required
12 in order to use the organization's logo or design. The licensing
13 agreement shall provide for a payment to the Oklahoma Music Hall of
14 Fame Inc. of not more than Twenty Dollars (\$20.00) for each license
15 plate issued. The plates shall incorporate a numbering system
16 agreed upon by the Oklahoma Music Hall of Fame Inc. and Service
17 Oklahoma. Subject to the provisions of subsection A of this
18 section, the Oklahoma Music Hall of Fame Inc. License Plate is
19 hereby reauthorized effective November 1, 2019;

20 81. Techlahoma Foundation License Plate - such plates shall be
21 issued to any person wishing to provide financial support for the
22 Techlahoma Foundation. The license plate shall be designed in
23 consultation with the Techlahoma Foundation. The plate shall be
24 issued to any person in any combination of numbers and letters from

1 one to a maximum of seven, as for personalized license plates.
2 Service Oklahoma shall be authorized to enter into a licensing
3 agreement with the Techlahoma Foundation for any licensing fees,
4 which may be required in order to use the association's logo or
5 design. The licensing agreement shall provide for a payment to the
6 Techlahoma Foundation of not more than Twenty Dollars (\$20.00) for
7 each license plate issued;

8 82. Bethany Public Schools Foundation License Plate - such
9 plates shall be issued to any person wishing to demonstrate support
10 for the Bethany Public Schools Foundation. The license plates shall
11 be designed in consultation with the administration of the Bethany
12 Public Schools Foundation. Service Oklahoma shall be authorized to
13 enter into a licensing agreement with the Bethany Public Schools
14 Foundation for any licensing fees which may be required in order to
15 use the Foundation's logo or design. The licensing agreement shall
16 provide for a payment to the Bethany Public Schools Foundation of
17 not more than Twenty Dollars (\$20.00) for each license plate issued;

18 83. Cystic Fibrosis Foundation License Plate - such plates
19 shall be issued to any person wishing to demonstrate support for the
20 Cystic Fibrosis Foundation. The license plates shall be designed in
21 consultation with the administration of the Cystic Fibrosis
22 Foundation. Service Oklahoma shall be authorized to enter into a
23 licensing agreement with the Cystic Fibrosis Foundation for any
24 licensing fees which may be required in order to use the

1 Foundation's logo or design. The licensing agreement shall provide
2 for a payment to the Cystic Fibrosis Foundation of not more than
3 Twenty Dollars (\$20.00) for each license plate issued;

4 84. Down Syndrome Association of Central Oklahoma License Plate
5 - such plates shall be designed and issued to any person wishing to
6 demonstrate support for the Down Syndrome Association of Central
7 Oklahoma. Such plates shall be designed in consultation with the
8 Association. As provided in this section, an amount of the fee
9 collected shall be deposited in the Down Syndrome Association of
10 Central Oklahoma License Plate Revolving Fund created in Section
11 1104.30 of this title;

12 85. Elk City Education Foundation License Plate - such plates
13 shall be designed and issued to any person wishing to demonstrate
14 support for the Elk City Education Foundation. Such plates shall be
15 designed in consultation with the Foundation. As provided in this
16 section, an amount of the fee collected shall be deposited in the
17 Elk City Education Foundation License Plate Revolving Fund created
18 in Section 1104.31 of this title;

19 86. A Brotherhood Aiming Toward Education of Oklahoma (ABATE)
20 License Plate - such plates shall be designed and issued to any
21 person wishing to provide financial support for ABATE of Oklahoma.
22 Such plates shall be designed in consultation with ABATE of
23 Oklahoma. The plates shall be issued to any person in any
24 combination of numbers and letters from one to a maximum of seven,

1 as for personalized plates. The license plate for a motorcycle may
2 be of similar design as space permits or a new design in order to
3 meet the space requirements of a motorcycle license plate. Service
4 Oklahoma shall be authorized to enter into a licensing agreement
5 with ABATE of Oklahoma for any licensing fees which may be required
6 in order to use the ABATE of Oklahoma logo or design. The licensing
7 agreement shall provide for a payment to ABATE of Oklahoma of not
8 more than Twenty Dollars (\$20.00) for each license plate issued;

9 87. Downed Bikers Association License Plate - such plates shall
10 be designed for a vehicle or motorcycle in any combination of
11 numbers and letters from one to a maximum of seven, as for
12 personalized license plates, and issued to any person wishing to
13 demonstrate support for the Downed Bikers Association, a nonprofit
14 charitable organization exempt from taxation pursuant to the
15 provisions of the Internal Revenue Code, 26 U.S.C., Section
16 501(c)(3), which provides emotional and financial support for downed
17 bikers. The license plate shall be designed in consultation with
18 the Central Oklahoma Chapter of the Downed Bikers Association and
19 shall contain any official logo or design of the organization. The
20 license plate for a motorcycle may be of similar design as space
21 permits or a new design in order to meet the space requirements of a
22 motorcycle license plate. Service Oklahoma, if necessary, may enter
23 into a licensing agreement with the Downed Bikers Association for
24 any licensing fees which may be required in order to use the

1 organization's logo or design. The licensing agreement shall
2 provide for a payment to the Downed Bikers Association of not more
3 than Twenty Dollars (\$20.00) for each license plate;

4 88. Eagle Scout License Plate - such plates shall be designed
5 to demonstrate support for Eagle Scouts of the Boy Scouts of America
6 and shall include the Eagle Scout logo. Plates may be issued to any
7 person who can show proof of having obtained the rank of Eagle
8 Scout. Service Oklahoma shall be authorized to enter into a
9 licensing agreement with the various Oklahoma local councils for any
10 licensing fees which may be required in order to use the applicable
11 logo or design. The licensing agreement shall provide for a payment
12 of not more than Twenty Dollars (\$20.00) for each license plate
13 issued to the specific Oklahoma local area council designated by the
14 applicant;

15 89. Extraordinary Educators License Plate - such plates shall
16 be designed and issued to any person wishing to provide financial
17 support for common education in this state. Such plates shall be
18 designed in consultation with the State Department of Education.
19 The plates shall be issued to any person in any combination of
20 numbers and letters from one to a maximum of seven, as for
21 personalized license plates. As provided in this section, an amount
22 of the fee collected shall be deposited in the Extraordinary
23 Educators License Plate Revolving Fund created in Section 1104.32 of
24 this title;

1 90. Former Oklahoma Legislator License Plate - such plates
2 shall be designed and issued to any person who previously served as
3 a member of the House of Representatives or Senate. The license
4 plates shall be designed in consultation with the Oklahoma
5 Historical Society. As provided in this section, an amount of the
6 fee collected shall be deposited in the Oklahoma Historical Society
7 Capital Improvement and Operations Revolving Fund created in Section
8 1.10a of Title 53 of the Oklahoma Statutes. Service Oklahoma shall
9 create and maintain a list of former members of the House of
10 Representatives and Senate eligible to be issued such plates;
11 provided, that no former member of the House of Representatives and
12 Senate shall be eligible to possess more than two of such plates at
13 any one time. Service Oklahoma shall confer as needed with the
14 Chief Clerk of the House of Representatives and the Secretary of the
15 Senate to confirm that such list is complete and accurate;

16 91. Monarch Butterfly License Plate - such plates shall be
17 designed and issued to any person wishing to demonstrate support for
18 the operations of the Oklahoma Monarch Society. Such plates shall
19 be designed in consultation with the Oklahoma Monarch Society.
20 Service Oklahoma shall be authorized to enter into a licensing
21 agreement with the Oklahoma Monarch Society for any licensing fees
22 which may be required in order to use the foundation's logo or
23 design. The plates shall be issued to any person in any combination
24 of numbers and letters from one to a maximum of seven, as for

1 personalized license plates. The licensing agreement shall provide
2 for a payment to the Oklahoma Monarch Society of not more than
3 Twenty Dollars (\$20.00) for each license plate issued;

4 92. Oklahoma Tennis Foundation License Plate - such plates
5 shall be designed and issued to any person wishing to demonstrate
6 support for the Oklahoma Tennis Foundation. The license plates
7 shall be designed in consultation with the Oklahoma Tennis
8 Foundation. Service Oklahoma shall be authorized to enter into a
9 licensing agreement with the Oklahoma Tennis Foundation for any
10 licensing fees which may be required in order to use the
11 foundation's logo or design. The licensing agreement shall provide
12 for a payment to the Oklahoma Tennis Foundation of not more than
13 Twenty Dollars (\$20.00) for each license plate issued;

14 93. Oklahoma Veterans of Foreign Wars License Plate - such
15 plates shall be designed to honor the Oklahoma Veterans of Foreign
16 Wars Chapters and shall be issued to any resident of this state upon
17 proof of membership in the Oklahoma Veterans of Foreign Wars
18 organization. The license plates shall be designed in consultation
19 with the Oklahoma Veterans of Foreign Wars organization. Service
20 Oklahoma shall be authorized to enter into a licensing agreement
21 with the Oklahoma Veterans of Foreign Wars organization for any
22 licensing fees which may be required in order to use the
23 organization's logo or design. The licensing agreement shall
24 provide for a payment to the Oklahoma Veterans of Foreign Wars

1 organization of not more than Twenty Dollars (\$20.00) for each
2 license plate issued. Service Oklahoma shall reinstate any Veterans
3 of Foreign Wars license plates issued prior to November 1, 2021, and
4 shall reimburse any individual who held a Veterans of Foreign Wars
5 License Plate on October 31, 2021, for fees incurred for the
6 replacement of such plate;

7 94. Oklahoma Women Veterans Organization License Plate - such
8 plates shall be designed and issued to any female veteran of any
9 branch of the United States Armed Forces wishing to demonstrate
10 support for the Oklahoma Women Veterans Organization. The license
11 plates shall be designed in consultation with the Oklahoma Women
12 Veterans Organization. Service Oklahoma shall be authorized to
13 enter into a licensing agreement with the Oklahoma Women Veterans
14 Organization for any licensing fees which may be required in order
15 to use the organization's logo or design. The licensing agreement
16 shall provide for a payment to the Oklahoma Women Veterans
17 Organization of not more than Twenty Dollars (\$20.00) for each
18 license plate issued;

19 95. FIRST (For Inspiration and Recognition of Science and
20 Technology) in Oklahoma License Plate - such plates shall be issued
21 to any person wishing to demonstrate support for FIRST in Oklahoma
22 Robotics programs. The license plates shall be designed in
23 consultation with the administration of FIRST in Oklahoma. Service
24 Oklahoma shall be authorized to enter into a licensing agreement

1 with FIRST in Oklahoma for any licensing fees which may be required
2 in order to use the FIRST in Oklahoma logo or design. The licensing
3 agreement shall provide for a payment to FIRST in Oklahoma of not
4 more than Twenty Dollars (\$20.00) for each license plate issued;

5 96. Pittsburg State University License Plate - such plates
6 shall be designed and issued to any person wishing to demonstrate
7 support for the Pittsburg State University. The license plates
8 shall be designed in consultation with Pittsburg State University.
9 Service Oklahoma shall be authorized to enter into a licensing
10 agreement with Pittsburg State University for any licensing fees
11 which may be required in order to use the school foundation's logo
12 or design. The licensing agreement shall provide for a payment to
13 the Pittsburg State University of not more than Twenty Dollars
14 (\$20.00) for each license plate issued;

15 97. Greenwood Historical District License Plate - such plates
16 shall be issued to persons wishing to demonstrate support for the
17 Tulsa Juneteenth Festival held in the Greenwood Historical District
18 in Tulsa, Oklahoma. The plates shall be issued to any person in any
19 combination of numbers and letters from one to a maximum of seven,
20 as for personalized license plates. The license plates shall be
21 designed in consultation with the Black Wall Street Chamber of
22 Commerce. Service Oklahoma shall be authorized to enter into a
23 licensing agreement with the Tulsa Juneteenth Festival for any
24 licensing fees which may be required in order to use the Festival's

1 logo or design. For each license plate issued, the licensing
2 agreement shall provide for a payment of Twenty-five Dollars
3 (\$25.00) of the fee collected to the Tulsa Juneteenth Festival and
4 an additional Two Dollars (\$2.00) of the fee collected shall be
5 deposited in the Public School Classroom Support Revolving Fund, for
6 expenditure as provided in Section 1-123 of Title 70 of the Oklahoma
7 Statutes;

8 98. Oklahoma Veterans of Foreign Wars Auxiliary Chapters
9 License Plate - such plates shall be designed to honor the Oklahoma
10 Veterans of Foreign Wars Auxiliary Chapters and issued to any
11 resident of this state upon proof of membership in the Oklahoma
12 Veterans of Foreign Wars Auxiliary organization in this state. The
13 license plates shall be designed in consultation with the Oklahoma
14 Veterans of Foreign Wars Auxiliary organization. Service Oklahoma
15 shall be authorized to enter into a licensing agreement with the
16 Oklahoma Veterans of Foreign Wars Auxiliary organization for any
17 licensing fees which may be required in order to use the
18 organization's logo or design. The licensing agreement shall
19 provide for a payment to the Oklahoma Veterans of Foreign Wars
20 Auxiliary organization of not more than Twenty Dollars (\$20.00) for
21 each license plate issued;

22 99. Transportation to Transportation License Plate - such
23 plates shall be designed and issued to persons wishing to support
24 county roads and bridges. The license plates shall be designed in

1 consultation with the Association of County Commissioners of
2 Oklahoma. Twenty Dollars (\$20.00) of the fee collected shall be
3 paid to the county treasurer for the county in which the license
4 plate was purchased to be credited to the county highway fund
5 created pursuant to Section 1503 of Title 69 of the Oklahoma
6 Statutes;

7 100. Blue Star Mothers License Plate - such plates shall be
8 designed and issued to any person showing proof of membership in an
9 Oklahoma Chapter of Blue Star Mothers of America, Inc. The license
10 plates shall be designed in consultation with Blue Star Mothers of
11 America, Inc., Oklahoma Chapter One. Service Oklahoma shall be
12 authorized to enter into a licensing agreement with Blue Star
13 Mothers of America, Inc., Oklahoma Chapter One for any licensing
14 fees which may be required in order to use the Blue Star Mothers of
15 America logo or design. The licensing agreement shall provide for a
16 payment to Blue Star Mothers of America, Inc., Oklahoma Chapter One
17 of not more than Twenty Dollars (\$20.00) for each license plate
18 issued;

19 101. Oklahoma Golf License Plate - such plates shall be
20 designed and issued to any person wishing to demonstrate support for
21 the sport of golf in this state. The license plates shall be
22 designed in consultation with the South Central Section of the
23 Professional Golfers' Association of America and issued to any
24 person wishing to demonstrate support for the sport of golf in this

1 state. Service Oklahoma shall be authorized to enter into a
2 licensing agreement with the South Central Section of the
3 Professional Golfers' Association of America for any licensing fees
4 which may be required in order to use the organization's logo or
5 design. The licensing agreement shall provide for a payment to the
6 South Central Section of the Professional Golfers' Association of
7 America of not more than Twenty Dollars (\$20.00) for each license
8 plate issued;

9 102. Paramedic License Plate - such plates shall be designed
10 and issued to any person who is a paramedic. Such persons may apply
11 for a paramedic license plate for each vehicle with a rated carrying
12 capacity of one (1) ton or less or a motorcycle upon proof of a
13 paramedic license. The license plates shall be designed in
14 consultation with the Oklahoma State University-Oklahoma City
15 Paramedicine program and the Oklahoma Emergency Medical Technicians
16 Association. The letters "PM" shall be placed on the plate followed
17 by four random numbers, or such numbers as requested by such persons
18 applying for the plate. Twenty Dollars (\$20.00) of the fees
19 collected shall be deposited in the Emergency Medical Personnel
20 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63
21 of the Oklahoma Statutes. Subject to the provisions of subsection A
22 of this section, the Paramedic License Plate is hereby reauthorized
23 effective November 1, 2022;

1 103. National Defense Service Medal License Plate - such plates
2 shall be designed and issued to those persons who have received the
3 National Defense Service Medal and wish to demonstrate support for
4 the Oklahoma Department of Veterans Affairs. The license plates
5 shall be designed in consultation with the Oklahoma Department of
6 Veterans Affairs. Service Oklahoma shall be authorized to enter
7 into a licensing agreement with the Oklahoma Department of Veterans
8 Affairs for any licensing fees which may be required in order to use
9 the Department's logo or design. The licensing agreement shall
10 provide for a payment to the Oklahoma Department of Veterans Affairs
11 of not more than Twenty Dollars (\$20.00) for each license plate
12 issued;

13 104. University of Oklahoma RUF/NEKS License Plate - such
14 plates shall be designed and issued to any past or present member of
15 the University of Oklahoma RUF/NEKS upon providing proof of
16 membership in the organization as may be required by Service
17 Oklahoma. The license plates shall be designed in consultation with
18 the University of Oklahoma RUF/NEKS. Service Oklahoma shall be
19 authorized to enter into a licensing agreement with the University
20 of Oklahoma RUF/NEKS for any licensing fees which may be required in
21 order to use the organization's logo or design. The licensing
22 agreement shall provide for a payment to the Mike James RUF/NEKS
23 Memorial Scholarship of not more than Twenty Dollars (\$20.00) for
24 each license plate issued;

1 105. Tulsa Community College License Plate - such plates shall
2 be issued to persons wishing to support Tulsa Community College.
3 The plates shall be designed in consultation with Tulsa Community
4 College. Service Oklahoma shall be authorized to enter into a
5 licensing agreement with Tulsa Community College for any licensing
6 fees which may be required in order to use the organization's logo
7 or design. The licensing agreement shall provide for a payment to
8 Tulsa Community College of not more than Twenty Dollars (\$20.00) for
9 each license plate issued;

10 106. Street Kings Car Club License Plate - such plates shall be
11 designed and issued to any person wishing to demonstrate support for
12 the Street Kings Car Club in Guthrie. The license plates shall be
13 designed in consultation with the Street Kings Car Club. Service
14 Oklahoma shall be authorized to enter into a licensing agreement
15 with the Street Kings Car Club for any licensing fees which may be
16 required in order to use the organization's logo or design. The
17 licensing agreement shall provide for a payment to the Street Kings
18 Car Club of not more than Twenty Dollars (\$20.00) for each license
19 plate issued;

20 107. Epilepsy Foundation License Plate - such plates shall be
21 designed and issued to any person wishing to demonstrate support for
22 the Epilepsy Foundation. The license plates shall be designed in
23 consultation with the Epilepsy Foundation of Oklahoma. Service
24 Oklahoma shall be authorized to enter into licensing agreements with

1 the Epilepsy Foundation for any licensing fees which may be required
2 in order to use the organization's logo or design. The licensing
3 agreement shall provide for a payment to the Epilepsy Foundation of
4 not more than Twenty Dollars (\$20.00) for each license plate issued;

5 108. America First License Plate - such plates shall be
6 designed and issued to any person wishing to demonstrate support for
7 the proclamation of "America First". The license plates shall be
8 designed in consultation with Warriors for Freedom and the Honoring
9 America's Warriors Foundations. Service Oklahoma shall be
10 authorized to enter into licensing agreements with the Warriors for
11 Freedom and Honoring America's Warriors Foundations for any
12 licensing fees which may be required in order to use the
13 Foundations' logos or designs. The licensing agreements shall
14 provide for a payment to the Honoring America's Warriors Foundation
15 of not more than Ten Dollars (\$10.00) and a payment to the Warriors
16 for Freedom Foundation of not more than Ten Dollars (\$10.00) for
17 each license plate issued;

18 109. Diabetes Awareness License Plate - such plates shall be
19 designed and issued to any person wishing to provide financial
20 support for Diabetes Solutions of Oklahoma. The license plates
21 shall be designed in consultation with Diabetes Solutions of
22 Oklahoma. Service Oklahoma shall be authorized to enter into
23 licensing agreements with Diabetes Solutions of Oklahoma for any
24 licensing fees which may be required in order to use the Diabetes

1 Solutions of Oklahoma logos or designs. The licensing agreements
2 shall provide for a deposit to the Diabetes Awareness License Plate
3 Revolving Fund established in Section 1104.33 of this title;

4 110. Alliance of Mental Health Providers of Oklahoma License
5 Plate - such plates shall be designed and issued to any person
6 wishing to demonstrate support for the Alliance of Mental Health
7 Providers of Oklahoma. The license plates shall be designed in
8 consultation with the Alliance of Mental Health Providers of
9 Oklahoma. Service Oklahoma shall be authorized to enter into
10 licensing agreements with the Alliance of Mental Health Providers of
11 Oklahoma for any licensing fees which may be required in order to
12 use the organization's logo or design. The licensing agreement
13 shall provide for a payment to the Alliance of Mental Health
14 Providers of Oklahoma of not more than Twenty Dollars (\$20.00) for
15 each license plate issued;

16 111. Stillwater Public Schools License Plate - such plates
17 shall be designed and issued to any person wishing to demonstrate
18 support for the Stillwater School District. The license plates
19 shall be designed in consultation with the administration of the
20 Stillwater School District. Service Oklahoma shall be authorized to
21 enter into a licensing agreement with the Stillwater School District
22 for any licensing fees which may be required in order to use the
23 school district's logo or design. The licensing agreement shall

24

1 provide for a payment to the Stillwater School District of not more
2 than Twenty Dollars (\$20.00) for each license plate issued; and

3 112. Broken Arrow Public Schools License Plate - such plates
4 shall be designed and issued to any person wishing to demonstrate
5 support for Broken Arrow Public Schools. The license plates shall
6 be designed in consultation with the administration of Broken Arrow
7 Public Schools. Service Oklahoma shall be authorized to enter into
8 a licensing agreement with Broken Arrow Public Schools for any
9 licensing fee which may be required in order to use the school
10 district's logo or design. The licensing agreement shall provide
11 for payment to Broken Arrow Public Schools of not more than Twenty
12 Dollars (\$20.00) for each license plate issued.

13 C. The fee for such plates shall be Thirty-five Dollars
14 (\$35.00) per year of renewal and shall be in addition to all other
15 registration fees provided by the Oklahoma Vehicle License and
16 Registration Act. The fee shall be apportioned as follows through
17 June 30, 2023:

18 1. Twenty Dollars (\$20.00) per year of renewal or any other
19 amount as provided in this title of the fee shall be apportioned as
20 provided or deposited in a fund as specified within the paragraph
21 authorizing the special license plate;

22 2. Eight Dollars (\$8.00) per year of renewal of the fee shall
23 be deposited in the Tax Commission Reimbursement Fund to be used for
24 the administration of the Oklahoma Vehicle License and Registration

1 Act. Beginning January 1, 2023, Eight Dollars (\$8.00) per year of
2 renewal of the fee shall be deposited in the Service Oklahoma
3 Reimbursement Fund to be used for the administration of the Oklahoma
4 Vehicle License and Registration Act; and

5 3. Any remaining amounts of the fee shall be apportioned as
6 provided in Section 1104 of this title.

7 SECTION 2. REPEALER 47 O.S. 2021, Section 1104.13, is
8 hereby repealed.

9 SECTION 3. This act shall become effective November 1, 2025.
