21	2. The Secretary of State shall develop a schedule, subject to
22	approval by the President Pro Tempore of the State Senate, the
23	Speaker of the House of Representatives, and the Administrative
24	Rules Committee chairs of both houses, for the initial expiration of

necessary and shall include a cost-benefit analysis. The agency
shall also publish the request on its website.

E. 1. Except for rules expiring pursuant to subparagraph a of paragraph 2 of subsection A of this section, the Secretary of State shall provide notice to the promulgating agency at least eighteen (18) months prior to every rule's termination date. Agencies with rules expiring under subparagraph a of paragraph 2 of subsection A of this section shall be provided notice not later than sixty (60) days after the effective date of this act.

Lack of notice under this subsection shall not prevent
expiration of any rules under an agency's purview.

12 SECTION 2. This act shall become effective July 1, 2025.

SECTION 3. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
