AS INTRODUCED

An Act relating to boards and commissions; repealing 2 O.S. 2021, Section 16-38, which relates to the Advisory Committee of the South Central Interstate Forest Fire Protection Compact; repealing 43A O.S. 2021, Section 12-104, which relates to the Oklahoma Suicide Prevention Council; repealing 62 O.S. 2021, Section 34.30, which relates to the Electronic and Information Technology Accessibility Advisory Council; repealing 68 O.S. 2021, Section 50015, which relates to the Oklahoma Tourism Promotion Advisory Committee; repealing 70 O.S. 2021, Section 1210.451, which relates to the Oklahoma School for the Visual and Performing Arts; repealing 73 O.S. 2021, Section 176, which relates to the permanent legislative liaison committee; repealing 74 O.S. 2021, Section 291.10, which relates to the Staff Review Committee of the Senate; repealing 74 O.S. 2021, Section 840-1.7, as amended by Section 5, Chapter 243, O.S.L. 2022 (74 O.S. Supp. 2024, Section 840-1.7), which relates to the Oklahoma Merit Protection Commission; repealing 74 O.S. 2021, Section 1051, which relates to the Southern States Energy Compact; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 9. REPEALER 74 O.S. 2021, Section 1051, is

18 SECTION 10. This act shall become effective November 1, 2025.
