6 AS INTRODUCED

7 An Act relating to special license plates; amending
8 47 O.S. 2021, Section 1135.5, as last amended by
9 Section 1, Chapter 88, O.S.L. 2024 (47 O.S. Supp.
10 2024, Section 1135.5), which relates to the issuance
11 of special license plates; updating statutory
12 language; modifying certain special license plate;
13 repealing 47 O.S. 2021, Section 1104.13, which
14 relates to the Oklahoma Zoological Society Revolving
15 Fund; and providing an effective date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 47 O.S. 2021, Section 1135.5, as
18 last amended by Section 1, Chapter 88, O.S.L. 2024 (47 O.S. Supp.
19 2024, Section 1135.5), is amended to read as follows:

20 Section 1135.5. A. Service Oklahoma is hereby authorized to
21 design and issue appropriate official special license plates to
22 persons wishing to demonstrate support and provide financial
23 assistance as provided by this section.

24 Special license plates shall not be transferred to any other
person but shall be removed from the vehicle upon transfer of
ownership and retained. The special license plate may then be used

1 on another vehicle but only after such other vehicle has been
2 registered for the current year with a licensed operator.

3 Special license plates shall be renewed each year by Service
4 Oklahoma or a licensed operator, unless authorized by Service
5 Oklahoma to be renewed for a period greater than one (1) year.
6 Service Oklahoma shall notify by mail all persons issued special
7 license plates. The notice shall contain all necessary information
8 and shall contain instructions for the renewal procedure upon
9 presentation to a licensed operator or Service Oklahoma. The
10 license plates shall be issued on a staggered system.

11 Service Oklahoma is hereby directed to develop and implement a
12 system whereby licensed operators are permitted to accept
13 applications for special license plates authorized under this
14 section. The licensed operator shall confirm the applicant's
15 eligibility, if applicable, collect and deposit any amount
16 specifically authorized by law, accept and process the necessary
17 information directly into such system and generate a receipt
18 accordingly. For performance of these duties, licensed operators
19 shall retain the fee provided in Section 1141.1 of this title for
20 registration of a motor vehicle through June 30, 2025. Through June
21 30, 2025, the licensed operator fees for acceptance of applications
22 and renewals shall be paid out of the Service Oklahoma Reimbursement
23 Fund. Beginning July 1, 2023, fees shall be retained by the
24

1 licensed operator pursuant to subsection E of Section 1141.1 of this
2 title.

3 If fewer than one hundred of any type of special license plates
4 authorized prior to January 1, 2004, are issued prior to January 1,
5 2006, Service Oklahoma shall discontinue issuance and renewal of
6 that type of special license plate. Any such authorized special
7 license plate registrant shall be allowed to display the license
8 plate upon the designated vehicle until the registration expiration
9 date. After such time the expired special license plate shall be
10 removed from the vehicle.

11 For special license plates authorized on or after July 1, 2004,
12 no special license plates shall be developed or issued by Service
13 Oklahoma until Service Oklahoma receives one hundred prepaid
14 applications therefor. The prepaid applications must be received by
15 Service Oklahoma within one hundred eighty (180) days of the
16 effective date of the authorization or the authority to issue shall
17 be null and void. In the event one hundred prepaid applications are
18 not received by Service Oklahoma within such prescribed time period
19 any payment so received shall be refunded accordingly.

20 B. The special license plates provided by this section are as
21 follows:

22 1. University or College Supporter License Plate - such plates
23 shall be designed and issued to any person wishing to demonstrate
24 support to any state-supported or private university or college. As

1 provided in this section, an amount of the fee collected shall be
2 apportioned as provided in Section 1104.1 of this title;

3 2. Environmental Awareness License Plate - such plates shall be
4 designed, subject to the criteria to be presented to Service
5 Oklahoma by the Department of Environmental Quality in consultation
6 with the Oklahoma Arts Council, and issued to any person wishing to
7 demonstrate support to implement the statewide general public
8 Environmental Education Program created pursuant to the provisions
9 of the Oklahoma Environmental Quality Code. Such plates shall be
10 designed and issued to any person in any combination of numbers and
11 letters from one to a maximum of seven, as for personalized license
12 plates. A dealer's license plate issued pursuant to Section 1116.1
13 or 1128 of this title may be designated an Environmental Awareness
14 License Plate upon payment of the fee imposed by this section and
15 any other registration fees required by the Oklahoma Vehicle License
16 and Registration Act. As provided in this section, an amount of the
17 fee collected shall be apportioned pursuant to Section 1104.2 of
18 this title;

19 3. Firefighter License Plate - such plates shall be designed
20 for any career or retired firefighter, volunteer or paid.
21 Firefighters may apply for firefighter plates for up to four
22 vehicles with a rated capacity of one (1) ton or less or for a
23 motorcycle upon proof of a fire department membership by either an
24 identification card or letter from the chief of the fire department.

1 Retirees who are eligible for such plates shall provide proof of
2 eligibility upon initial application, but shall not be required to
3 provide proof of eligibility annually. The surviving spouse of any
4 deceased firefighter, if the spouse has not since remarried, may
5 apply for a firefighter license plate for one vehicle with a rated
6 carrying capacity of one (1) ton or less or for a motorcycle upon
7 proof that the deceased firefighter was a member of a fire
8 department by either an identification card or letter from the chief
9 of the fire department. The license plate shall be designed in
10 consultation with the Oklahoma State Firefighters Association.

11 As provided in this section, an amount of the fee collected
12 shall be deposited to the Oklahoma State Firemen's Museum Building &
13 Memorial Fund for support of the Oklahoma State Firefighters Museum
14 and the Oklahoma Fallen and Living Firefighters Memorial;

15 4. Wildlife Conservation License Plate - such plates shall be
16 designed, subject to the criteria to be presented to Service
17 Oklahoma by the Department of Wildlife Conservation in consultation
18 with the Oklahoma Arts Council, and issued to any person wishing to
19 demonstrate support for wildlife conservation in this state through
20 the Wildlife Diversity Fund, provided for in Section 3-310 of Title
21 29 of the Oklahoma Statutes. Such plates may be designed and issued
22 to any person as for personalized license plates.

1 As provided in this section, an amount of the fee collected
2 shall be apportioned pursuant to subsection D of Section 3-310 of
3 Title 29 of the Oklahoma Statutes;

4 5. Child Abuse Prevention License Plate - such plates shall be
5 designed, subject to the criteria to be presented to Service
6 Oklahoma by the Office of Child Abuse Prevention in the State
7 Department of Health and the Child Abuse Prevention Action
8 Committee, and issued to any person wishing to demonstrate support
9 for the prevention of child abuse.

10 As provided in this section, an amount of the fee collected
11 shall be deposited in the Child Abuse Prevention Fund;

12 6. United States Olympic and Paralympic Committee Supporter
13 License Plate - such plates shall be designed and issued to any
14 person wishing to demonstrate support for the United States Olympic
15 and Paralympic Committee. The plates shall be issued to any person
16 in any combination of numbers and letters from one to a maximum of
17 seven, as for personalized license plates. The plate shall contain
18 the official United States Olympic and Paralympic Committee logo.
19 Service Oklahoma shall be authorized, if necessary, to enter into a
20 licensing agreement with the United States Olympic and Paralympic
21 Committee for any licensing fees which may be required in order to
22 use the United States Olympic and Paralympic Committee logo or
23 design. The licensing agreement shall provide for a payment of not
24

1 more than Twenty-five Dollars (\$25.00) for each license plate
2 issued;

3 7. Oklahoma History License Plate - such plates shall be
4 designed and issued to any person wishing to demonstrate interest in
5 Oklahoma history. As provided in this section, an amount of the fee
6 collected shall be deposited to the Oklahoma Historical Society
7 Revolving Fund to be used for educational purposes;

8 8. Historic Route 66 License Plate - such:

- 9 a. vehicle plates shall be designed to honor historic
10 Route 66, also known as the "Mother Road". As
11 provided in this section, an amount of the fee
12 collected for each vehicle license plate shall be
13 apportioned to the Oklahoma Historical Society
14 Revolving Fund to be distributed to the Oklahoma Route
15 66 Museum located in Clinton, Oklahoma, and
- 16 b. motorcycle plates shall be designed in consultation
17 with the Oklahoma Route 66 Association, Inc. Service
18 Oklahoma shall be authorized to enter into a licensing
19 agreement with the Oklahoma Route 66 Association,
20 Inc., for any licensing fees which may be required in
21 order to use the Oklahoma Route 66 Association, Inc.,
22 logo or design. The licensing agreement shall provide
23 for a payment to the Oklahoma Route 66 Association,

1 Inc., of not more than Twenty Dollars (\$20.00) for
2 each motorcycle license plate issued;

3 9. Heart of the Heartland License Plate - such plates shall be
4 designed and issued to any person wishing to honor the victims of
5 the terrorist bombing attack on the Alfred P. Murrah Federal
6 Building in downtown Oklahoma City on April 19, 1995. As provided
7 in this section, an amount of the fee collected shall be deposited
8 in the Heart of the Heartland Scholarship Fund, as established in
9 Section 2282 of Title 70 of the Oklahoma Statutes;

10 10. Emergency Medical Technician License Plate - such plates
11 shall be designed and issued to any person who is an emergency
12 medical technician. Such persons may apply for an emergency medical
13 technician license plate for each vehicle with a rated carrying
14 capacity of one (1) ton or less upon proof of an emergency medical
15 technician's license. The license plate shall be designed in
16 consultation with the Oklahoma Emergency Medical Technicians
17 Association. As provided in this section, an amount of the fee
18 collected shall be apportioned to the Emergency Medical Personnel
19 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63
20 of the Oklahoma Statutes;

21 11. Fight Breast Cancer License Plate - such plates shall be
22 designed to demonstrate support for the prevention and treatment of
23 breast cancer in this state;

1 12. Crime Victims Awareness License Plate - such plates shall
2 be designed and issued to any person wishing to demonstrate
3 awareness of and support for victims of crimes. The license plates
4 shall be designed in consultation with the Crime Victims
5 Compensation Program. As provided in this section, an amount of the
6 fee collected shall be apportioned to the Attorney General's
7 Revolving Fund for the Office of the Attorney General, which is
8 hereby directed to use such funds to contract with a statewide
9 nonprofit organization to provide services to crime victims;

10 13. Safe Kids Oklahoma License Plate - such plates shall be
11 designed and issued to any person wishing to demonstrate support and
12 awareness of the Safe Kids Oklahoma. The license plate shall be
13 designed in consultation with the Oklahoma Safe Kids Association.
14 As provided in this section, an amount of the fee collected shall be
15 deposited in the Children's Hospital - Oklahoma Safe Kids
16 Association Revolving Fund to be distributed to the Safe Kids
17 Oklahoma program;

18 14. Oklahoma Four-H Club License Plate - such plates shall be
19 designed, subject to criteria to be presented to Service Oklahoma by
20 the Four-H Foundation, and issued to any person wishing to
21 demonstrate support of the Oklahoma Four-H Club. Such plates may be
22 designed and issued to any person as for personalized license
23 plates. As provided in this section, an amount of the fee collected
24

1 shall be apportioned to the OSU Extension Service License Plate
2 Revolving Fund created in Section 1104.4 of this title;

3 15. Agricultural Awareness License Plate - such plates shall be
4 designed, subject to criteria to be presented to Service Oklahoma,
5 by the Oklahoma Department of Agriculture, Food, and Forestry in
6 consultation with the Oklahoma Arts Council, and issued to any
7 person wishing to demonstrate support of the Department's Ag in the
8 Classroom Education Program. As provided in this section, an amount
9 of the fee collected shall be apportioned as provided in Section
10 1104.3 of this title;

11 16. Oklahoma Statehood Centennial License Plate - such plates
12 shall be designed and issued to any person wishing to commemorate
13 the centennial of Oklahoma's admission to statehood in 1907. The
14 license plates shall be designed in consultation with the Oklahoma
15 Capitol Complex and Centennial Commemoration Commission. As
16 provided in this section, an amount of the fee collected shall be
17 deposited in the Oklahoma Department of Commerce Revolving Fund
18 created in Section 5012 of Title 74 of the Oklahoma Statutes;

19 17. Support Education License Plate - such plates shall be
20 designed, subject to criteria to be presented to Service Oklahoma by
21 the State Department of Education in consultation with the Oklahoma
22 Arts Council, and issued to any person wishing to demonstrate
23 support for education in this state. All licensed operators shall
24 display a sample of the Support Education License plate in the area

1 of the business accessed by the public. Twenty-three Dollars
2 (\$23.00) of the fee collected shall be apportioned as follows:

- 3 a. five percent (5%) shall be deposited to the Education
4 Reform Revolving Fund,
- 5 b. five percent (5%) shall be deposited to the Oklahoma
6 State Regents for Higher Education Revolving Fund,
- 7 c. five percent (5%) shall be deposited to the State
8 Career-Technology Fund, and
- 9 d. eighty-five percent (85%) shall be deposited to the
10 Retirement Benefit Fund as set forth in Section 17-108
11 of Title 70 of the Oklahoma Statutes.

12 However, when the Retirement Benefit Fund attains a seventy
13 percent (70%) funded ratio based on an annual actuarial valuation as
14 required by law, the amount of the fee shall be apportioned equally
15 pursuant to subparagraphs a, b and c of this paragraph;

16 18. Retired Oklahoma Highway Patrol Officers License Plate -
17 such plates shall be designed and issued to any retired officer of
18 the Oklahoma Highway Patrol. The license plate shall have the
19 legend "Oklahoma" and shall contain, in the center of the plate, the
20 Highway Patrol Officers patch using the same colors and pattern as
21 used in the patch. Centered on the bottom of the license plate
22 shall be the word "Retired". The letters "TRP" shall be used in
23 combination with three numbers on either side of the insignia or
24 emblem. The color of the letters and numbers shall be brown.

1 Retirees who are eligible for such plates shall provide proof of
2 eligibility upon initial application, but shall not be required to
3 provide proof of eligibility annually. The surviving spouse of any
4 deceased retired officer of the Oklahoma Highway Patrol, if the
5 spouse has not since remarried, or if remarried, the remarriage is
6 terminated by death, divorce, or annulment, may apply for a Retired
7 Oklahoma Highway Patrol Officers license plate. As provided in this
8 section, an amount of the fee collected shall be deposited into the
9 Oklahoma Law Enforcement Retirement Fund;

10 19. Boy Scouts of America Supporter License Plate - such plates
11 shall be designed and issued to any person wishing to demonstrate
12 support for the Boy Scouts of America. The plates shall be issued
13 to any person in any combination of numbers and letters from one to
14 a maximum of seven, as for personalized license plates. The plate
15 shall contain the official Boy Scouts of America logo. Service
16 Oklahoma shall be authorized, if necessary, to enter into a
17 licensing agreement with the Boy Scouts of America for any licensing
18 fees which may be required in order to use the Boy Scouts of America
19 logo or design. The licensing agreement shall provide for a payment
20 to the Boy Scouts of America of not more than Twenty Dollars
21 (\$20.00) for each license plate issued;

22 20. Urban Forestry and Beautification License Plate - such
23 plates shall be designed, subject to criteria to be presented to
24 Service Oklahoma, by the Oklahoma Department of Agriculture, Food,

1 and Forestry in consultation with nonprofit organizations in this
2 state that develop and operate programs to encourage urban forestry
3 and beautification, and issued to any person wishing to demonstrate
4 support of such programs. As provided in this section, an amount of
5 the fee collected shall be apportioned as provided in Section 1104.5
6 of this title;

7 21. Oklahoma State Parks Supporter License Plate - such plates
8 shall be designed, subject to criteria to be presented to ~~Serve~~
9 Service Oklahoma by the Oklahoma Tourism and Recreation Department,
10 and issued to any person wishing to demonstrate support for the
11 Oklahoma state parks system. Twenty-three Dollars (\$23.00) of the
12 fee collected shall be deposited in the Oklahoma Tourism and
13 Recreation Department Revolving Fund. Such money shall be
14 designated for and may only be expended for the support of Oklahoma
15 state parks;

16 22. Adoption Creates Families License Plate - such plates shall
17 be issued to any person wishing to demonstrate support of pregnant
18 women who are committed to placing their children for adoption and
19 wishing to provide assistance to guardians, adoptive parents and
20 other created families to assist in the adoption and placement of
21 children in permanent, safe homes. The license plates shall be
22 designed and final terminology delivered in consultation with the
23 Oklahoma Adoption Coalition and the Department of Human Services.
24 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited

1 in a revolving fund established in the State Treasury for and to be
2 used by the Department of Human Services for the implementation of
3 the Investing in Stronger Oklahoma Families Act specifically for
4 created families;

5 23. Choose Life License Plate - such plates shall be designed,
6 subject to criteria presented to Service Oklahoma, by Choose Life
7 America, Inc., and issued to any person who wishes to demonstrate
8 support of organizations that encourage adoption as a positive
9 choice for women with unplanned pregnancies. As provided in this
10 section, an amount of the fee collected shall be deposited in the
11 Choose Life Assistance Program Revolving Fund established in Section
12 1104.6 of this title;

13 24. Future Farmers of America License Plate - such plates shall
14 be designed and issued to persons wishing to demonstrate support for
15 the Oklahoma FFA Association (formerly known as Future Farmers of
16 America). The license plates shall be designed in consultation with
17 the Oklahoma FFA Association Board of Directors. As provided in
18 this section, an amount of the fee collected shall be apportioned as
19 provided in Section 1104.7 of this title;

20 25. Lions Club License Plate - such plates shall be designed
21 and issued to persons wishing to demonstrate support for the Lions
22 Clubs of Oklahoma. The plates shall be issued to any person in any
23 combination of numbers and letters from one to a maximum of seven,
24 as for personalized license plates. The license plates shall be

1 designed in consultation with the Oklahoma Lions Service Foundation
2 and shall contain the official logo of the International Association
3 of Lions Clubs. Service Oklahoma shall be authorized to enter into
4 a licensing agreement with the Oklahoma Lions Service Foundation.
5 The licensing agreement shall provide for a payment to the Oklahoma
6 Lions Service Foundation of not more than Ten Dollars (\$10.00) for
7 each license plate issued;

8 26. Color Oklahoma License Plate - such plates shall be
9 designed, subject to criteria to be presented to Service Oklahoma by
10 the Oklahoma Native Plant Society, and issued to any person wishing
11 to demonstrate support for preserving and planting wildflowers and
12 native plants in this state and to promote Oklahoma's wildflower
13 heritage through education. As provided in this section, an amount
14 of the fee collected shall be apportioned as provided in Section
15 1104.8 of this title;

16 27. Girl Scouts of the United States of America Supporter
17 License Plate - such plates shall be designed and issued to any
18 person wishing to demonstrate support for the Girl Scouts of the
19 United States of America. The plates shall be issued to any person
20 in any combination of numbers and letters from one to a maximum of
21 seven, as for personalized license plates. The plate shall contain
22 the official Girl Scouts of the United States of America logo.
23 Service Oklahoma shall be authorized, if necessary, to enter into a
24 licensing agreement with the Girl Scouts of the United States of

1 America for any licensing fees which may be required in order to use
2 the Girl Scouts of the United States of America logo or design. The
3 licensing agreement shall provide for a payment to the Magic Empire
4 Council of Girl Scouts, acting on behalf of all Oklahoma Girl Scout
5 councils, of not more than Twenty Dollars (\$20.00) for each license
6 plate issued;

7 28. Oklahoma City Memorial Marathon License Plate - such plates
8 shall be designed and issued to any person wishing to demonstrate
9 support for the Oklahoma City Memorial Marathon. The plate shall be
10 designed in consultation with the Oklahoma City Memorial Marathon.
11 Service Oklahoma shall be authorized to enter into a licensing
12 agreement with the Oklahoma City Memorial Marathon for any licensing
13 fees which may be required in order to use the Oklahoma City
14 Memorial Marathon logo or design. The licensing agreement shall
15 provide for a payment to the Oklahoma City Memorial Marathon of not
16 more than Twenty Dollars (\$20.00) for each license plate issued;

17 29. Oklahoma Scenic Rivers License Plate - such plates shall be
18 designed to demonstrate support for the Grand River Dam Authority.
19 The plates shall be designed in consultation with the Grand River
20 Dam Authority. Twenty-five Dollars (\$25.00) of the fee shall be
21 apportioned to the Grand River Dam Authority;

22 30. Fight Cancer License Plate - such plates shall be designed
23 to demonstrate support for the Oklahoma Central Cancer Registry.
24 The plate shall contain the American Cancer Society logo. The

1 American Cancer Society logo shall be used in accordance with the
2 American Cancer Society's branding guidelines and shall only be
3 utilized to support the Oklahoma Central Cancer Registry. Twenty
4 Dollars (\$20.00) of the fee shall be apportioned to the Oklahoma
5 Central Cancer Registry Revolving Fund;

6 31. Animal Friendly License Plate - such plates shall be
7 designed and issued to any person wishing to demonstrate support for
8 controlling the overpopulation of dogs and cats through educational
9 and sterilization efforts. The plates shall be designed in
10 consultation with the Veterinary Medical Association. Twenty
11 Dollars (\$20.00) of the fee collected shall be designated by the
12 purchaser of the plate to be deposited in the Oklahoma Pet
13 Overpopulation Fund created in Section 2368.13 of Title 68 of the
14 Oklahoma Statutes or the Animal Friendly Revolving Fund created in
15 Section 1104.10 of this title;

16 32. Patriot License Plate - such plates shall be designed in
17 consultation with the Military Department of the State of Oklahoma
18 and issued to any person wishing to demonstrate support for Oklahoma
19 residents who are members of the Oklahoma National Guard and
20 deployed on active duty. The plates shall be issued to any person
21 in any combination of numbers and letters from one to a maximum of
22 seven, as for personalized license plates. As provided in this
23 section, a portion of the fee collected shall be deposited in the
24

1 Patriot License Plate Revolving Fund created in Section 1104.11 of
2 this title;

3 33. Global War on Terrorism License Plate - such plate shall be
4 designed in consultation with the Military Department of the State
5 of Oklahoma and issued to any person wishing to demonstrate support
6 for Oklahoma residents who are members of the Armed Forces of the
7 United States or Oklahoma National Guard that have served in the
8 Global War on Terrorism. The plate shall be issued to any person in
9 any combination of numbers and letters from one to a maximum of six.
10 As provided in this section, a portion of the fee collected shall be
11 deposited in the Oklahoma National Guard Museum Fund created in
12 Section 235.1 of Title 44 of the Oklahoma Statutes;

13 34. Boys and Girls Clubs of America Supporter License Plate -
14 such plates shall be designed and issued to any person wishing to
15 demonstrate support for the Boys and Girls Clubs of America. The
16 plates shall be issued to any person in any combination of numbers
17 and letters from one to a maximum of seven, as for personalized
18 license plates. The plate shall contain the official Boys and Girls
19 Clubs of America logo. Service Oklahoma, if necessary, may enter
20 into a licensing agreement with the Boys and Girls Clubs of America
21 for any licensing fees which may be required in order to use the
22 Boys and Girls Clubs of America logo or design. The licensing
23 agreement shall provide for a payment to the Boys and Girls Clubs of
24

1 America of not more than Twenty Dollars (\$20.00) for each license
2 plate issued;

3 35. Oklahoma Quarter Horse License Plate - such plates shall be
4 designed and issued to any person wishing to demonstrate support for
5 the American Quarter Horse in this state. The plate shall be
6 designed in consultation with the Oklahoma Quarter Horse
7 Association. As provided in this section, a portion of the fee
8 collected shall be deposited in the Oklahoma Quarter Horse Revolving
9 Fund created in Section 1104.12 of this title;

10 36. Oklahoma Association for the Deaf License Plate - such
11 plates shall be designed in consultation with the Oklahoma
12 Association for the Deaf and issued to any person wishing to
13 demonstrate support for Oklahoma residents who are deaf. The plates
14 shall be issued to any person in any combination of numbers and
15 letters from one to a maximum of seven, as for personalized license
16 plates. As provided in this section, a portion of the fee collected
17 shall be deposited in the Oklahoma Association for the Deaf License
18 Plate Revolving Fund created in Section 1104.15 of this title;

19 37. Oklahoma City Zoo License Plate - such plates shall be
20 issued to any person wishing to demonstrate support for the Oklahoma
21 City Zoo. The license plates shall be designed in consultation with
22 the Oklahoma Zoological Society, Inc. ~~As provided in this section,~~
23 ~~an amount of the fee collected~~ Service Oklahoma shall be deposited

12 plates shall be designed in consultation with the Oklahoma Music
13 Hall of Fame Inc. and issued to any member of the organization
14 wishing to demonstrate support. Service Oklahoma shall be
15 authorized to enter into a licensing agreement with the Oklahoma
16 Music Hall of Fame Inc. for any licensing fees which may be required
17 in order to use the organization's logo or design. The licensing
18 agreement shall provide for a payment to the Oklahoma Music Hall of
19 Fame Inc. of not more than Twenty Dollars (\$20.00) for each license
20 plate issued. The plates shall incorporate a numbering system
21 agreed upon by the Oklahoma Music Hall of Fame Inc. and Service
22 Oklahoma. Subject to the provisions of subsection A of this
23 section, the Oklahoma Music Hall of Fame Inc. License Plate is
24 hereby reauthorized effective November 1, 2019;

1 81. Techlahoma Foundation License Plate - such plates shall be
2 issued to any person wishing to provide financial support for the
3 Techlahoma Foundation. The license plate shall be designed in
4 consultation with the Techlahoma Foundation. The plate shall be
5 issued to any person in any combination of numbers and letters from
6 one to a maximum of seven, as for personalized license plates.
7 Service Oklahoma shall be authorized to enter into a licensing
8 agreement with the Techlahoma Foundation for any licensing fees,
9 which may be required in order to use the association's logo or
10 design. The licensing agreement shall provide for a payment to the
11 Techlahoma Foundation of not more than Twenty Dollars (\$20.00) for
12 each license plate issued;

13 82. Bethany Public Schools Foundation License Plate - such
14 plates shall be issued to any person wishing to demonstrate support
15 for the Bethany Public Schools Foundation. The license plates shall
16 be designed in consultation with the administration of the Bethany
17 Public Schools Foundation. Service Oklahoma shall be authorized to
18 enter into a licensing agreement with the Bethany Public Schools
19 Foundation for any licensing fees which may be required in order to
20 use the Foundation's logo or design. The licensing agreement shall
21 provide for a payment to the Bethany Public Schools Foundation of
22 not more than Twenty Dollars (\$20.00) for each license plate issued;

23 83. Cystic Fibrosis Foundation License Plate - such plates
24 shall be issued to any person wishing to demonstrate support for the
25

1 Cystic Fibrosis Foundation. The license plates shall be designed in
2 consultation with the administration of the Cystic Fibrosis
3 Foundation. Service Oklahoma shall be authorized to enter into a
4 licensing agreement with the Cystic Fibrosis Foundation for any
5 licensing fees which may be required in order to use the
6 Foundation's logo or design. The licensing agreement shall provide
7 for a payment to the Cystic Fibrosis Foundation of not more than
8 Twenty Dollars (\$20.00) for each license plate issued;

9 84. Down Syndrome Association of Central Oklahoma License Plate
10 - such plates shall be designed and issued to any person wishing to
11 demonstrate support for the Down Syndrome Association of Central
12 Oklahoma. Such plates shall be designed in consultation with the
13 Association. As provided in this section, an amount of the fee
14 collected shall be deposited in the Down Syndrome Association of
15 Central Oklahoma License Plate Revolving Fund created in Section
16 1104.30 of this title;

17 85. Elk City Education Foundation License Plate - such plates
18 shall be designed and issued to any person wishing to demonstrate
19 support for the Elk City Education Foundation. Such plates shall be
20 designed in consultation with the Foundation. As provided in this
21 section, an amount of the fee collected shall be deposited in the
22 Elk City Education Foundation License Plate Revolving Fund created
23 in Section 1104.31 of this title;

1 86. A Brotherhood Aiming Toward Education of Oklahoma (ABATE)
2 License Plate - such plates shall be designed and issued to any
3 person wishing to provide financial support for ABATE of Oklahoma.
4 Such plates shall be designed in consultation with ABATE of
5 Oklahoma. The plates shall be issued to any person in any
6 combination of numbers and letters from one to a maximum of seven,
7 as for personalized plates. The license plate for a motorcycle may
8 be of similar design as space permits or a new design in order to
9 meet the space requirements of a motorcycle license plate. Service
10 Oklahoma shall be authorized to enter into a licensing agreement
11 with ABATE of Oklahoma for any licensing fees which may be required
12 in order to use the ABATE of Oklahoma logo or design. The licensing
13 agreement shall provide for a payment to ABATE of Oklahoma of not
14 more than Twenty Dollars (\$20.00) for each license plate issued;

15 87. Downed Bikers Association License Plate - such plates shall
16 be designed for a vehicle or motorcycle in any combination of
17 numbers and letters from one to a maximum of seven, as for
18 personalized license plates, and issued to any person wishing to
19 demonstrate support for the Downed Bikers Association, a nonprofit
20 charitable organization exempt from taxation pursuant to the
21 provisions of the Internal Revenue Code, 26 U.S.C., Section
22 501(c) (3), which provides emotional and financial support for downed
23 bikers. The license plate shall be designed in consultation with
24 the Central Oklahoma Chapter of the Downed Bikers Association and

1 shall contain any official logo or design of the organization. The
2 license plate for a motorcycle may be of similar design as space
3 permits or a new design in order to meet the space requirements of a
4 motorcycle license plate. Service Oklahoma, if necessary, may enter
5 into a licensing agreement with the Downed Bikers Association for
6 any licensing fees which may be required in order to use the
7 organization's logo or design. The licensing agreement shall
8 provide for a payment to the Downed Bikers Association of not more
9 than Twenty Dollars (\$20.00) for each license plate;

10 88. Eagle Scout License Plate - such plates shall be designed
11 to demonstrate support for Eagle Scouts of the Boy Scouts of America
12 and shall include the Eagle Scout logo. Plates may be issued to any
13 person who can show proof of having obtained the rank of Eagle
14 Scout. Service Oklahoma shall be authorized to enter into a
15 licensing agreement with the various Oklahoma local councils for any
16 licensing fees which may be required in order to use the applicable
17 logo or design. The licensing agreement shall provide for a payment
18 of not more than Twenty Dollars (\$20.00) for each license plate
19 issued to the specific Oklahoma local area council designated by the
20 applicant;

21 89. Extraordinary Educators License Plate - such plates shall
22 be designed and issued to any person wishing to provide financial
23 support for common education in this state. Such plates shall be
24 designed in consultation with the State Department of Education.

1 The plates shall be issued to any person in any combination of
2 numbers and letters from one to a maximum of seven, as for
3 personalized license plates. As provided in this section, an amount
4 of the fee collected shall be deposited in the Extraordinary
5 Educators License Plate Revolving Fund created in Section 1104.32 of
6 this title;

7 90. Former Oklahoma Legislator License Plate - such plates
8 shall be designed and issued to any person who previously served as
9 a member of the House of Representatives or Senate. The license
10 plates shall be designed in consultation with the Oklahoma
11 Historical Society. As provided in this section, an amount of the
12 fee collected shall be deposited in the Oklahoma Historical Society
13 Capital Improvement and Operations Revolving Fund created in Section
14 1.10a of Title 53 of the Oklahoma Statutes. Service Oklahoma shall
15 create and maintain a list of former members of the House of
16 Representatives and Senate eligible to be issued such plates;
17 provided, that no former member of the House of Representatives and
18 Senate shall be eligible to possess more than two of such plates at
19 any one time. Service Oklahoma shall confer as needed with the
20 Chief Clerk of the House of Representatives and the Secretary of the
21 Senate to confirm that such list is complete and accurate;

22 91. Monarch Butterfly License Plate - such plates shall be
23 designed and issued to any person wishing to demonstrate support for
24 the operations of the Oklahoma Monarch Society. Such plates shall

1 be designed in consultation with the Oklahoma Monarch Society.
2 Service Oklahoma shall be authorized to enter into a licensing
3 agreement with the Oklahoma Monarch Society for any licensing fees
4 which may be required in order to use the foundation's logo or
5 design. The plates shall be issued to any person in any combination
6 of numbers and letters from one to a maximum of seven, as for
7 personalized license plates. The licensing agreement shall provide
8 for a payment to the Oklahoma Monarch Society of not more than
9 Twenty Dollars (\$20.00) for each license plate issued;

10 92. Oklahoma Tennis Foundation License Plate - such plates
11 shall be designed and issued to any person wishing to demonstrate
12 support for the Oklahoma Tennis Foundation. The license plates
13 shall be designed in consultation with the Oklahoma Tennis
14 Foundation. Service Oklahoma shall be authorized to enter into a
15 licensing agreement with the Oklahoma Tennis Foundation for any
16 licensing fees which may be required in order to use the
17 foundation's logo or design. The licensing agreement shall provide
18 for a payment to the Oklahoma Tennis Foundation of not more than
19 Twenty Dollars (\$20.00) for each license plate issued;

20 93. Oklahoma Veterans of Foreign Wars License Plate - such
21 plates shall be designed to honor the Oklahoma Veterans of Foreign
22 Wars Chapters and shall be issued to any resident of this state upon
23 proof of membership in the Oklahoma Veterans of Foreign Wars
24 organization. The license plates shall be designed in consultation

1 with the Oklahoma Veterans of Foreign Wars organization. Service
2 Oklahoma shall be authorized to enter into a licensing agreement
3 with the Oklahoma Veterans of Foreign Wars organization for any
4 licensing fees which may be required in order to use the
5 organization's logo or design. The licensing agreement shall
6 provide for a payment to the Oklahoma Veterans of Foreign Wars
7 organization of not more than Twenty Dollars (\$20.00) for each
8 license plate issued. Service Oklahoma shall reinstate any Veterans
9 of Foreign Wars license plates issued prior to November 1, 2021, and
10 shall reimburse any individual who held a Veterans of Foreign Wars
11 License Plate on October 31, 2021, for fees incurred for the
12 replacement of such plate;

13 94. Oklahoma Women Veterans Organization License Plate - such
14 plates shall be designed and issued to any female veteran of any
15 branch of the United States Armed Forces wishing to demonstrate
16 support for the Oklahoma Women Veterans Organization. The license
17 plates shall be designed in consultation with the Oklahoma Women
18 Veterans Organization. Service Oklahoma shall be authorized to
19 enter into a licensing agreement with the Oklahoma Women Veterans
20 Organization for any licensing fees which may be required in order
21 to use the organization's logo or design. The licensing agreement
22 shall provide for a payment to the Oklahoma Women Veterans
23 Organization of not more than Twenty Dollars (\$20.00) for each
24 license plate issued;

1 95. FIRST (For Inspiration and Recognition of Science and
2 Technology) in Oklahoma License Plate - such plates shall be issued
3 to any person wishing to demonstrate support for FIRST in Oklahoma
4 Robotics programs. The license plates shall be designed in
5 consultation with the administration of FIRST in Oklahoma. Service
6 Oklahoma shall be authorized to enter into a licensing agreement
7 with FIRST in Oklahoma for any licensing fees which may be required
8 in order to use the FIRST in Oklahoma logo or design. The licensing
9 agreement shall provide for a payment to FIRST in Oklahoma of not
10 more than Twenty Dollars (\$20.00) for each license plate issued;

11 96. Pittsburg State University License Plate - such plates
12 shall be designed and issued to any person wishing to demonstrate
13 support for the Pittsburg State University. The license plates
14 shall be designed in consultation with Pittsburg State University.
15 Service Oklahoma shall be authorized to enter into a licensing
16 agreement with Pittsburg State University for any licensing fees
17 which may be required in order to use the school foundation's logo
18 or design. The licensing agreement shall provide for a payment to
19 the Pittsburg State University of not more than Twenty Dollars
20 (\$20.00) for each license plate issued;

21 97. Greenwood Historical District License Plate - such plates
22 shall be issued to persons wishing to demonstrate support for the
23 Tulsa Juneteenth Festival held in the Greenwood Historical District
24 in Tulsa, Oklahoma. The plates shall be issued to any person in any

1 combination of numbers and letters from one to a maximum of seven,
2 as for personalized license plates. The license plates shall be
3 designed in consultation with the Black Wall Street Chamber of
4 Commerce. Service Oklahoma shall be authorized to enter into a
5 licensing agreement with the Tulsa Juneteenth Festival for any
6 licensing fees which may be required in order to use the Festival's
7 logo or design. For each license plate issued, the licensing
8 agreement shall provide for a payment of Twenty-five Dollars
9 (\$25.00) of the fee collected to the Tulsa Juneteenth Festival and
10 an additional Two Dollars (\$2.00) of the fee collected shall be
11 deposited in the Public School Classroom Support Revolving Fund, for
12 expenditure as provided in Section 1-123 of Title 70 of the Oklahoma
13 Statutes;

14 98. Oklahoma Veterans of Foreign Wars Auxiliary Chapters
15 License Plate - such plates shall be designed to honor the Oklahoma
16 Veterans of Foreign Wars Auxiliary Chapters and issued to any
17 resident of this state upon proof of membership in the Oklahoma
18 Veterans of Foreign Wars Auxiliary organization in this state. The
19 license plates shall be designed in consultation with the Oklahoma
20 Veterans of Foreign Wars Auxiliary organization. Service Oklahoma
21 shall be authorized to enter into a licensing agreement with the
22 Oklahoma Veterans of Foreign Wars Auxiliary organization for any
23 licensing fees which may be required in order to use the
24 organization's logo or design. The licensing agreement shall

1 provide for a payment to the Oklahoma Veterans of Foreign Wars
2 Auxiliary organization of not more than Twenty Dollars (\$20.00) for
3 each license plate issued;

4 99. Transportation to Transportation License Plate - such
5 plates shall be designed and issued to persons wishing to support
6 county roads and bridges. The license plates shall be designed in
7 consultation with the Association of County Commissioners of
8 Oklahoma. Twenty Dollars (\$20.00) of the fee collected shall be
9 paid to the county treasurer for the county in which the license
10 plate was purchased to be credited to the county highway fund
11 created pursuant to Section 1503 of Title 69 of the Oklahoma
12 Statutes;

13 100. Blue Star Mothers License Plate - such plates shall be
14 designed and issued to any person showing proof of membership in an
15 Oklahoma Chapter of Blue Star Mothers of America, Inc. The license
16 plates shall be designed in consultation with Blue Star Mothers of
17 America, Inc., Oklahoma Chapter One. Service Oklahoma shall be
18 authorized to enter into a licensing agreement with Blue Star
19 Mothers of America, Inc., Oklahoma Chapter One for any licensing
20 fees which may be required in order to use the Blue Star Mothers of
21 America logo or design. The licensing agreement shall provide for a
22 payment to Blue Star Mothers of America, Inc., Oklahoma Chapter One
23 of not more than Twenty Dollars (\$20.00) for each license plate
24 issued;

1 101. Oklahoma Golf License Plate - such plates shall be
2 designed and issued to any person wishing to demonstrate support for
3 the sport of golf in this state. The license plates shall be
4 designed in consultation with the South Central Section of the
5 Professional Golfers' Association of America and issued to any
6 person wishing to demonstrate support for the sport of golf in this
7 state. Service Oklahoma shall be authorized to enter into a
8 licensing agreement with the South Central Section of the
9 Professional Golfers' Association of America for any licensing fees
10 which may be required in order to use the organization's logo or
11 design. The licensing agreement shall provide for a payment to the
12 South Central Section of the Professional Golfers' Association of
13 America of not more than Twenty Dollars (\$20.00) for each license
14 plate issued;

15 102. Paramedic License Plate - such plates shall be designed
16 and issued to any person who is a paramedic. Such persons may apply
17 for a paramedic license plate for each vehicle with a rated carrying
18 capacity of one (1) ton or less or a motorcycle upon proof of a
19 paramedic license. The license plates shall be designed in
20 consultation with the Oklahoma State University-Oklahoma City
21 Paramedicine program and the Oklahoma Emergency Medical Technicians
22 Association. The letters "PM" shall be placed on the plate followed
23 by four random numbers, or such numbers as requested by such persons
24 applying for the plate. Twenty Dollars (\$20.00) of the fees

1 collected shall be deposited in the Emergency Medical Personnel
2 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63
3 of the Oklahoma Statutes. Subject to the provisions of subsection A
4 of this section, the Paramedic License Plate is hereby reauthorized
5 effective November 1, 2022;

6 103. National Defense Service Medal License Plate - such plates
7 shall be designed and issued to those persons who have received the
8 National Defense Service Medal and wish to demonstrate support for
9 the Oklahoma Department of Veterans Affairs. The license plates
10 shall be designed in consultation with the Oklahoma Department of
11 Veterans Affairs. Service Oklahoma shall be authorized to enter
12 into a licensing agreement with the Oklahoma Department of Veterans
13 Affairs for any licensing fees which may be required in order to use
14 the Department's logo or design. The licensing agreement shall
15 provide for a payment to the Oklahoma Department of Veterans Affairs
16 of not more than Twenty Dollars (\$20.00) for each license plate
17 issued;

18 104. University of Oklahoma RUF/NEKS License Plate - such
19 plates shall be designed and issued to any past or present member of
20 the University of Oklahoma RUF/NEKS upon providing proof of
21 membership in the organization as may be required by Service
22 Oklahoma. The license plates shall be designed in consultation with
23 the University of Oklahoma RUF/NEKS. Service Oklahoma shall be
24 authorized to enter into a licensing agreement with the University

1 of Oklahoma RUF/NEKS for any licensing fees which may be required in
2 order to use the organization's logo or design. The licensing
3 agreement shall provide for a payment to the Mike James RUF/NEKS
4 Memorial Scholarship of not more than Twenty Dollars (\$20.00) for
5 each license plate issued;

6 105. Tulsa Community College License Plate - such plates shall
7 be issued to persons wishing to support Tulsa Community College.
8 The plates shall be designed in consultation with Tulsa Community
9 College. Service Oklahoma shall be authorized to enter into a
10 licensing agreement with Tulsa Community College for any licensing
11 fees which may be required in order to use the organization's logo
12 or design. The licensing agreement shall provide for a payment to
13 Tulsa Community College of not more than Twenty Dollars (\$20.00) for
14 each license plate issued;

15 106. Street Kings Car Club License Plate - such plates shall be
16 designed and issued to any person wishing to demonstrate support for
17 the Street Kings Car Club in Guthrie. The license plates shall be
18 designed in consultation with the Street Kings Car Club. Service
19 Oklahoma shall be authorized to enter into a licensing agreement
20 with the Street Kings Car Club for any licensing fees which may be
21 required in order to use the organization's logo or design. The
22 licensing agreement shall provide for a payment to the Street Kings
23 Car Club of not more than Twenty Dollars (\$20.00) for each license
24 plate issued;

1 107. Epilepsy Foundation License Plate - such plates shall be
2 designed and issued to any person wishing to demonstrate support for
3 the Epilepsy Foundation. The license plates shall be designed in
4 consultation with the Epilepsy Foundation of Oklahoma. Service
5 Oklahoma shall be authorized to enter into licensing agreements with
6 the Epilepsy Foundation for any licensing fees which may be required
7 in order to use the organization's logo or design. The licensing
8 agreement shall provide for a payment to the Epilepsy Foundation of
9 not more than Twenty Dollars (\$20.00) for each license plate issued;

10 108. America First License Plate - such plates shall be
11 designed and issued to any person wishing to demonstrate support for
12 the proclamation of "America First". The license plates shall be
13 designed in consultation with Warriors for Freedom and the Honoring
14 America's Warriors Foundations. Service Oklahoma shall be
15 authorized to enter into licensing agreements with the Warriors for
16 Freedom and Honoring America's Warriors Foundations for any
17 licensing fees which may be required in order to use the
18 Foundations' logos or designs. The licensing agreements shall
19 provide for a payment to the Honoring America's Warriors Foundation
20 of not more than Ten Dollars (\$10.00) and a payment to the Warriors
21 for Freedom Foundation of not more than Ten Dollars (\$10.00) for
22 each license plate issued;

23 109. Diabetes Awareness License Plate - such plates shall be
24 designed and issued to any person wishing to provide financial

1 support for Diabetes Solutions of Oklahoma. The license plates
2 shall be designed in consultation with Diabetes Solutions of
3 Oklahoma. Service Oklahoma shall be authorized to enter into
4 licensing agreements with Diabetes Solutions of Oklahoma for any
5 licensing fees which may be required in order to use the Diabetes
6 Solutions of Oklahoma logos or designs. The licensing agreements
7 shall provide for a deposit to the Diabetes Awareness License Plate
8 Revolving Fund established in Section 1104.33 of this title;

9 110. Alliance of Mental Health Providers of Oklahoma License
10 Plate - such plates shall be designed and issued to any person
11 wishing to demonstrate support for the Alliance of Mental Health
12 Providers of Oklahoma. The license plates shall be designed in
13 consultation with the Alliance of Mental Health Providers of
14 Oklahoma. Service Oklahoma shall be authorized to enter into
15 licensing agreements with the Alliance of Mental Health Providers of
16 Oklahoma for any licensing fees which may be required in order to
17 use the organization's logo or design. The licensing agreement
18 shall provide for a payment to the Alliance of Mental Health
19 Providers of Oklahoma of not more than Twenty Dollars (\$20.00) for
20 each license plate issued;

21 111. Stillwater Public Schools License Plate - such plates
22 shall be designed and issued to any person wishing to demonstrate
23 support for the Stillwater School District. The license plates
24 shall be designed in consultation with the administration of the
25

1 Stillwater School District. Service Oklahoma shall be authorized to
2 enter into a licensing agreement with the Stillwater School District
3 for any licensing fees which may be required in order to use the
4 school district's logo or design. The licensing agreement shall
5 provide for a payment to the Stillwater School District of not more
6 than Twenty Dollars (\$20.00) for each license plate issued; and

7 112. Broken Arrow Public Schools License Plate - such plates
8 shall be designed and issued to any person wishing to demonstrate
9 support for Broken Arrow Public Schools. The license plates shall
10 be designed in consultation with the administration of Broken Arrow
11 Public Schools. Service Oklahoma shall be authorized to enter into
12 a licensing agreement with Broken Arrow Public Schools for any
13 licensing fee which may be required in order to use the school
14 district's logo or design. The licensing agreement shall provide
15 for payment to Broken Arrow Public Schools of not more than Twenty
16 Dollars (\$20.00) for each license plate issued.

17 C. The fee for such plates shall be Thirty-five Dollars
18 (\$35.00) per year of renewal and shall be in addition to all other
19 registration fees provided by the Oklahoma Vehicle License and
20 Registration Act. The fee shall be apportioned as follows through
21 June 30, 2023:

22 1. Twenty Dollars (\$20.00) per year of renewal or any other
23 amount as provided in this title of the fee shall be apportioned as
24

1 provided or deposited in a fund as specified within the paragraph
2 authorizing the special license plate;

3 2. Eight Dollars (\$8.00) per year of renewal of the fee shall
4 be deposited in the Tax Commission Reimbursement Fund to be used for
5 the administration of the Oklahoma Vehicle License and Registration
6 Act. Beginning January 1, 2023, Eight Dollars (\$8.00) per year of
7 renewal of the fee shall be deposited in the Service Oklahoma
8 Reimbursement Fund to be used for the administration of the Oklahoma
9 Vehicle License and Registration Act; and

10 3. Any remaining amounts of the fee shall be apportioned as
11 provided in Section 1104 of this title.

12 SECTION 2. REPEALER 47 O.S. 2021, Section 1104.13, is
13 hereby repealed.

14 SECTION 3. This act shall become effective November 1, 2025.
