## **Research Analysis**

The committee substitute for HB2138 provides that a motion or hearing for default judgement is not required if a defendant fails to a file a written response within 20 days after being served with a summons or petition. Failure to file a written response does not prevent an evidentiary hearing to determine the amount of damages to be awarded.

Additionally, the measure clarifies that any funds collected on a judgment during the pendency of an appeal that is subsequently overturned also bears interest.

## **Fiscal Analysis**

The CS to HB2138 sets forth that a motion or hearing for default judgement is not required in certain proceedings, and clarifies that certain funds that are collected but subsequently overturned shall also bear interest.
