Research Analysis

The policy recommendation for HB2138 provides that a motion or hearing for default judgement is not required if a defendant fails to a file a written response within 20 days after being served with a summons or petition. Failure to file a written response does not prevent an evidentiary hearing to determine the amount of damages to be awarded.

Additionally, the measure clarifies that any funds collected on a judgment during the pendency of an appeal that is subsequently overturned also bears interest.

Fiscal Analysis

The POLREC to HB2138 sets forth that a motion or hearing for default judgement is not required in certain proceedings, and clarifies that certain funds that are collected but subsequently overturned shall also bear interest. In its current form, this measure is not anticipated to have a material impact on state budget or appropriations.
