10 COMMITTEE SUBSTITUTE

11 An Act relating to administration of elections;  
12 amending 26 O.S. 2021, Section 3-130, which relates  
13 to post-election audits; clarifying language;  
14 requiring Secretary of the State Election Board to  
15 direct all counties to conduct post-election audits  
16 for specified elections; modifying definition;  
17 updating statutory language; and providing an  
18 effective date.

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. AMENDATORY 26 O.S. 2021, Section 3-130, is  
21 amended to read as follows:

22 Section 3-130. A. The Secretary of the State Election Board  
23 shall have the authority to direct the secretary of a county  
24 election board to conduct a post-election audit of election results  
25 for any election, for the purpose of maintaining the security of the  
26 election system by ensuring that voting devices and software used in  
27 a particular election correctly tabulated votes. The Secretary

1 shall direct the secretary of the county election board in each  
2 county to conduct a post-election audit following elections held on  
3 dates set forth in Sections 1-101, 1-102, 1-103, and 20-101 of this  
4 title.

5 B. The method, timing, and procedures for conducting a post-  
6 election audit shall be determined by the Secretary of the State  
7 Election Board.

8 C. The secretary of a county election board shall report the  
9 findings of a post-election audit to the Secretary of the State  
10 Election Board, and such report shall be available to the public.

11 D. The Secretary of the State Election Board may promulgate  
12 policies, rules, and procedures to implement the requirements of  
13 this section.

14 E. For the purposes of this title, a "post-election audit" ~~is~~  
15 ~~defined as~~ means a manual or electronic examination of a limited  
16 number of ballots by a secretary of a county election board or other  
17 authorized election officials following an election. A post-  
18 election audit shall be conducted only at the direction of the  
19 Secretary of the State Election Board and only subject to the  
20 Secretary's ~~previously promulgated~~ prescribed policies, rules, or  
21 procedures.

22 SECTION 2. This act shall become effective November 1, 2025.
