6 An Act relating to motor vehicles; defining terms;
7 making certain use of cellular telephones and
8 electronic devices unlawful on certain stretches of
9 road; creating penalty for violation; making certain
10 exceptions; authorizing municipalities to enact
11 certain ordinances; providing details for certain
ordinances; requiring the Department of Public Safety
not assess certain points for violations; prohibiting
confiscation of certain devices and information;
making certain exceptions; providing for
codification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified

16

in the Oklahoma Statutes as Section 11-901e of Title 47, unless

17

there is created a duplication in numbering, reads as follows:

A. For the purpose of this section:

19

1. "Cellular telephone" means an analog or digital wireless

20

telephone authorized by the Federal Communications Commission to

21

operate in the frequency bandwidth reserved for cellular telephones;

2. "Compose", "send", or "read" with respect to a text message

23

means the manual entry, sending, or retrieval of a text message to

24

communicate with any person or device;

1 3. "Electronic communication device" means an electronic device
2 that permits the user to manually transmit a communication of
3 written text by means other than through an oral transfer or wire
4 communication. This term does not include:

- 5 a. a device that is physically or electronically
6 integrated into a motor vehicle,
- 7 b. a voice-operated global positioning or navigation
8 system that is affixed to a motor vehicle,
- 9 c. a hands-free or voice-operated device that allows the
10 user to write, send, or read a text message without
11 the use of either hand except to activate, deactivate,
12 or initiate a feature or function,
- 13 d. an ignition interlock device that has been installed
14 on a motor vehicle, or
- 15 e. amateur radio use or operation; and

16 4. "Text message" includes a text-based message, instant
17 message, electronic message, photo, video, or electronic mail.

18 B. Where any portion of a road, street, or highway is a
19 properly marked school zone, as indicated with appropriate warning
20 signs placed in accordance with the latest edition of the Manual on
21 Uniform Traffic Control Devices, and a reduced speed limit is
22 properly posted that is in effect during certain times due to the
23 presence or potential presence of school children, or in a road
24 construction zone, and while a motor vehicle is in motion, it shall

1 be unlawful for any person to operate a motor vehicle on any street
2 or highway within this state while:

3 1. Using a hand-held electronic communication device or
4 cellular telephone to manually compose, send, or read an electronic
5 text message; or

6 2. Holding or using a hand-held cellular telephone.

7 C. Any person who violates the provisions of subsection B of
8 this section shall, upon conviction, be punished by a fine of not
9 more than One Hundred Dollars (\$100.00).

10 D. The provisions of subsection B of this section shall not
11 apply if the person is using the cellular telephone or electronic
12 communication device:

13 1. In conjunction with hands-free or voice-operated technology;
14 or

15 2. For the sole purpose of communicating with any of the
16 following regarding an imminent emergency situation:

- 17 a. an emergency response operator,
- 18 b. a hospital, physician's office, or health clinic,
- 19 c. a provider of ambulance services,
- 20 d. a provider of firefighting services, or
- 21 e. a law enforcement agency.

22 E. Municipalities may enact and municipal police officers may
23 enforce ordinances prohibiting and penalizing conduct under the
24 provisions of this section. The provisions of such ordinances shall

1 be the same as provided for in this section; the enforcement
2 provisions of those ordinances shall not be more stringent than
3 those of this section; and the total fine and court costs for
4 municipal ordinance violations shall not exceed One Hundred Dollars
5 (\$100.00).

6 F. The Department of Public Safety shall not record or assess
7 points for violations of this section on any license holder's
8 traffic record maintained by Service Oklahoma.

9 G. A law enforcement officer shall not, without the consent of
10 the person:

11 1. Confiscate a cellular telephone or electronic communication
12 device for the purpose of determining compliance with this section;

13 2. Confiscate a cellular telephone or electronic communication
14 device and retain it as evidence pending trial for a violation of
15 this section; or

16 3. Extract or otherwise download information from a cellular
17 telephone or electronic communication device for a violation of this
18 section unless:

19 a. the law enforcement officer has probable cause to
20 believe that the cellular telephone or electronic
21 communication device has been used in the commission
22 of a crime,

23 b. the information is extracted or otherwise downloaded
24 under a valid search warrant, or

c. otherwise authorized by law.

SECTION 2. This act shall become effective November 1, 2025.
