BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 47 O.S. 2021, Section 1-168, is
amended to read as follows:

Section 1-168. State.

A state, territory or possession of the United States, the
District of Columbia, the Commonwealth of Puerto Rico or a province
or territory of the Dominion of Canada.

SECTION 2. AMENDATORY 47 O.S. 2021, Section 2-116, as
amended by Section 34, Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2024,
Section 2-116), is amended to read as follows:

1 Section 2-116. A. Whenever the Department of Public Safety or
2 the Oklahoma Insurance Department is authorized or required to give
3 any notice under this act or other law regulating the operation of
4 vehicles, unless a different method of giving such notice is
5 otherwise expressly prescribed, such notice shall be given either by
6 personal delivery thereof to the person to be so notified or by
7 deposit in the United States mail of such notice in an envelope with
8 first class postage prepaid, addressed to such person at the address
9 as shown by the records of the Department. The giving of notice by
10 mail is complete upon the expiration of ten (10) days after such
11 deposit of said notice. Proof of the giving of notice in either
12 such manner may be made by the certificate of any officer or
13 employee of the Department or affidavit of any person over eighteen
14 (18) years of age, naming the person to whom such notice was given
15 and specifying the time, place and manner of the giving thereof.
16 Failure of the person to receive notice because of failure to notify
17 the Department of a change in his or her current mailing address, as
18 required by Section 6-116 of this title, shall not be sufficient
19 grounds for the person to protest the notice.

20 B. Whenever Service Oklahoma is authorized or required to give
21 any notice under this title, unless a different method of giving
22 such notice is otherwise expressly prescribed, such notice shall be
23 given by mailing such notice by United States mail, in an envelope
24 with first class postage prepaid, addressed to such person at the

1 address as shown by the records of Service Oklahoma. The giving of
2 notice by mail is complete upon the expiration of ten (10) days
3 after such mailing. Service Oklahoma may show proof of such mailing
4 by certificate of any officer or employee of Service Oklahoma or
5 affidavit of any person over eighteen (18) years of age, naming the
6 person to whom such notice was given and specifying the time, place,
7 and manner of the giving thereof. Failure of the person to receive
8 notice because of failure to notify Service Oklahoma of a change in
9 his or her current mailing address, as required by Section 6-116 of
10 this title, shall not be sufficient grounds for the person to
11 protest the notice.

12 SECTION 3. AMENDATORY 47 O.S. 2021, Section 6-101, as
13 last amended by Section 34, Chapter 452, O.S.L. 2024 (47 O.S. Supp.
14 2024, Section 6-101), is amended to read as follows:

15 Section 6-101. A. No person, except those hereinafter
16 expressly exempted in Sections 6-102 and 6-102.1 of this title,
17 shall operate any motor vehicle upon a highway in this state unless
18 the person has a valid Oklahoma driver license for the class of
19 vehicle being operated under the provisions of this title. No
20 person shall be permitted to possess more than one valid license at
21 any time, except as provided in paragraph 4 of subsection F of this
22 section.

23 B. 1. No person shall operate a Class A commercial motor
24 vehicle unless the person is eighteen (18) years of age or older and

1 holds a valid Class A commercial license, except as provided in
2 paragraph 5 of this subsection and subsection F of this section.
3 Any person holding a valid Class A commercial license shall be
4 permitted to operate motor vehicles in Classes A, B, C and D, except
5 as provided for in paragraph 4 of this subsection.

6 2. No person shall operate a Class B commercial motor vehicle
7 unless the person is eighteen (18) years of age or older and holds a
8 valid Class B commercial license, except as provided in paragraph 5
9 of subsection F of this section. Any person holding a valid Class B
10 commercial license shall be permitted to operate motor vehicles in
11 Classes B, C and D, except as provided for in paragraph 4 of this
12 subsection.

13 3. No person shall operate a Class C commercial motor vehicle
14 unless the person is eighteen (18) years of age or older and holds a
15 valid Class C commercial license, except as provided in subsection F
16 of this section. Any person holding a valid Class C commercial
17 license shall be permitted to operate motor vehicles in Classes C
18 and D, except as provided for in paragraph 4 of this subsection.

19 4. No person under twenty-one (21) years of age shall be
20 licensed to operate any motor vehicle which is required to be
21 placarded for hazardous materials pursuant to 49 C.F.R., Part 172,
22 subpart F, except as provided in subsection F of this section;
23 provided, a person eighteen (18) years of age or older may be
24 licensed to operate a farm vehicle which is required to be placarded

1 for hazardous materials pursuant to 49 C.F.R., Part 172, subpart F,
2 except as provided in subsection F of this section.

3 5. A person at least seventeen (17) years of age who
4 successfully completes all examinations required by law may be
5 issued by Service Oklahoma:

6 a. a restricted Class A commercial license which shall
7 grant to the licensee the privilege to operate a Class
8 A or Class B commercial motor vehicle for harvest
9 purposes or a Class D motor vehicle, or

10 b. a restricted Class B commercial license which shall
11 grant to the licensee the privilege to operate a Class
12 B commercial motor vehicle for harvest purposes or a
13 Class D motor vehicle.

14 6. No person shall operate a Class D motor vehicle unless the
15 person is sixteen (16) years of age or older and holds a valid Class
16 D license, except as provided for in Section 6-102 or 6-105 of this
17 title. Any person holding a valid Class D license shall be
18 permitted to operate motor vehicles in Class D only.

19 C. Any person issued a driver license pursuant to this section
20 may exercise the privilege thereby granted upon all streets and
21 highways in this state.

22 D. No person shall operate a motorcycle or motor-driven cycle
23 without having a valid Class A, B, C or D license with a motorcycle
24 endorsement. Except as otherwise provided by law, any new applicant

1 for an original driver license shall be required to successfully
2 complete a written examination, vision examination and driving
3 examination for a motorcycle as prescribed by the Department of
4 Public Safety, in conjunction with Service Oklahoma, and a certified
5 state-approved motorcycle basic rider course approved by the
6 Department, in conjunction with Service Oklahoma, if the applicant
7 is seventeen (17) years of age or younger to be eligible for a
8 motorcycle endorsement thereon. The written examination and driving
9 examination for a motorcycle shall be waived by Service Oklahoma
10 upon verification that the person has successfully completed a
11 certified Motorcycle Safety Foundation rider course approved by the
12 Department, in conjunction with Service Oklahoma.

13 E. Except as otherwise provided by law, any person who lawfully
14 possesses a valid Oklahoma driver license which is eligible for
15 renewal shall be required to successfully complete a written
16 examination, vision examination and driving examination for a
17 motorcycle as prescribed by the Department, in conjunction with
18 Service Oklahoma, and a certified state-approved motorcycle basic
19 rider course approved by the Department, in conjunction with Service
20 Oklahoma, if the person is seventeen (17) years of age or younger to
21 be eligible for a motorcycle endorsement. The written examination
22 and driving examination for a motorcycle shall be waived by Service
23 Oklahoma upon verification that the person has successfully

1 completed a certified Motorcycle Safety Foundation rider course
2 approved by the Department, in conjunction with Service Oklahoma.

3 F. 1. Any person eighteen (18) years of age or older may apply
4 for a restricted Class A, B or C commercial learner permit. Service
5 Oklahoma, after the applicant has passed all parts of the
6 examination for a Class D license and has successfully passed all
7 parts of the examination for a Class A, B or C commercial license
8 other than the driving examination, may issue to the applicant a
9 commercial learner permit which shall entitle the person having
10 immediate lawful possession of the commercial learner permit and a
11 valid Oklahoma driver license or provisional driver license pursuant
12 to Section 6-212 of this title to operate a Class A, B or C
13 commercial motor vehicle upon the public highways solely for the
14 purpose of behind-the-wheel training in accordance with rules
15 promulgated by the Department.

16 2. This commercial learner permit shall be issued for a period
17 as provided in Section 6-115 of this title of one (1) year;
18 provided, such commercial learner permit may be suspended, revoked,
19 canceled, denied or disqualified at the discretion of the
20 Department, with notice to Service Oklahoma, for violation of the
21 restrictions, for failing to give the required or correct
22 information on the application or for violation of any traffic laws
23 of this state pertaining to the operation of a motor vehicle.
24 Except as otherwise provided, the lawful possessor of a commercial

1 learner permit who has been issued a commercial learner permit for a
2 minimum of fourteen (14) days may have the restriction requiring an
3 accompanying driver removed by satisfactorily completing a driver's
4 examination; provided, the removal of a restriction shall not
5 authorize the operation of a Class A, B or C commercial motor
6 vehicle if such operation is otherwise prohibited by law.

7 3. No person shall apply for and Service Oklahoma shall not
8 issue an original Class A, B or C driver license until the person
9 has been issued a commercial learner permit and held the permit for
10 at least fourteen (14) days. Any person who currently holds a Class
11 B or C license and who wishes to apply for another class of
12 commercial driver license shall be required to apply for a
13 commercial learner permit and to hold the permit for at least
14 fourteen (14) days before applying for the Class A or B license, as
15 applicable. Any person who currently holds a Class A, B or C
16 license and who wishes to add an endorsement or remove a restriction
17 for which a skills examination is required shall be required to
18 apply for a commercial learner permit and to hold the permit for at
19 least fourteen (14) days before applying for the endorsement.

20 4. A commercial learner permit shall be issued by Service
21 Oklahoma as a separate and unique document which shall be valid only
22 in conjunction with a valid Oklahoma driver license or provisional
23 driver license pursuant to Section 6-212 of this title, both of
24 which shall be in the possession of the person to whom they have

1 | been issued whenever that person is operating a commercial motor
2 | vehicle as provided in this subsection.

3 | 5. After one renewal of a commercial learner permit, as
4 | provided in paragraph 2 of this subsection, a commercial permit
5 | shall not be renewed again. Any person who has held a commercial
6 | learner permit for the initial issuance period and one renewal
7 | period shall not be eligible for and Service Oklahoma shall not
8 | issue another renewal of the permit; provided, the person may
9 | reapply for a new commercial learner permit, as provided for in this
10 | subsection.

11 | G. 1. For purposes of this title:

12 | a. "REAL ID Compliant Driver License" or "Identification
13 | Card" means a driver license or identification card
14 | issued by this state that has been certified by the
15 | United States Department of Homeland Security (USDHS)
16 | as compliant with the requirements of the REAL ID Act
17 | of 2005, Public Law No. 109-13. A REAL ID Compliant
18 | Driver License or Identification Card and the process
19 | through which it is issued incorporate a variety of
20 | security measures designed to protect the integrity
21 | and trustworthiness of the license or card. A REAL ID
22 | Compliant Driver License or Identification Card will
23 | be clearly marked on the face indicating that it is a
24 | compliant document, and

1 b. "REAL ID Noncompliant Driver License" or
2 "Identification Card" means a driver license or
3 identification card issued by this state that has not
4 been certified by the United States Department of
5 Homeland Security (USDHS) as being compliant with the
6 requirements of the REAL ID Act of 2005. A REAL ID
7 Noncompliant Driver License or Identification Card
8 will be clearly marked on the face indicating that it
9 is not compliant with the federal REAL ID Act of 2005
10 and is not acceptable for official federal purposes.
11 The driver license or identification card will have a
12 unique design or color indicator that clearly
13 distinguishes it from a compliant license or card.

14 2. Original Driver License and Identification Card Issuance:

- 15 a. Application for an original REAL ID Compliant or REAL
16 ID Noncompliant Driver License or Identification Card
17 shall be made to Service Oklahoma or a licensed
18 operator provided such licensed operator is authorized
19 to process application for REAL ID Compliant Driver
20 Licenses and Identification Cards. Application for a
21 REAL ID Noncompliant Driver License or Identification
22 Card shall be made to Service Oklahoma.
- 23 b. Service Oklahoma employees or authorized licensed
24 operators shall perform all document recognition and

1 other requirements needed for approval of an original
2 REAL ID Compliant Driver License or Identification
3 Card application. Service Oklahoma employees shall
4 perform all document recognition and other
5 requirements needed for approval of a REAL ID
6 Noncompliant Driver License or Identification Card
7 application.

8 c. Upon approval of an original REAL ID Compliant or REAL
9 ID Noncompliant Driver License or Identification Card
10 application, the applicant may take the approved
11 application document to a licensed operator to receive
12 a temporary driver license or identification card.

13 d. The licensed operator shall process the approved REAL
14 ID Compliant or REAL ID Noncompliant Driver License or
15 Identification Card application and upon payment shall
16 provide the applicant a temporary driver license or
17 identification card. A temporary driver license or
18 identification card shall afford the holder the
19 privileges otherwise granted by the specific class of
20 driver license or identification card for the period
21 of time listed on the temporary driver license or
22 identification card or the period of time prior to the
23 applicant receiving a REAL ID Compliant or REAL ID

1 Noncompliant Driver License or Identification Card,

3 3. REAL ID Compliant Driver License and Identification Card

20 REAL ID Compliant or REAL ID Noncompliant Driver Licenses or
21 Identification Cards shall be retained by the licensed operator
22 pursuant to subsection E of Section 1141.1 of this title.

23 F. The Oklahoma Tax Commission is hereby authorized to
24 reimburse, from funds available to that agency, each licensed

1 operator issuing an identification card to a person sixty-five (65)
2 years of age or older, an amount not to exceed One Dollar (\$1.00)
3 for each card or driver license so issued through June 30, 2023.
4 The Tax Commission shall develop procedures for claims for
5 reimbursement.

6 G. Notwithstanding any other provision of law, when a person
7 makes application for a new identification card, or makes
8 application to renew an identification card, and the person has been
9 convicted of, or received a deferred judgment for, any offense
10 required to register pursuant to the Sex Offenders Registration Act,
11 the identification card shall be valid for a period of one (1) year
12 from the month of issuance, but may be renewed yearly during the
13 time the person is subject to registration on the Sex Offender
14 Registry. The cost for such identification card shall be the same
15 as for other identification cards and renewals.

16 H. Nothing in this section requires or authorizes the
17 Department of Public Safety to issue a REAL ID Noncompliant
18 Identification Card without the documentation required by the
19 provisions of paragraph 9 of subsection A of Section 6-103 of this
20 title.

21 SECTION 5. AMENDATORY 47 O.S. 2021, Section 6-111, as
22 last amended by Section 46, Chapter 452, O.S.L. 2024 (47 O.S. Supp.

1 Section 6-111. A. 1. Service Oklahoma shall, upon payment of
2 the required fee, issue to every applicant qualifying therefor a
3 Class A, B, C or D driver license or identification card as applied
4 for, which license or card shall bear thereon a distinguishing
5 alphanumeric identification assigned to the licensee or cardholder,
6 date of issuance and date of expiration of the license or card, the
7 full legal name, signature or computerized signature, date of birth,
8 residence address, unless specified as an exception in the Code of
9 Federal Regulations per 6 C.F.R., Section 37.17, sex, a computerized
10 ~~color~~ image of the licensee or cardholder taken in accordance with
11 Service Oklahoma rules and security features as determined by
12 Service Oklahoma. The image shall depict a full front unobstructed
13 view of the entire face of the licensee or cardholder; provided, a
14 commercial learner permit shall not bear the image of the licensee.
15 ~~When any person is issued both a driver license and an~~
16 ~~identification card, Service Oklahoma shall ensure the information~~
17 ~~on both the license and the card are the same, unless otherwise~~
18 ~~provided by law.~~

19 2. A driver license or identification card issued by Service
20 Oklahoma on or after March 1, 2004, shall bear thereon the county of
21 residence of the licensee or cardholder.

22 3. Service Oklahoma may cancel the distinguishing number, when
23 that distinguishing number is another person's Social Security
24 number, assign a new distinguishing alphanumeric identification, and

1 issue a new license or identification card without charge to the
2 licensee or cardholder.

3 4. Service Oklahoma may promulgate rules for inclusion of the
4 height and a brief description of the licensee or cardholder on the
5 face of the card or license identifying the licensee or cardholder
6 as deaf or hard-of-hearing.

7 5. It is unlawful for any person to apply, adhere, or otherwise
8 attach to a driver license or identification card any decal,
9 sticker, label, or other attachment. Any law enforcement officer is
10 authorized to remove and dispose of any unlawful decal, sticker,
11 label, or other attachment from the driver license of a person. The
12 law enforcement officer, the employing agency of the officer,
13 Service Oklahoma, and the State of Oklahoma shall be immune from any
14 liability for any loss suffered by the licensee, cardholder, or the
15 owner of the decal, sticker, label, or other attachment caused by
16 the removal and destruction of the decal, sticker, label, or other
17 attachment. Nothing in this section shall prohibit Service Oklahoma
18 from adopting, applying, adhering, or otherwise attaching decals,
19 stickers, labels, or other attachments to a driver license or
20 identification card.

21 6. Service Oklahoma may develop by rule a procedure which
22 complies with the provisions of subsection G of Section 6-101 of
23 this title whereby a person may apply for a renewal or replacement
24 Oklahoma Class D license or Oklahoma identification card.

1 B. 1. Service Oklahoma may issue or authorize the issuance of
2 a temporary permit or license to an applicant for a driver license
3 permitting such applicant to operate a motor vehicle while Service
4 Oklahoma is completing its investigation and determination of all
5 facts relative to such applicant's privilege to receive a license,
6 or while a permanent driver license is being produced and delivered
7 to the applicant. Such permit or license must be in the immediate
8 possession of the driver while operating a motor vehicle, and it
9 shall be invalid when the applicant's permanent driver license has
10 been issued and delivered or for good cause has been refused.

11 2. Service Oklahoma may issue or authorize the issuance of a
12 temporary identification card to an applicant, permitting the holder
13 the privileges otherwise granted by identification cards, while a
14 permanent driver license is being provided and delivered to the
15 applicant. Such card shall be invalid when the applicant's
16 permanent identification card has been issued and delivered, or for
17 good cause has been refused.

18 C. 1. Service Oklahoma may issue a restricted commercial
19 driver license to drivers eighteen (18) years of age or older for
20 any of the following specific farm-related service industries:

- 21 a. farm retail outlets and suppliers,
- 22 b. agri-chemical businesses,
- 23 c. custom harvesters, and
- 24 d. livestock feeders.

1 The applicant shall have held a valid driver license for at
2 least one year. Applicants with more than two (2) years of driving
3 experience shall have a good driving record for the most recent two
4 (2) year period and shall meet all the requirements for a commercial
5 driver license. The restricted commercial driver license shall not
6 exceed the maximum total days that federal law allows. Applicants
7 for the restricted commercial driver license shall be exempt from
8 the knowledge and skills test. Application of the restricted
9 commercial driver license does not have to be used in consecutive
10 days. The use of the permit shall be declared at application.

11 2. A "good driving record" as used in this subsection shall
12 mean an applicant:

- 13 a. has not had more than one license,
- 14 b. has not had any license suspended, revoked, or
15 canceled,
- 16 c. has not had any conviction for any type of
17 disqualifying offenses or serious traffic violations,

- 19 d. has not had any conviction for a violation of state or
20 local law relating to motor vehicle traffic control,
21 other than a parking violation, arising in connection

1 3. The restricted commercial driver license shall not be valid
2 for operators of commercial motor vehicles beyond one hundred fifty
3 (150) miles from the place of business or the farm currently being

6 required to be placarded shall be limited to the following:

7 a. diesel fuel in quantities of one thousand (1,000)

19 federal regulations, state laws and Service Oklahoma rules. The
20 issued license shall be valid until the expiration of the visa for
21 the non-domiciled worker. Service Oklahoma may promulgate rules for
22 the implementation of the process to carry out the provisions of
23 this section.

1 E. 1. Service Oklahoma shall develop a procedure whereby a
2 person applying for an original, renewal or replacement Class A, B,
3 C or D driver license or identification card who is required to
4 register as a convicted sex offender with the Department of
5 Corrections pursuant to the provisions of the Sex Offenders
6 Registration Act and who the Department of Corrections designates as
7 an aggravated or habitual offender pursuant to subsection J of
8 Section 584 of Title 57 of the Oklahoma Statutes shall be issued a
9 license or card bearing the words "Sex Offender".

10 2. Service Oklahoma shall notify every person subject to
11 registration under the provisions of Section 1-101 et seq. of this
12 title who holds a current Class A, B, C or D driver license or
13 identification card that such person is required to surrender the
14 license or card to Service Oklahoma within one hundred eighty (180)
15 days from the date of the notice.

16 3. Upon surrendering the license or card for the reason set
17 forth in this subsection, application may be made with Service
18 Oklahoma for a replacement license or card bearing the words "Sex
19 Offender".

20 4. Failure to comply with the requirements set forth in such
21 notice shall result in cancellation of the person's license or card.
22 Such cancellation shall be in effect for one (1) year, after which
23 time the person may make application with Service Oklahoma for a new
24 license or card bearing the words "Sex Offender". Continued use of

1 a canceled license or card shall constitute a misdemeanor and shall,

15 G. A person subject to an order for the installation of an
16 ignition interlock device shall be required by Service Oklahoma to
17 submit his or her driver license for a replacement. The replacement

20 the order requiring the ignition interlock device. The replacement
21 license shall be subject to the same expiration and renewal
22 procedures provided by law. Upon completion of the requirements for

1 H. Service Oklahoma shall develop a procedure whereby a person
2 applying for an original, renewal or replacement Class D driver
3 license who has been granted modified driving privileges under this
4 title shall be issued a Class D driver license which identifies the
5 license as a modified license.

- 15 2. The expiration date on the valid documentation authorizing

20 date of an initial license shall be no more than either four (4)
21 years or eight (8) years from the last day of the month of issuance

1 C. Except as otherwise provided in this section, the expiration
2 date of a renewal license shall be:

5 expiration of the expiring license or either four (4) or eight (8)
6 years from the last day of the birth month of the licensee
7 immediately preceding the expiration date of the expiring license,

17 required to register pursuant to the Sex Offenders Registration Act,
18 the driver license shall be valid for a period of one (1) year from
19 the month of issuance, but may be renewed yearly during the time the

21 any other provision of law, the cost for such license shall be the

- 12 a. cannot walk two hundred (200) feet without stopping to
13 rest,
 - 14 b. cannot walk without the use of or assistance from a
15 brace, cane, crutch, another person, prosthetic
16 device, wheelchair or other assistance device,
 - 17 c. is restricted to such an extent that the person's
18 forced (respiratory) expiratory volume for one (1)
19 second, when measured by spirometry, is less than one
20 (1) liter, or the arterial oxygen tension is less than
21 sixty (60) mm/hg on room air at rest,
 - 22 d. must use portable oxygen,
- 23
24

1 e. has functional limitations which are classified in
2 severity as Class III or Class IV according to
3 standards set by the American Heart Association,

4 f. is severely limited in the person's ability to walk
5 due to an arthritic, neurological or orthopedic
6 condition, or from complications due to pregnancy,

7 g. is certified legally blind, or is missing one or more
8 limbs.

9 B. Service Oklahoma shall issue a detachable placard indicating
10 physical disability to any person who submits an application on a
11 form furnished by Service Oklahoma and certified by a physician,
12 physician assistant, or advanced registered nurse practitioner
13 attesting that the applicant has a physical disability. The
14 attestation of the physician, physician assistant, or advanced
15 registered nurse practitioner shall denote "temporary" as the type
16 of placard requested and shall indicate an expiration date which the
17 physician, physician assistant, or advanced registered nurse
18 practitioner estimates to be the date of termination of such
19 physical disability; however, if the physician, physician assistant,
20 or advanced registered nurse practitioner certifies that the
21 physical disability is permanent, the physician, physician
22 assistant, or advanced registered nurse practitioner shall denote
23 "five-year" as the type of placard requested.

1 C. Any placard issued by Service Oklahoma shall remain valid
2 until:

3 1. The placard expires;

4 2. The person to whom the placard was issued requests a
5 replacement placard; or

6 3. The placard is no longer needed by the person to whom the
7 placard was issued for the disability for which the placard was
8 originally issued, whereupon such placard shall be returned to
9 Service Oklahoma.

10 D. 1. A five-year placard shall expire five (5) years from the
11 last day of the month in which the placard was issued. Upon the
12 expiration of a five-year placard, the person to whom such placard
13 was issued may obtain a subsequent placard by reapplying to Service
14 Oklahoma, in the same manner as provided in subsection B of this
15 section.

16 2. A temporary placard shall indicate the expiration date which
17 the physician, physician assistant, or advanced registered nurse
18 practitioner certifying the physical disability estimates to be the
19 date of termination of such physical disability, which shall not be
20 later than six (6) months from the date of issuance and upon which
21 date such placard shall expire and shall be returned to Service
22 Oklahoma; provided, however, nothing in this paragraph shall be
23 construed to prevent the holder from applying for another placard,
24 as provided for in this section.

1 3. In the event that a placard is lost or destroyed, the person
2 to whom such placard was issued may apply in writing to Service
3 Oklahoma for a replacement placard, which Service Oklahoma shall
4 issue with the same expiration date as the original placard.

5 4. On and after January 1, 1998, all placards issued prior to
6 October 31, 1990, shall expire on the last day of the month in which
7 the placard was issued, and the person to whom such placard was
8 issued may follow the procedure provided for in subsection B of this
9 section to obtain a second or subsequent placard.

10 5. On and after January 1, 2000, all placards issued between
11 November 1, 1990, and June 30, 1995, shall expire on the last day of
12 the birth month of the person to whom the placard was issued, and
13 the person to whom such placard was issued may follow the procedure
14 provided for in subsection B of this section to obtain a second or
15 subsequent placard.

16 E. A physician, physician assistant, or advanced registered
17 nurse practitioner may sign an application certifying that a person
18 has a physical disability, as provided in subsection B of this
19 section, only if care and treatment of the illness, disease, injury
20 or condition causing the physical disability of such person falls
21 within the authorized scope of practice of the physician or
22 physician assistant, or advanced registered nurse practitioner.

23 F. Service Oklahoma shall have the power to formulate, adopt
24 and promulgate rules as may be necessary to implement and administer

1 the provisions of this section, including, but not limited to,
2 prescribing the manner in which the placard is to be displayed on a
3 motor vehicle.

4 G. All applications and information submitted in conjunction
5 with an application for a placard are confidential and Service
6 Oklahoma shall not be required to release to any person,
7 applications, or placard information, in whole or in part and in any
8 format, except as otherwise provided for in this subsection.

9 Information contained on the application, including personally
10 identifiable information, shall only be released for the following
11 purposes:

12 1. For use by a law enforcement agency in carrying out its
13 functions, specifically including parking enforcement; and

14 2. For use in connection with any civil, criminal, or

16 agency.

17 H. Nothing in this section shall prohibit the issuance of a

- 6 23. The District Attorneys Council and Oklahoma district
7 attorneys, provided adequate funding exists;
- 8 24. The Oklahoma Boll Weevil Eradication Organization;
- 9 25. The Oklahoma Horse Racing Commission;
- 10 26. The Council on Law Enforcement Education and Training; ~~and~~
- 11 27. The Office of the Attorney General; and
- 12 28. Service Oklahoma.

13 B. 1. The Oklahoma School for the Deaf at Sulphur, the
14 Oklahoma School for the Blind at Muskogee, and any state institution
15 of higher education may purchase, own, or keep if now owned, or
16 acquire by lease or gift, and use and maintain such station wagons,
17 automobiles, trucks, or buses as are reasonably necessary for the
18 implementation of the educational programs of said institutions.

19 2. No bus operated, owned, or used by such educational

23 subsection, "screening test" means the use of devices, equipment,

3 ~~F.~~ D. The Board may set rules and charge appropriate fees for
4 operations incidental to its required duties and responsibilities.

5 ~~G.~~ E. There is hereby created in the State Treasury a revolving
6 fund for the Board of Tests for Alcohol and Drug Influence to be
7 designated the "Board of Tests for Alcohol and Drug Influence
8 Revolving Fund". The fund shall be a continuing fund, not subject
9 to fiscal year limitations, and shall consist of monies received
10 pursuant to the provisions of subsection ~~F~~ D of this section and any
11 funds previously deposited in the Board of Tests for Alcohol and
12 Drug Influence Revolving Fund. All monies accruing to the credit of
13 the fund are hereby appropriated and may be budgeted and expended by
14 the Board of Tests for Alcohol and Drug Influence for operating
15 expenses of the Board. Expenditures from the funds shall be made
16 upon warrants issued by the State Treasurer against claims filed as

14 licensed operator pursuant to the Oklahoma Vehicle License and
15 Registration Act, shall be retained by the licensed operator
16 pursuant to subsection E of Section 1141.1 of this title.

17 1. This section shall apply to subsection H of Section 1105,
18 Section 1115, 1132, 1132.1, 1132.4, 1135.1, 1135.2, 1135.3,
19 subsection H of Section 1140, and Section 1151 of this title, and
20 Section 2103 of Title 68 of the Oklahoma Statutes, beginning July 1,
21 2023. Except that the five-dollar fee for the license plate issued
22 pursuant to paragraph 31 of subsection B of Section 1135.2 of this
23 title shall be retained by the licensed operator.

8 Section 1105A. A. On or before July 1, 2023, Service Oklahoma
9 shall implement a program which will permit the electronic filing,
10 storage, and delivery of motor vehicle certificates of title and
11 allow a lienholder to perfect, assign and release a lien on a motor
12 vehicle in lieu of submission and maintenance of paper documents as
13 otherwise provided in the provisions of Section 1101 et seq. of this
14 title. Service Oklahoma may:

15 1. Enter into a competitive contract with a qualified third-
16 party service provider (System Developer), subject to the provisions
17 of the Oklahoma Central Purchasing Act, Section 85.1 et seq. of
18 Title 74 of the Oklahoma Statutes;

19 2. Act as the service provider; or

20 3. Authorize proprietary provider systems by Oklahoma financial
21 institutions,
22 to provide necessary hardware, software and services facilitating
23 the interconnection between licensed operators and electronic title
24 service providers described in subsection B of this section for a

1 certificate of title and for filing or releasing a lien pursuant to
2 the procedures prescribed by Service Oklahoma. The provisions of
3 this section shall apply to certificates of title issued and liens
4 filed after June 30, 2022. Service Oklahoma shall promulgate rules
5 to implement the provisions of this section.

6 B. The program authorized under subsection A of this section
7 shall include, but not be limited to, procedures:

8 1. For the delivery of a certificate of title, on a paper
9 document or in an electronic format, to the secured party having the
10 primary perfected security interest in a vehicle in lieu of delivery
11 to the record owner, notwithstanding the provisions of Section 1101
12 et seq. of this title. When there is no security interest, lien, or
13 other encumbrance on the vehicle, delivery of a certificate of

16 liens and lien satisfactions is used, a certificate of title need
17 not be issued or printed until the last lien is satisfied and a
18 clear certificate of title is issued to the owner of the vehicle at

20 2. Establishing qualifications for third-party electronic title
21 service providers offering electronic lien services. The vendor
22 selected in subsection A of this section shall not be considered an
23 electronic title service provider and shall not operate or own an
24 electronic title service provider;

1 3. Establishing reasonable fees, if necessary, to be charged by
2 service providers or contractors for the establishment, maintenance
3 and operation of the electronic lien title program;

4 4. Providing access to the electronic certificate of title
5 records including liens on record, for licensed motor vehicle
6 dealers and lienholders who participate in the program
7 notwithstanding the provisions of Section 1109 of this title;

8 5. Allowing licensed operators to participate in the electronic
9 lien title program. Participating licensed operators shall receive
10 all fees provided by the Oklahoma Vehicle License and Registration
11 Act unless otherwise provided in Section 1132A of this title; and

12 6. For the acceptance and use of electronic or digital
13 signatures.

14 C. As used in this section and Section 1101 et seq. of this
15 title:

16 1. "Deliver" or "delivery" means, with respect to a certificate
17 of title or lien, either the physical delivery of a paper document
18 or the electronic delivery of a document in an electronic format;

19 2. "Electronic format" means an electronic or digital format or
20 medium of any document, record or other information; and

21 3. "Possess" or "possession" means, with respect to a
22 certificate of title or lien, to hold or otherwise exercise control
23 over a document which is in either a physical or electronic format.

1 D. Any documents created, stored or delivered under the
2 electronic lien title program as provided in this section shall be
3 presumed valid including any signatures which are generated
4 electronically or contained on a scanned copy. A certified copy of

7 administrative proceeding in this state as evidence of the existence

4 I. Submission and maintenance of paper documents as otherwise

11 determines at any time that an applicant for a certificate of title
12 of a vehicle is not entitled thereto, it may refuse to issue such
13 certificate or to register such vehicle.

14 2. a. If Service Oklahoma may for a similar reason, after
15 determines that a previously issued certificate of
16 title or registration was issued in contradiction of
17 any statutory requirement or that the applicant was
18 not entitled to such certificate or registration, it
19 may revoke such certificate of title or registration
20 by sending a notice of revocation hearing. Said
21 notice shall be mailed to the last known address
22 reflected on the motor vehicle records of Service

23 a commercial motor carrier whose ability to operate has been
24 terminated or denied by a federal agency.

1 2. Service Oklahoma may revoke the registration, certificate of
2 title, and license plate of a commercial motor vehicle if the
3 vehicle has been assigned to be operated by a commercial motor
4 carrier whose ability to operate has been terminated or denied by a
5 federal agency.

6 C. The Corporation Commission may revoke, suspend or deny
7 registration of and/or issuance of license plates for a commercial
8 motor vehicle licensed pursuant to the jurisdiction of the

10 terminated or denied by a state or federal agency.

14 the amount apportioned for the fiscal year ending on

21 of paragraph 1 of this subsection shall be transmitted to the
22 various counties on the basis of a formula to be developed by the
23 Department of Transportation. Such formula shall be similar to that

1 but also taking into consideration the effect of terrain and traffic
2 volume as related to county road improvement and maintenance costs.

- 18 d. for the year beginning July 1, 2015, through the year
19 ending on June 30, 2019, eighty-three one-hundredths
20 percent (0.83%), but in no event shall the amount
21 apportioned in any fiscal year pursuant to this
22 subparagraph exceed the total amount apportioned for
23 the fiscal year ending on June 30, 2015. Any amounts

24

1 in excess of such limitation shall be placed to the
2 credit of the General Revenue Fund, and
3 e. for the year beginning July 1, 2019, and all
4 subsequent years, eighty-three one-hundredths percent
5 (0.83%), but in no event shall the amount apportioned
6 in any fiscal year pursuant to this subparagraph
7 exceed the total amount apportioned for the fiscal
8 year ending on June 30, 2015. Any amounts in excess
9 of such limitation shall be placed to the credit of
10 the Rebuilding Oklahoma Access and Driver Safety Fund
11 created in Section 1521 of Title 69 of the Oklahoma
12 Statutes.

13 2. The monies apportioned pursuant to subparagraphs a through e
14 of paragraph 1 of this subsection shall be apportioned to the
15 various counties based upon the proportion that each county's
16 population bears to the total state population.

17 Each county's allocation of funds shall be remitted to the
18 various county treasurers to be deposited in the general fund of the
19 county and used for the support of county government.

20 I. 1. The following percentages of the monies referred to in
21 subsection A of this section shall be apportioned to the various
22 cities and incorporated towns as set forth in paragraph 2 of this
23 subsection:
24

- 1 a. from October 1, 2000, until June 30, 2001, three and
2 four one-hundredths percent (3.04%),
- 3 b. for the year beginning July 1, 2001, and ending June
4 30, 2002, three and eight one-hundredths percent
5 (3.08%),
- 6 c. for the year beginning July 1, 2002, through the year
7 ending on June 30, 2015, three and ten one-hundredths
8 percent (3.10%),
- 9 d. for the year beginning July 1, 2015, through the year
10 ending on June 30, 2019, three and ten one-hundredths
11 percent (3.10%), but in no event shall the amount
12 apportioned in any fiscal year pursuant to this
13 subparagraph exceed the total amount apportioned for
14 the fiscal year ending on June 30, 2015. Any amounts
15 in excess of such limitation shall be placed to the
16 credit of the General Revenue Fund, and
- 17 e. for the year beginning July 1, 2019, and all
18 subsequent years, three and ten one-hundredths percent
19 (3.10%), but in no event shall the amount apportioned
20 in any fiscal year pursuant to this subparagraph
21 exceed the total amount apportioned for the fiscal
22 year ending on June 30, 2015. Any amounts in excess
23 of such limitation shall be placed to the credit of
24 the Rebuilding Oklahoma Access and Driver Safety Fund

1 created in Section 1521 of Title 69 of the Oklahoma
2 Statutes.

3 2. The monies apportioned pursuant to subparagraphs a through e
4 of paragraph 1 of this subsection shall be apportioned to the
5 various cities and incorporated towns based upon the proportion that
6 each city or incorporated town's population bears to the total
7 population of all cities and incorporated towns in the state. Such
8 funds shall be remitted to the various county treasurers for
9 allocation to the various cities and incorporated towns. All such
10 funds shall be used for the construction, maintenance, repair,
11 improvement and lighting of streets and alleys. Provided, however,
12 the governing board of any city or town may, with the approval of
13 the county excise board, transfer any surplus funds to the general
14 revenue fund of such city or town whenever an emergency requires
15 such a transfer.

16 J. The following percentages of the monies referred to in
17 subsection A of this section shall be remitted to the State
18 Treasurer to be credited to the Oklahoma Law Enforcement Retirement
19 Fund:

20 1. From October 1, 2000, until June 30, 2001, one and twenty-
21 two one-hundredths percent (1.22%);

22 2. For the year beginning July 1, 2001, and ending June 30,
23 2002, one and twenty-three one-hundredths percent (1.23%); and
24

1 3. For the year beginning July 1, 2002, and all subsequent
2 years, one and twenty-four one-hundredths percent (1.24%).

3 K. Three one-hundredths of one percent (3/100 of 1%) of the
4 monies referred to in subsection A of this section shall be remitted
5 to the State Treasurer to be credited to the Wildlife Conservation
6 Fund. Seventy-five percent (75%) of the funds shall be used for
7 fish habitat restoration and twenty-five percent (25%) of the funds
8 shall be used in the fish hatchery system for fish production.

9 L. 1. For the year beginning July 1, 2007, and ending June 30,
10 2008, five percent (5%) of monies referred to in subsection A of
11 this section shall be remitted to the State Treasurer to be credited
12 to the County Improvements for Roads and Bridges Fund as created in
13 Section 507 of Title 69 of the Oklahoma Statutes.

14 2. For the year beginning July 1, 2008, and ending June 30,
15 2009, ten percent (10%) of monies referred to in subsection A of
16 this section shall be remitted to the State Treasurer to be credited
17 to the County Improvements for Roads and Bridges Fund as created in
18 Section 507 of Title 69 of the Oklahoma Statutes.

19 3. For the period beginning July 1, 2009, and ending December
20 31, 2012, fifteen percent (15%) of monies referred to in subsection
21 A of this section shall be remitted to the State Treasurer to be
22 credited to the County Improvements for Roads and Bridges Fund as
23 created in Section 507 of Title 69 of the Oklahoma Statutes.

24

1 4. For the period beginning January 1, 2013, and ending June
2 30, 2013, fifteen and fifty one-hundredths percent (15.50%) of
3 monies referred to in subsection A of this section shall be remitted
4 to the State Treasurer to be credited to the County Improvements for
5 Roads and Bridges Fund as created in Section 507 of Title 69 of the
6 Oklahoma Statutes.

7 5. For the year beginning July 1, 2013, and ending June 30,
8 2014, eighteen percent (18%) of monies referred to in subsection A
9 of this section shall be remitted to the State Treasurer to be
10 credited to the County Improvements for Roads and Bridges Fund as
11 created in Section 507 of Title 69 of the Oklahoma Statutes.

12 6. For the year beginning July 1, 2014, twenty percent (20%) of
13 monies referred to in subsection A of this section shall be remitted
14 to the State Treasurer to be credited to the County Improvements for
15 Roads and Bridges Fund as created in Section 507 of Title 69 of the
16 Oklahoma Statutes.

17 7. For the year beginning July 1, 2015, through the year ending
18 on June 30, 2019, twenty percent (20%) of monies referred to in
19 subsection A of this section shall be remitted to the State
20 Treasurer to be credited to the County Improvements for Roads and
21 Bridges Fund as created in Section 507 of Title 69 of the Oklahoma
22 Statutes, but in no event shall the total amount apportioned in any
23 fiscal year pursuant to this paragraph exceed One Hundred Twenty
24 Million Dollars (\$120,000,000.00). Any amounts in excess of One

1 Hundred Twenty Million Dollars (\$120,000,000.00) shall be placed to
2 the credit of the General Revenue Fund.

3 8. a. Except as provided in subparagraph b of this
4 paragraph, for the year beginning July 1, 2019, and
5 all subsequent years, twenty percent (20%) of monies
6 referred to in subsection A of this section shall be
7 remitted to the State Treasurer to be credited to the
8 County Improvements for Roads and Bridges Fund as
9 created in Section 507 of Title 69 of the Oklahoma
10 Statutes, but in no event shall the total amount
11 apportioned in any fiscal year pursuant to this
12 paragraph exceed the fiscal year limitations provided
13 in subparagraph c of this paragraph. Any amounts in
14 excess of the fiscal year limitations provided in
15 subparagraph c of this paragraph shall be placed to
16 the credit of the Rebuilding Oklahoma Access and
17 Driver Safety Fund created in Section 1521 of Title 69
18 of the Oklahoma Statutes,

19 b. (1) for the fiscal year beginning July 1, 2021,
20 through the fiscal year ending June 30, 2026, the
21 Oklahoma Tax Commission shall remit twenty-five
22 percent (25%) of the monthly allocation,
23 otherwise scheduled to be credited to the County
24 Improvements for Roads and Bridges Fund, to the

1 various counties of the state. The Commission
2 shall distribute such funds monthly to each
3 county treasurer as follows:

4 (a) one-third (1/3) of such funds shall be
5 distributed to the various counties in the
6 proportion which the area of each county
7 bears to the total area of the state,

8 (b) one-third (1/3) of such funds shall be
9 distributed to the various counties in the
10 proportion which the certified county road
11 miles of each county bear to the total sum
12 of county road miles in the state, and

13 (c) one-third (1/3) of such funds shall be
14 distributed to the various counties in the
15 proportion which the total replacement cost
16 for obsolete or deficient bridges according
17 to the most recent Department of
18 Transportation yearly Bridge Summary Report
19 for County Bridges for each county bears to
20 the total amount of such cost for all such
21 county bridges in the state, and

22 (2) for the fiscal year beginning July 1, 2026, and
23 all subsequent fiscal years thereafter, the
24 Oklahoma Tax Commission shall remit twenty-five

1 percent (25%) of the monthly allocation,
2 otherwise scheduled to be credited to the County
3 Improvements for Roads and Bridges Fund, to the
4 various counties of the state. The Commission
5 shall distribute such funds monthly to each
6 county treasurer as follows:

7 (a) one-third (1/3) of such funds shall be
8 distributed to the various counties in the
9 proportion which the area of each county
10 bears to the total area of the state,

11 (b) one-third (1/3) of such funds shall be
12 distributed to the various counties in the
13 proportion which the certified county road
14 miles of each county bear to the total sum
15 of county road miles in the state, and

16 (c) one-third (1/3) of such funds shall be
17 distributed to the various counties in the
18 proportion which the number of county
19 bridges in each county according to the
20 Department of Transportation 2020 Bridge
21 Summary Report for County Bridges bears to
22 the total sum of county bridges in the state
23 according to such report.
24

1 Each county treasurer shall deposit such funds to the
2 county's county highway fund and such funds shall be used
3 for maintenance and operations. In no event shall the
4 total amount apportioned in any fiscal year pursuant to the
5 provisions of subparagraphs a and b of this paragraph
6 exceed the fiscal year limitations provided in subparagraph
7 c of this paragraph, and

8 c. the total amount apportioned each fiscal year pursuant
9 to this paragraph shall be limited as follows:

20 M. Twenty-four and eighty-four one-hundredths percent (24.84%)
21 of the monies referred to in subsection A of this section shall be
22 remitted to the State Treasurer to be credited to the Rebuilding
23 Oklahoma Access and Driver Safety Fund created in Section 1521 of
24 Title 69 of the Oklahoma Statutes.

1 N. Monies allocated to counties by this section may be
2 estimated by the county excise board in the budget for the county as
3 anticipated revenue to the extent of ninety percent (90%) of the
4 previous year's income from such source; provided, not more than
5 fifteen percent (15%) can be encumbered during any month.

6 O. Notwithstanding any other provisions of this section, for
7 the fiscal year beginning July 1, 2003, the first One Hundred
8 Thousand Dollars (\$100,000.00) of the monies collected or received
9 by the Tax Commission pursuant to the registration of motorcycles
10 and mopeds in this state shall be placed to the credit of the
11 Oklahoma Tax Commission Revolving Fund.

12 SECTION 19. AMENDATORY 47 O.S. 2021, Section 1137.1, as
13 last amended by Section 11, Chapter 236, O.S.L. 2024 (47 O.S. Supp.
14 2024, Section 1137.1), is amended to read as follows:

15 Section 1137.1. A. Except for vehicles, travel trailers or
16 commercial trailers which display a current Oklahoma license tag,
17 upon the purchase or transfer of ownership of a used motor vehicle,
18 travel trailer or commercial trailer, including an out-of-state
19 purchase or transfer of the same, to a licensed used motor vehicle
20 dealer, wholesale used motor vehicle dealer, used travel trailer
21 dealer or used commercial trailer dealer, subsequently referred to
22 in this section as "dealer", the dealer shall affix a used dealer's
23 plate visible from the rear of the vehicle, travel trailer or
24 commercial trailer. Such license plate shall expire on December 31

1 of each year. When the vehicle, travel trailer or commercial
2 trailer is parked on the dealer's licensed place of business, it
3 shall not be required to have a license plate of any kind affixed.
4 A dealer shall obtain from Service Oklahoma at a cost of Ten Dollars
5 (\$10.00) a dealer license plate for demonstrating, transporting or
6 any other normal business of a dealer including use by an individual
7 holding a valid salesperson's license issued by the Oklahoma Used
8 Motor Vehicle, Dismantler, and Manufactured Housing Commission. Any
9 dealer who operates a wrecker or towing service licensed pursuant to
10 Sections 951 through 957 of this title shall register each wrecker
11 vehicle and display a wrecker license plate on each vehicle as
12 required by Section 1134.3 of this title. A dealer may obtain as
13 many additional license plates as may be desired upon the payment of
14 Ten Dollars (\$10.00) for each additional license plate. Use of the
15 used dealer license plate by a licensed dealer for other than the
16 purposes as set forth herein shall constitute grounds for revocation
17 of the dealer's license. Service Oklahoma shall design the official
18 used dealer license plate to include the used dealer's license
19 number issued to him or her each year by Service Oklahoma or the
20 Oklahoma Used Motor Vehicle, Dismantler, and Manufactured Housing
21 Commission.

22 B. Upon the purchase or transfer of ownership of an out-of-
23 state used motor vehicle, travel trailer or commercial trailer to a
24 licensed dealer, the dealer shall make application for an Oklahoma

1 certificate of title pursuant to the Oklahoma Vehicle License and
2 Registration Act, Section 1101 et seq. of this title. Upon receipt
3 of the Oklahoma certificate of title, the dealer shall follow the
4 procedure as set forth in subsection A of this section. Provided,
5 nothing in this title shall be construed as requiring a dealer to
6 register a used motor vehicle, travel trailer or commercial trailer
7 purchased in another state which will not be operated or sold in
8 this state.

9 C. Upon sale or transfer of ownership of the used motor vehicle
10 or travel trailer, the dealer shall place upon the reassignment
11 portion of the certificate of title a tax stamp issued by the county
12 treasurer of the county in which the dealer has his or her primary
13 place of business. The tax stamp shall be issued upon payment of a
14 fee of Three Dollars and fifty cents (\$3.50) and shall be in lieu of
15 the dealer's ad valorem tax on the inventories of used motor
16 vehicles or travel trailers but shall not relieve any other property
17 of the dealer from ad valorem taxation.

18 D. Upon sale of a used motor vehicle or travel trailer to
19 another licensed dealer, the selling dealer shall place the tax
20 stamp required in subsection C of this section upon the certificate
21 of title. The used dealer license plate or wholesale dealer license
22 plate shall be removed by the selling dealer. The purchasing dealer
23 shall, at time of purchase, place his or her dealer license plate on
24 the used motor vehicle, travel trailer or commercial trailer as

1 provided in subsection A of this section; provided, for vehicles,
2 travel trailers or commercial trailers purchased by a licensed used
3 dealer at an auction, in lieu of such placement of the dealer
4 license plate, the auction may provide temporary documentation as
5 approved by the Director of the Motor Vehicle Division of Service
6 Oklahoma for the purpose of transporting such vehicle to the
7 purchaser's point of destination. Such temporary documentation
8 shall be valid for two (2) days following the date of sale.

9 E. 1. The purchaser of every used motor vehicle, travel
10 trailer, or commercial trailer, except as otherwise provided by law,
11 shall obtain registration and title for the vehicle or trailer
12 within two (2) months from the date of purchase of same. It shall
13 be the responsibility of the selling dealer to place a temporary
14 license plate, in size similar to the permanent Oklahoma license
15 plate but of a ten-mil weatherproof plastic-impregnated paper
16 approved by the Oklahoma Used Motor Vehicle, Dismantler, and
17 Manufactured Housing Commission, upon a used motor vehicle, travel
18 trailer or commercial trailer when a transaction is completed for
19 the sale of such vehicle. Provided, upon a determination by the
20 Commission that there exists a national shortage of ten-mil
21 weatherproof plastic-impregnated paper, eight-mil weatherproof
22 plastic-impregnated paper may be approved by the Commission until it
23 has been determined by the Commission the shortage has ended. The
24 temporary license plate under this subsection shall be placed at the

1 location provided for the permanent motor vehicle license plate.
2 The temporary license plate shall show the license number which is
3 issued to the dealer each year by Service Oklahoma or the Oklahoma
4 Used Motor Vehicle, Dismantler, and Manufactured Housing Commission,
5 the date of expiration, and the company name of the selling dealer.

6 2. The Oklahoma Used Motor Vehicle, Dismantler, and
7 Manufactured Housing Commission is hereby directed to develop the
8 motor vehicle temporary license plate design to incorporate these
9 requirements in a manner that will permit law enforcement personnel
10 to readily identify the dealer license number and date of
11 expiration. The Oklahoma Used Motor Vehicle, Dismantler, and
12 Manufactured Housing Commission is hereby authorized to develop
13 additional requirements and parameters as deemed appropriate to
14 discourage or prevent illegal duplication and use of the temporary
15 license plate. Such motor vehicle temporary license plate shall be
16 valid for a period of ten (10) days from the date of purchase. Use
17 of the motor vehicle temporary license plate by a dealer for other
18 than the purposes set forth herein shall constitute grounds for
19 revocation of the dealer's license to conduct business. Purchasers
20 of a commercial trailer shall affix the commercial trailer temporary
21 license plate to the rear of the commercial trailer. The purchaser
22 of a motor vehicle shall display the motor vehicle temporary license
23 plate for a period not to exceed ten (10) days or until registration
24 and title are obtained as provided in this section. The purchaser

1 of a commercial trailer shall display the commercial trailer
2 temporary license plate for a period not to exceed two (2) months or
3 until registration and title are obtained as provided in this
4 section.

5 3. The provisions of this subsection on temporary licenses
6 shall apply to nonresidents who purchase a used motor vehicle,
7 travel trailer, or commercial trailer within this state that is to
8 be licensed in another state. The nonresident purchaser shall be
9 allowed to operate the vehicle or trailer within the state with a
10 temporary license plate for a period not to exceed ten (10) days
11 from date of purchase. Any nonresident purchaser found to be
12 operating a used motor vehicle, travel trailer, or commercial
13 trailer within this state after two (2) months shall be subject to
14 the registration fees of this state upon the same terms and
15 conditions applying to residents of this state. Additionally,
16 within two (2) business days of the date of the sale or transfer of
17 the vehicle or trailer, the parties shall submit the requisite
18 documentation to Service Oklahoma or licensed operator identifying
19 the vehicle or trailer subject to the sale or transfer, purchaser
20 information, and any associated license plate on the vehicle,
21 pursuant to the requirements of Section 1112.2 of this title.

22 F. It shall be unlawful for any dealer to procure the
23 registration and licensing of any used motor vehicle, travel trailer
24 or commercial trailer sold by the dealer or to act as the agent for

1 the purchaser in the procurement of the registration and licensing
2 of the purchaser's used vehicle, travel trailer, or commercial
3 trailer. A license of any dealer violating the provision of this
4 section may be revoked.

5 G. Dealers following the procedure set forth herein shall not
6 be required to register vehicles, travel trailers, or commercial
7 trailers to which this section applies, nor will the registration
8 fee otherwise required be assessed. Provided, dealers shall not
9 purchase or trade for a used motor vehicle, travel trailer, or
10 commercial trailer on which the registration therefor has been
11 expired for a period exceeding two (2) months without obtaining
12 current registration therefor.

13 H. A nonprofit charitable organization which is exempt from
14 taxation pursuant to the provisions of the Internal Revenue Code, 26
15 U.S.C., Section 501(c)(3), and which accepts donations of used motor
16 vehicles previously titled in Oklahoma to be subsequently
17 transferred to another owner, upon the qualifying organization
18 providing sufficient documentation of its tax-exempt status, may
19 obtain from Service Oklahoma charitable nonprofit organization
20 license plates for demonstrating, transporting, or test-driving
21 donated vehicles, provided that no organization shall possess or use
22 at any one time more than eight such plates. Service Oklahoma shall
23 design distinctive license plates for that purpose. The cost for
24

1 such plates shall be the same as provided in subsection A of this
2 section for dealer plates.

3 I. The transfer of ownership from the vehicle donor to the
4 qualifying nonprofit organization described in subsection H of this
5 section shall be made without the payment of motor vehicle excise
6 tax levied pursuant to Section 2103 of Title 68 of the Oklahoma
7 Statutes.

8 SECTION 20. AMENDATORY 47 O.S. 2021, Section 1141.1, as
9 last amended by Section 14, Chapter 236, O.S.L. 2024 (47 O.S. Supp.
10 2024, Section 1141.1), is amended to read as follows:

11 Section 1141.1. A. Each licensed operator shall be entitled to
12 retain the following amounts from the taxes and fees collected by
13 such licensed operator to be used to fund the operation of the
14 office of such licensed operator subject to the provisions of
15 Sections 1140 through 1147 of this title:

16 1. Beginning July 1, 2006, through June 30, 2023, Three Dollars
17 and fifty-six cents (\$3.56) for each vehicle registered pursuant to
18 the Oklahoma Vehicle License and Registration Act;

19 2. Beginning on or after January 1, 2022, through June 30,
20 2023, if a special or personalized license plate is issued pursuant
21 to Sections 1135.1 through 1135.7 of this title and remittance is
22 combined with the registration required pursuant to Section 1132 of
23 this title, Seven Dollars and twelve cents (\$7.12). Beginning July
24 1, 2023, through June 30, 2025, Three Dollars and fifty-six cents

1 (\$3.56) for each special license plate issued pursuant to Sections
2 1135.1 through Section 1135.7 of this title;

3 3. One Dollar and twenty-five cents (\$1.25) for each
4 certificate of title issued for boats and motors pursuant to the
5 Oklahoma Statutes;

6 4. For each certificate of registration issued for boats and
7 motors pursuant to the Oklahoma Statutes, an amount determined
8 pursuant to the provisions of subsection B of this section;

9 5. Two Dollars and twenty-five cents (\$2.25) for each
10 certificate of title issued pursuant to the Oklahoma Vehicle License
11 and Registration Act. Provided, the fee retention amount for
12 certificates of title issued pursuant to the provisions of
13 subsection H of Section 1105 of this title, in which an insurer pays
14 the optional twenty-two-dollar-fee amount, is Four Dollars and fifty
15 cents (\$4.50);

16 6. Beginning July 1, 2002, through June 30, 2023, each licensed
17 operator shall be entitled to retain three and twenty-five one-
18 hundredths percent (3.25%) of the vehicle excise tax collected
19 pursuant to Section 2103 of Title 68 of the Oklahoma Statutes;

20 7. Four percent (4%) of the excise tax collected on the
21 transfer of boats and motors pursuant to the Oklahoma Statutes
22 through June 30, 2025;

- 1 8. Two Dollars (\$2.00) for each driver license, endorsement,
2 identification license, or renewal or duplicate issued pursuant to
3 Section 6-101 et seq. of this title through June 30, 2023;
- 4 9. Two Dollars (\$2.00) for the recording of security interests
5 as provided in Section 1110 of this title;
- 6 10. Two Dollars (\$2.00) for each inspection conducted pursuant
7 to subsection L of Section 1105 of this title;
- 8 11. Three Dollars (\$3.00) for each inspection conducted
9 pursuant to subsection M of Section 1105 of this title;
- 10 12. One Dollar (\$1.00) for each certificate of ownership filed
11 pursuant to subsection R of Section 1105 of this title;
- 12 13. One Dollar (\$1.00) for each temporary permit issued
13 pursuant to Section 1124 of this title;
- 14 14. One Dollar and fifty cents (\$1.50) for processing each
15 proof of financial responsibility, driver license information,
16 insurance verification information, and other additional information
17 as provided in Section 7-602 of this title;
- 18 15. The mailing fees and registration fees provided in Sections
19 1131 and 1140 of this title;
- 20 16. The notary fee provided in Section 1143 of this title;
- 21 17. Three Dollars (\$3.00) for each lien entry form completed
22 and recorded on a certificate of title pursuant to subsection G of
23 Section 1105 of this title;

24

1 18. Seven Dollars (\$7.00) for each notice of transfer as
2 provided by subsection B of Section 1107.4 of this title;

3 19. Seven Dollars (\$7.00) for each certificate of title or each
4 certificate of registration issued for repossessed vehicles pursuant
5 to Section 1126 of this title;

6 20. Any amount specifically authorized by law to be retained by
7 the licensed operator for the furnishing of a summary of a traffic
8 record;

9 21. Beginning July 1, 2009, and through June 30, 2023, each
10 licensed operator shall also be entitled to a portion of the
11 penalties for delinquent registration or payment of excise tax as
12 provided for in subsection C of Section 1115, subsection F of
13 Section 1132 and subsection C of Section 1151 of this title and of
14 subsection A of Section 2103 of Title 68 of the Oklahoma Statutes;

15 22. Beginning January 1, 2023, each licensed operator shall be
16 entitled to retain Three Dollars and fifty-six cents (\$3.56) for
17 each electric vehicle registered pursuant to the provisions of this
18 act and such amount shall be in addition to any other amount
19 otherwise authorized by this section to be retained with respect to
20 a vehicle ~~through~~ through June 30, 2025;

21 23. Beginning January 1, 2023, and through June 30, 2023, each
22 licensed operator shall be entitled to retain three and twenty-five
23 hundredths percent (3.25%) of the vehicle excise tax collected
24 pursuant to Section 2103 of Title 68 of the Oklahoma Statutes for

1 each electric vehicle but such amount shall not be in addition to
2 any other amount otherwise authorized by this section to be retained
3 with respect to a vehicle; and

4 24. Upon the effective date of this act, Service Oklahoma is
5 authorized to set the licensed operator compensation pursuant to
6 Section 3-103 of this title for processing the documentation
7 submitted and issuing the license plate and/or decal pursuant to
8 this subsection.

9 The balance of the funds collected shall be remitted to Service
10 Oklahoma as provided in Section 1142 of this title to be apportioned
11 pursuant to Section 1104 of this title.

12 B. Through June 30, 2025, for each certificate of registration
13 issued for boats and motors, each licensed operator shall be
14 entitled to retain the greater of One Dollar and twenty-five cents
15 (\$1.25) or an amount to be determined by Service Oklahoma according
16 to the provisions of this subsection. At the end of fiscal year
17 1997 and each fiscal year thereafter, Service Oklahoma shall compute
18 the average amount of registration fees for all boats and motors
19 registered in this state during the fiscal year and shall multiply
20 the result by six and twenty-two one-hundredths percent (6.22%).
21 The resulting product shall be the amount which may be retained by
22 each licensed operator for each certificate of registration for
23 boats and motors issued during the following calendar year.

1 C. When an application for registration is made with Service
2 Oklahoma, the Corporation Commission or a licensed operator, a
3 registration fee of One Dollar and seventy-five cents (\$1.75) shall
4 be collected for each license plate or decal issued. Such fees
5 shall be in addition to the registration fees on motor vehicles and
6 when an application for registration is made to the licensed
7 operator, such licensed operator shall retain a fee as provided in

19 person shall be listed separately on the application and

21 licensed operators shall charge only such fees as are specifically
22 provided for by law, and all such authorized fees shall be posted in
23 such a manner that any person shall have notice of all fees that are
24 imposed by law.

1 D. Unless otherwise provided, beginning July 1, 2025, the
2 provisions related to the reimbursement, retention, apportionment,
3 or distribution of funds to or by licensed operators as outlined in
4 this section shall be retained by the licensed operator pursuant to
5 subsection E of this section.

6 E. Beginning July 1, 2023, unless otherwise provided, licensed
7 operator compensation shall be fixed by Service Oklahoma pursuant to
8 Section 3-103 of this title.

9 1. For fiscal year beginning July 1, 2023, through the fiscal
10 year ending on June 30, 2025:

11 a. licensed operators shall be entitled to retain
12 nineteen percent (19%) of all fees collected related
13 to registrations provided by the Oklahoma Vehicle
14 License and Registration Act, ~~pursuant to subsection A~~

19 b. licensed operators shall be entitled to retain forty
20 percent (40%) of all fees collected related to the
21 issuance of Class A, Class B, Class C, and Class D
22 driver licenses, permits, and identification cards,
23 including REAL ID Compliant and REAL ID Noncompliant

1 credentials, pursuant to Section 6-101 et seq. of this
2 title, and

3 c. licensed operators shall be entitled to retain Three
4 Dollars and fifty-six cents (\$3.56) for the annual
5 renewal of each frac tank, construction machinery,
6 rental trailer, commercial trailer or semitrailer
7 registered pursuant to Section 1133 of this title.

8 2. All other fees directed by this section shall default back
9 to the apportionment outlined in Section 1104 of this title.

10 SECTION 21. AMENDATORY 47 O.S. 2021, Section 1143, as
11 amended by Section 180, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
12 2024, Section 1143), is amended to read as follows:

13 Section 1143. A. A licensed operator shall retain as
14 compensation those taxes and fees collected and retained pursuant to
15 Section 1141.1 of this title, and shall additionally retain:

16 1. All amounts remaining from notary and mailing fees and those
17 provided by Section 1105A of this title received by such licensed
18 operator, after payment of all costs of handling and mailing;

19 2. All profits from any concessions operated in the licensed
20 operator's office; and

21 3. All amounts collected pursuant to subsection H of Section
22 1111 of this title.

23 B. A licensed operator shall receive a fee as regulated in
24 Title 49 of the Oklahoma Statutes for each document notarized.

1 C. Service Oklahoma shall initiate a mail order vehicle
2 registration notification program, which shall consist of
3 notification annually to all vehicle owners in this state of such
4 time an owner shall register and license a vehicle as provided for
5 in Section 1101 et seq. of this title. The notification issued by
6 Service Oklahoma shall include a breakdown of all charges to be paid
7 by the owner, other items deemed necessary by Service Oklahoma and
8 shall notify the owner of the option of paying registration fees and
9 receiving the license plate or decal through the mail directly from
10 Service Oklahoma or of registering and receiving the license plate
11 or decal from a licensed operator. On the back of such registration
12 notification forms there shall be the address of Service Oklahoma in
13 large black type and an explanation of the apportionment of all
14 license fees and penalties collected and their disposition. Such
15 explanation shall include information as to all charges included in
16 the total license fee and any fees or charges incident to the
17 registration of a motor vehicle, to include all fees that a licensed

21 instructed to pay the final total listed. The costs of mailing
22 shall be the cost of postage plus One Dollar and twenty-five cents

2 Registration Act. Provided however, Service Oklahoma may adjust any

4 allow for additional fees the U.S. Postal Service may charge.

5 D. Money received by Service Oklahoma for the issuance of any
6 registrations, license plates or otherwise shall be apportioned to
7 the schools in accordance with other laws controlling such
8 distributions.

9 E. Failure by an owner of a vehicle to receive registration
10 notification as provided for in the Motor Vehicle License and
11 Registration Act shall not in any manner relieve such person from
12 the obligation of proper and timely registration and licensing of
13 such vehicle, and such person shall be subject to any penalties
14 prescribed by the Oklahoma Vehicle License and Registration Act.

15 F. A licensed operator, out of the taxes and fees collected and
16 retained pursuant to Section 1141.1 of this title, shall obtain a
17 faithful performance surety bond or cash bond in the amount of
18 Thirty Thousand Dollars (\$30,000.00) or in such additional amount
19 and form required by Service Oklahoma or by the Oklahoma Vehicle
20 License and Registration Act, a blanket surety bond or cash bond
21 covering adequately all office personnel, necessary insurance,
22 necessary office equipment and furniture, and other goods and

24 location. Provided that Service Oklahoma shall have the authority

1 Dollars (\$150.00), there shall be added to the fee of One Dollar
2 (\$1.00), the sum of One Dollar (\$1.00) for each One Hundred Dollars
3 (\$100.00) or any fraction thereof, in excess of One Hundred Fifty
4 Dollars (\$150.00) provided such fee shall not exceed One Hundred
5 Fifty Dollars (\$150.00);

6 3. After the first year's registration in this state under the

9 second year shall be ninety percent (90%) of the fee computed and

6 age of same, the registration fee shall be computed and assessed at
7 the rate hereinabove provided for a new vessel or motor based on the
8 value thereof determined as provided in this subsection, but reduced
9 as though same had been registered for each prior year of its
10 existence. Except as provided in paragraph 1 of this subsection,
11 the registration fee for the eleventh year computed in accordance
12 with the provisions of this subsection shall be the amount of the
13 fee to be assessed for such eleventh year and shall be the minimum
14 annual registration fee for such vessel or motor for any subsequent
15 year; and

16 6. The initial and subsequent registration fee for any vessel
17 or motor which is not being used in a trade or business or for any
18 commercial purpose and is owned by:

19 a. a nonresident member of the Armed Forces of the United
20 States assigned to duty in this state in compliance
21 with official military or naval orders,

22 b. a resident member of the Armed Forces of the United
23 States assigned to duty in this state in compliance

1 c. the spouse, who resides in Oklahoma, of a resident or
2 nonresident member of the Armed Forces of the United
3 States serving in a foreign country, or

4 d. any Oklahoma resident who is stationed out of state
5 due to an official assignment of the Armed Forces of
6 the United States,

7 shall be the lesser of either a Fifteen Dollar (\$15.00) registration
8 fee or the fee computed and assessed for vessels or motors of
9 similar age and model pursuant to this section.

10 B. As used in this section, the term "manufacturer's factory
11 delivered price" shall represent the recommended retail selling
12 price and shall not mean the wholesale price to a dealer.

13 C. Service Oklahoma shall assess the registration fees and
14 penalties for the year or years a vessel or motor was not registered
15 as provided in the Oklahoma Vessel and Motor Registration Act. For
16 vessels or motors not registered for two (2) or more years, the
17 registration fees and penalties shall be due only for the current
18 year and one (1) previous year.

19 D. Upon each vessel or motor repossessed by a mortgagee, a fee

12 F. All vessels and motors owned:

13 1. By the Boy Scouts of America, the Girl Scouts of U.S.A., and
14 the Camp Fire USA, devoted exclusively to youth programs emphasizing
15 physical fitness, character development and citizenship training;

16 2. By the Department of Public Safety; and

17 3. By organizations which are exempt from taxation pursuant to
18 the provisions of Section 501(c)(3) of the Internal Revenue Code, 26
19 U.S.C., Section 501(c)(3), and which are primarily devoted to the
20 establishment, development, operation, promotion, and participation
21 in, alone or in conjunction with others, educational and training
22 programs and competitive events to provide knowledge, information,

6 behalf who donated the vessel or motor, purchases the same vessel or

15 Section 2103. A. 1. Except as otherwise provided in Sections
16 2101 through 2108 of this title, there shall be levied an excise tax
17 upon the transfer of legal ownership of any vehicle registered in
18 this state and upon the use of any vehicle registered in this state
19 and upon the use of any vehicle registered for the first time in
20 this state. Except for persons that possess an agricultural
21 exemption pursuant to Section 1358.1 of this title, the excise tax

1 ownership of utility vehicles used exclusively off roads and

5 one-half percent (4 1/2%) of the actual sales price of each new and

7 and highways before any discounts or credits are given for a trade-
8 in. Provided, the minimum excise tax assessment for such all-
9 terrain vehicles, utility vehicles and motorcycles used exclusively
10 off roads and highways shall be Five Dollars (\$5.00). The excise
11 tax for new vehicles shall be levied at three and one-fourth percent
12 (3 1/4%) of the value of each new vehicle. The excise tax for used
13 vehicles shall be as follows:

- 14 a. from October 1, 2000, until June 30, 2001, Twenty
15 Dollars (\$20.00) on the first One Thousand Dollars
16 (\$1,000.00) or less of value of such vehicle, and

1 c. for the year beginning July 1, 2002, and all
2 subsequent years, Twenty Dollars (\$20.00) on the first
3 One Thousand Five Hundred Dollars (\$1,500.00) or less
4 of value of such vehicle, and three and one-fourth
5 percent (3 1/4%) of the remaining value of such
6 vehicle.

7 2. There shall be levied an excise tax of Ten Dollars (\$10.00)
8 for any:

9 a. truck or truck-tractor registered under the provisions
10 of subsection A of Section 1133 of Title 47 of the
11 Oklahoma Statutes, for a laden weight or combined
12 laden weight of fifty-five thousand (55,000) pounds or
13 more,

14 b. trailer or semitrailer registered under subsection C
15 of Section 1133 of Title 47 of the Oklahoma Statutes,
16 which is primarily designed to transport cargo over
17 the highways of this state and generally recognized as
18 such, and

19 c. frac tank, as defined by Section 54 of Title 17 of the
20 Oklahoma Statutes, and registered under subsection C
21 of Section 1133 of Title 47 of the Oklahoma Statutes.

22 Except for frac tanks, the excise tax levied pursuant to this
23 paragraph shall not apply to special mobilized machinery, trailers,
24 or semitrailers manufactured, modified or remanufactured for the

1 purpose of providing services other than transporting cargo over the
2 highways of this state. The excise tax levied pursuant to this
3 paragraph shall also not apply to pickup trucks, vans, or sport
4 utility vehicles.

5 3. The tax levied pursuant to this section shall be due at the
6 time of the transfer of legal ownership or first registration in
7 this state of such vehicle; provided, the tax shall not be due at
8 the time of the issuance of a certificate of title for an all-
9 terrain vehicle, utility vehicle or motorcycle used exclusively off
10 roads and highways which is not required to be registered but which
11 the owner chooses to register pursuant to the provisions of
12 subsection B of Section 1115.3 of Title 47 of the Oklahoma Statutes,
13 and shall be collected by Service Oklahoma ~~or the Corporation~~

15 B. The excise tax levied in subsection A of this section and
16 assessed on all commercial vehicles registered pursuant to Section
17 1120 of Title 47 of the Oklahoma Statutes and trailers and
18 semitrailers registered under subsection C of Section 1133 of Title
19 47 of the Oklahoma Statutes to transport cargo over the highways of
20 this state shall be in lieu of all sales and use taxes levied
21 pursuant to the Sales Tax Code or the Use Tax Code. The transfer of
22 legal ownership of any motor vehicle as used in this section and the
23 Sales Tax Code and the Use Tax Code shall include the lease, lease
24 purchase or lease finance agreement involving any truck in excess of

1 eight thousand (8,000) pounds combined laden weight or any truck-
2 tractor provided the vehicle is registered in Oklahoma pursuant to
3 Section 1120 of Title 47 of the Oklahoma Statutes or any frac tank,
4 trailer, semitrailer or open commercial vehicle registered pursuant
5 to Section 1133 of Title 47 of the Oklahoma Statutes. The excise
6 tax levied pursuant to this section shall not be subsequently
7 collected at the end of the lease period if the lessee acquires
8 complete legal title of the vehicle.

9 C. The provisions of this section shall not apply to transfers
10 made without consideration between:

- 11 1. Husband and wife;
- 12 2. Parent and child; or
- 13 3. An individual and an express trust which that individual or
14 the spouse, child or parent of that individual has a right to
15 revoke.

16 D. 1. There shall be a credit allowed with respect to the
17 excise tax paid for a new vehicle which is a replacement for:

- 18 a. a new original vehicle which is stolen from the
19 purchaser/registrant within ninety (90) days of the
20 date of purchase of the original vehicle as certified
21 by a police report or other documentation as required
22 by Service Oklahoma, or
- 23 b. a defective new original vehicle returned by the
24 purchaser/registrant to the seller within six (6)

1 months of the date of purchase of the defective new
2 original vehicle as certified by the manufacturer.

3 2. The credit allowed pursuant to paragraph 1 of this
4 subsection shall be in the amount of the excise tax which was paid
5 for the new original vehicle and shall be applied to the excise tax
6 due on the replacement vehicle. In no event shall the credit be
7 refunded.

8 E. Despite any other definitions of the terms "new vehicle" and
9 "used vehicle", to the contrary, contained in any other law, the
10 term "new vehicle" as used in this section shall also include any
11 vehicle of the latest manufactured model which is owned or acquired
12 by a licensed used motor vehicle dealer which has not previously
13 been registered in this state and upon which the motor vehicle
14 excise tax as set forth in this section has not been paid. However,
15 upon the sale or transfer by a licensed used motor vehicle dealer
16 located in this state of any such vehicle which is the latest
17 manufactured model, the vehicle shall be considered a used vehicle
18 for purposes of determining excise tax.

19 F. The provisions of this section shall not apply to state
20 government entities.

21 SECTION 24. REPEALER 47 O.S. 2021, Sections 6-110.2 and
22 1113.3, are hereby repealed.

23 SECTION 25. This act shall become effective July 1, 2025.
24

1 SECTION 26. It being immediately necessary for the preservation
2 of the public peace, health or safety, an emergency is hereby
3 declared to exist, by reason whereof this act shall take effect and
4 be in full force from and after its passage and approval.
