COMMITTEE SUBSTITUTE

An Act relating to the State Capitol; amending 73 O.S. 2021, Section 15.3, which relates to assignment of parking for certain officials; modifying assignments of parking spaces; designating parking spaces for large vehicle inspection station; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 73 O.S. 2021, Section 15.3, is amended to read as follows:

Section 15.3. Except as provided in ~~subsection~~ subsections C and D of this section, the President Pro Tempore of the Oklahoma State Senate and the Speaker of the Oklahoma House of Representatives are empowered to designate the parking assignments and issue window stickers or other means of identification of elected and appointed officers and employees whose offices are in

1 the State Capitol Building in the parking areas described in this  
2 act.

3 A. Except as provided in ~~subsection~~ subsections C and D of this  
4 section, officers and employees shall not park in any space in the  
5 following described areas except as specified by the President Pro  
6 Tempore:

7 1. The parking area traversed by the semicircular drive to the  
8 west entrance of the State Capitol Building. This area shall have  
9 specifically assigned parking places for state officers, including  
10 the Governor, Lieutenant Governor, the President Pro Tempore of the  
11 Senate, the Speaker of the House of Representatives, the Attorney  
12 General, the State Treasurer, the State Auditor and Inspector, the  
13 Justices of the Supreme Court, the Judges of the Court of Criminal  
14 Appeals, the Judges of the Court of Appeals and any other elected or  
15 appointed state officer or employee so designated by the President  
16 Pro Tempore;

17 ~~2. The area beginning at the intersection of Northeast Twenty-~~  
18 ~~third Street and the east curb of the west drive of Lincoln~~  
19 ~~Boulevard (the southbound lanes of Lincoln Boulevard), thence east~~  
20 ~~along Northeast Twenty-third Street to a point in line with the~~  
21 ~~easternmost curb of that parking area lying west of the State~~  
22 ~~Capitol Building, thence south to the northernmost curb of the~~  
23 ~~parking area traversed by the semicircular drive on the west side of~~  
24 ~~the State Capitol Building, thence traverse that parking area lying~~

17 ~~Boulevard (the southbound lanes of Lincoln Boulevard) and the west~~  
18 ~~curb of the east drive of Lincoln Boulevard (the northbound lanes of~~  
19 ~~Lincoln Boulevard) All parking spaces west of the halfway point~~  
20 ~~along the north curb of NE 21st Street to the southernmost parking~~  
21 ~~spaces in the South Parking Area, except those designated in~~  
22 ~~subsections C and D of this section; and~~

23 4. ~~In the parking area located east of Lincoln Boulevard,~~  
24 ~~thirty-seven parking spaces in the southwest portion of the parking~~

1 area, south and southwest of the tunnel entrance, and north of NE  
2 21st Street. Seventy-eight parking spaces in the northeast portion  
3 of the parking area identified as the first three rows of parking  
4 spaces west of N. Phillips Avenue.

5 B. Except as provided in ~~subsection~~ subsections C and D of this  
6 section, officers and employees shall not park in any space in the  
7 following described areas except as specified by the Speaker of the  
8 House of Representatives:

9 1. ~~The area beginning at the intersection of Northeast Twenty-~~  
10 ~~third Street and the west curb of the east drive of Lincoln~~  
11 ~~Boulevard (the northbound lanes of Lincoln Boulevard), thence~~  
12 ~~southerly along said west curb to the intersection of the centerline~~  
13 ~~of Northeast Twenty-first Street extended, thence west along the~~  
14 ~~centerline of Northeast Twenty-first Street extended and the~~  
15 ~~centerline of Northeast Twenty-first Street to the crosswalk~~  
16 ~~traversing Northeast Twenty-first Street on the south side of the~~  
17 ~~Capitol Plaza, thence north to the north curb of Northeast Twenty-~~  
18 ~~first Street, thence east along said north curb to the westernmost~~  
19 ~~curb of the parking area lying east of the State Capitol Building,~~  
20 ~~thence north along said west curb to the southernmost curb of the~~  
21 ~~parking area traversed by the semicircular drive on the east side of~~  
22 ~~the State Capitol Building, thence traverse that parking area lying~~  
23 ~~in the semicircular drive east of the State Capitol Building to a~~  
24 ~~point on the westernmost curb of the parking area lying east of the~~

2 ~~Northeast Twenty-third Street, thence east along Northeast Twenty-~~

6 ~~Twenty-first Street between the east curb of the west drive of~~  
7 ~~Lincoln Boulevard (the southbound lanes of Lincoln Boulevard) and~~  
8 ~~the west curb of the east drive of Lincoln Boulevard (the northbound~~  
9 ~~lanes of Lincoln Boulevard)~~ All parking spaces east of the halfway  
10 point along the north curb of NE 21st Street to the southernmost  
11 parking spaces in the south parking area, except those designated in  
12 subsections C and D of this section; and

13       3. ~~The twenty parking spaces located adjacent to the entrance~~  
14 ~~of the east pedestrian tunnel that connects the State Capitol~~  
15 ~~Building with the parking area that lies to the east of the State~~  
16 ~~Capitol Building on the east side of Lincoln Boulevard.~~

17       In the parking area located east of Lincoln Boulevard, the one  
18 hundred fifty-four parking spaces east of the east entrance of NE  
19 21st Street and south of the north curblines of the entrance from N.  
20 Phillips Ave. The sixty parking spaces located in the fourth,  
21 fifth, and sixth rows of the northeast portion of the parking area  
22 located west of N. Phillips Ave. and north of the north curblines of  
23 the N. Phillips Ave. entrance into the parking area. The five  
24 parking spaces west of the sixth row of parking spaces in the

1 northeast portion of the parking lot and north of the north curblin  
2 of the N. Phillips Ave. entrance into the parking area.

3 ~~C. Except as provided in subsections D and E of this section,~~  
4 ~~the President Pro Tempore and the Speaker of the House of~~  
5 ~~Representatives shall be empowered to designate the parking~~  
6 ~~assignments of elected and appointed officers and employees in the~~  
7 ~~parking area located between the east curb of the west drive of~~  
8 ~~Lincoln Boulevard (the southbound lanes of Lincoln Boulevard) and~~  
9 ~~the west curb of the east drive of Lincoln Boulevard (the northbound~~  
10 ~~lanes of Lincoln Boulevard) and between Northeast Twenty-first~~  
11 ~~Street and the northernmost curb of the parking area located~~  
12 ~~immediately north of Northeast Nineteenth Street.~~

13 ~~1. The President Pro Tempore shall designate the parking~~  
14 ~~assignments of elected and appointed officers and employees in the~~  
15 ~~twenty-four parking spaces located immediately south of the~~  
16 ~~northernmost curb, the six northernmost spaces located immediately~~  
17 ~~east of the westernmost curb of the parking area, and the eleven~~  
18 ~~westernmost parking spaces on the north side of the second~~  
19 ~~northernmost parking island; and~~

20 ~~2. The Speaker of the House of Representatives shall designate~~  
21 ~~the parking assignments of elected and appointed officers and~~  
22 ~~employees in the parking spaces located on the east and west sides~~  
23 ~~of the east entrance to the parking area; the four westernmost~~  
24 ~~parking spaces on the north side of the northernmost parking island;~~

7 D. 1. ~~The Governor shall designate the parking assignments for~~

10 ~~Lincoln Boulevard) and the west curb of the east drive of Lincoln~~  
11 ~~Boulevard (the northbound lanes of Lincoln Boulevard) and between~~  
12 ~~Northeast Twenty-first Street and the northernmost curb of the~~  
13 ~~parking area located immediately north of Northeast Nineteenth~~  
14 ~~Street:~~

15 a. ~~the twenty easternmost parking spaces on the north~~  
16 ~~side of the northernmost parking island, and~~

17 b. ~~the thirteen easternmost parking spaces on the north~~  
18 ~~side of the second northernmost parking island.~~

19 2. ~~Upon completion and acceptance of the completed project by~~  
20 ~~the President Pro Tempore of renovation and repair of the parking~~  
21 ~~area described as beginning at the intersection of Northeast Twenty-~~  
22 ~~third Street and the east curb of the west drive of Lincoln~~  
23 ~~Boulevard (the southbound lanes of Lincoln Boulevard), thence east~~  
24 ~~along Northeast Twenty-third Street to a point in line with the~~

- 17       a. ~~the ten parking spaces beginning with the eighth space~~  
18             ~~and ending with the seventeenth space located south of~~  
19             ~~the oil well (count beginning with the parking space~~  
20             ~~immediately adjacent to the oil well) on the east curb~~  
21             ~~of the west drive of Lincoln Boulevard (the southbound~~  
22             ~~lanes of Lincoln Boulevard), and~~
- 23       b. ~~the ten southernmost parking spaces on the east side~~  
24             ~~of the southernmost parking island~~

1     The southernmost two rows of parking spaces in the south parking  
2 lot shall be reserved for the Department of Public Safety for the  
3 purpose of creating a large vehicle inspection station. The  
4 Department of Public Safety shall be permitted to post appropriate  
5 signage related to the inspection station of large vehicles along  
6 Lincoln Boulevard (northbound and southbound lanes) and at the  
7 Gatehouses for both the Senate and the House.

8     E. All unassigned parking spaces in the south parking area  
9 ~~described in subsections C and D of this section that are unassigned~~  
10 and the parking area that lies east of the State Capitol Building on  
11 the east side of Lincoln Boulevard shall be reserved for visitors.

12     SECTION 2. This act shall become effective November 1, 2025.
