



1           A. Contingent upon the availability of funds, the District  
2 Attorneys Council shall develop and implement a five-year Domestic  
3 Violence Forensic Exam Pilot Program. The purpose of the Domestic  
4 Violence Forensic Exam Pilot Program shall be to provide counties  
5 with qualified licensed health care professionals who shall conduct  
6 domestic violence forensic exams for victims of domestic violence  
7 assault. Counties with a population of more than one hundred  
8 thousand (100,000) according to the latest Federal Decennial Census  
9 may participate in the pilot program. In conjunction with the  
10 Domestic Violence Forensic Exam Pilot Program, a Domestic Violence  
11 Examination Fund shall be established in each participating county  
12 for the purpose of providing to a victim of domestic violence  
13 assault, a forensic medical examination by a qualified licensed  
14 health care professional.

15           B. As used in this section:

16           1. "Domestic violence" means any act of physical harm or the  
17 threat of imminent physical harm which is committed by an adult,  
18 emancipated minor, or minor child thirteen (13) years of age or  
19 older against another adult, emancipated minor, or minor child who  
20 is currently or was previously an intimate partner or family or  
21 household member;

22           2. "Intimate partner" means:

23           a. current or former spouses,

24           b. persons who are in a dating relationship,

1 c. persons who are the biological parents of the same  
2 child, regardless of marital status or whether they  
3 have lived together at any time, and

4 d. persons who currently or formerly lived together in an  
5 intimate way, primarily characterized by affectionate  
6 or sexual involvement. A sexual relationship may be  
7 an indicator that a person is an intimate partner, but  
8 is never a necessary condition;

9 3. "Living in the same household" means:

10 a. persons who regularly reside in the same single-  
11 dwelling unit,

12 b. persons who resided in the same single-dwelling unit  
13 within the past year, or

14 c. persons who have individual lease agreements whereby  
15 each person has his or her own private bedroom and  
16 shares common areas; and

17 4. "Qualified licensed health care professional" means a  
18 physician, registered nurse, or other licensed health care  
19 professional qualified by completion of a forty-hour didactic  
20 domestic violence examiners course, as well as successful completion  
21 of clinical competence.

22 C. The Crime Victims Compensation Board shall establish the  
23 procedures for disbursement of the Domestic Violence Examination  
24 Fund, but in no event shall the Crime Victims Compensation Board pay

1 an amount to exceed Two Hundred Dollars (\$200.00) for a domestic  
2 violence forensic exam. Such payments shall not exceed the amounts  
3 specified by this subsection regardless of the amount of any  
4 individual bills comprising the claim. Payments shall be made only  
5 upon claims signed by the victim or guardian and qualified licensed  
6 health care professional.

7 D. The District Attorneys Council is hereby authorized to  
8 transfer funds, as specified in the appropriations bill annually,  
9 from the Crime Victims Compensation Fund to the Domestic Violence  
10 Examination Fund for the payment of domestic violence forensic  
11 exams, pursuant to this section.

12 E. The District Attorneys Council shall have the authority to  
13 make any contract, execute any document, or perform any act in order  
14 to carry out the Domestic Violence Forensic Exam Pilot Program.

15 F. Nothing in this section shall prevent the Legislature from  
16 appropriating funds to the Domestic Violence Examination Fund for  
17 the payment of domestic violence forensic examinations.

18 SECTION 2. This act shall become effective November 1, 2025.
