14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. NEW LAW A new section of law to be codified
16	in the Oklahoma Statutes as Section 2-122.4 of Title 47, unless
17	there is created a duplication in numbering, reads as follows:
18	A. The Department of Environmental Quality shall promulgate
19	rules to create the Canine Cooperative Grant Program to provide
20	financial assistance to state, county, and municipal law enforcement
21	entities and fire departments for the acquisition and training of
22	law enforcement canines and search, rescue, and recovery canines and
23	medical expenses for the canines related to injuries sustained while
24 2 7	in the line of service; provided, canines shall be trained in

¹ accordance with state law and agency standards and shall be ² specifically allocated for law enforcement officers and fire ³ departments.

4 There is hereby created in the State Treasury a revolving Β. 5 fund for the Department of Environmental Quality to be designated 6 the "Canine Cooperative Grant Program Revolving Fund". The fund 7 shall be a continuing fund, not subject to fiscal year limitations, 8 and shall consist of all monies received from legislative 9 appropriations, private donations, and federal grant programs. All 10 monies accruing to the credit of the fund are hereby appropriated 11 and may be budgeted and expended by the Department of Environmental 12 Quality for the administration of the Canine Cooperative Grant 13 Program. Expenditures from the fund shall be made upon warrants 14 issued by the State Treasurer against claims filed as prescribed by 15 law with the Director of the Office of Management and Enterprise 16 Services for approval and payment.

C. The Department of Environmental Quality may retain five
percent (5%) of the proceeds of the fund annually to be used for the
administration of the program.

D. Subject to the availability of funds, the program shall have the following annual limits for grants:

I. Grants not to exceed Ten Thousand Dollars (\$10,000.00) per county sheriff for canine purchases or canine training;

4	3. Grants not to exceed Ten Thousand Dollars (\$10,000.00) per

6	E. Subject to the availability of funds, the program shall make
7	grants for the reimbursement of medical expenses for canines injured
8	in the line of service with state, county, or municipal law
9	enforcement or a fire department.
10	SECTION 2. This act shall become effective November 1, 2025.
