**Research Analysis**

The engrossed version of SB 109 requires any health benefit plan offered, issued, or renewed in this state on or after the act's effective date to provide coverage for clinical genetic testing for an inherited gene mutation in individuals with a person or family history of cancer and evidence-based cancer imaging for individuals with an increased risk of cancer. Coverage under this will not be subject to any annual deductibles, copayments, or coinsurance limits as established for all covered benefits under the health benefit plan. If application of this would result in health savings account ineligibility, the provisions will only apply to a high deductible plan after the enrollee has satisfied the minimum deductible.
